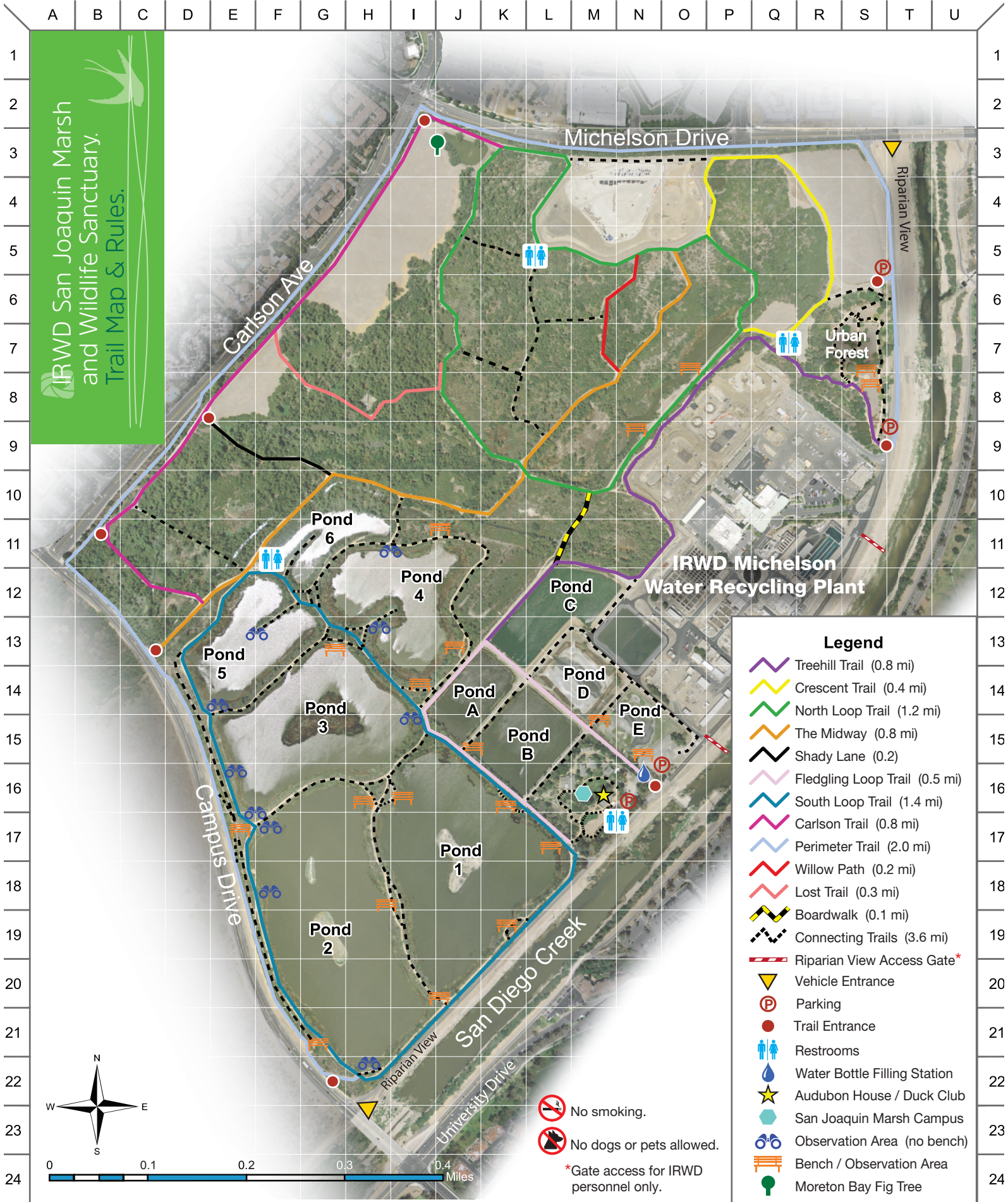


IRWD San Joaquin Marsh and Wildlife Sanctuary.

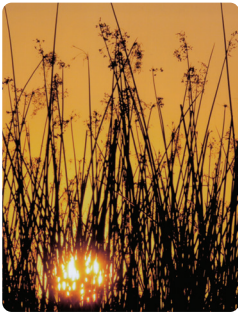

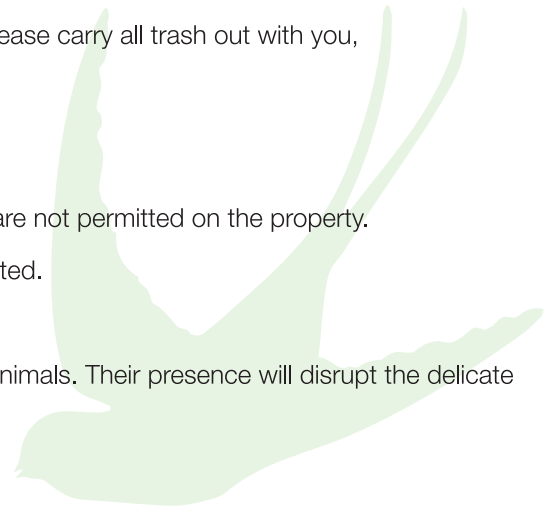
**Among its other purposes, the San Joaquin Marsh provides a safe and welcoming environment for many species of birds and other animals. To help preserve this haven for wildlife and people, please follow these rules:**



- Please stay on marked trails or roads at all times.
- Do not collect or disturb the wildlife, including flowers or other plant materials, animals, birds, insects, rocks or any element within the sanctuary. Harvesting of berries is allowed along Riparian View.
- Smoking, fires, and camping are not permitted. Please carry all trash out with you, including food scraps.
- Please do not feed the wildlife.
- Boating, swimming and wading are prohibited.
- Dogs and other pets — leashed or unleashed — are not permitted on the property.
- Hunting, fishing, trapping, and firearms are prohibited.
- Please obey all trail signs.
- Do not abandon or release any wild or domestic animals. Their presence will disrupt the delicate balance of the sanctuary's native wildlife.
- Horseback and bicycle riding are not permitted.
- Alcoholic beverages are prohibited.
- Organized athletic activities are prohibited.
- Organized events are prohibited without prior approval by Irvine Ranch Water District.

## Did You Know?

- The wildlife sanctuary spans a total of 321 acres.
- It supports 121 plant species and more than 282 bird species.
- 1.3 billion gallons of water flows into the marsh each year.
