## PUBLIC HEARING

## PROPOSED CHANGES TO THE SCHEDULE OF RATES AND CHARGES EFFECTIVE JULY 1, 2014

## SUMMARY:

The Fiscal Year (FY) 2014-15 Operating Budget was adopted by the Board at the public workshop held on April 28, 2014. The proposed changes to the rates and charges were publicly noticed by mail as required under Proposition 218 and protests to the implementation of those rates and charges have been tallied by the District. As of June 18, 2014, six written protest letters were received by the District, which represents 0.01% of the total customers, substantially less than the 50% which would have been required to prevent the Board from adopting the current proposed rates and charges. Protests may be received up until the commencement of the public hearing; staff will provide an updated report as part of the hearing process.

Pursuant to the requirements of Proposition 218, a Public Hearing on the rates and charges is required. Following the Public Hearing, staff recommends that the Board adopt the proposed changes to the Schedule of Rates and Charges required to fund operating expenses.

# **RESOLUTION NO. 2014 -**

RESOLUTION OF THE BOARD OF DIRECTORS OF IRVINE RANCH WATER DISTRICT, ORANGE COUNTY, CALIFORNIA RESCINDING RESOLUTION NO. 2013- AND ADOPTING CHANGES TO THE SCHEDULE OF RATES AND CHARGES AS SET FORTH IN EXHIBIT "B" TO THE RULES AND REGULATIONS OF IRVINE RANCH WATER DISTRICT FOR WATER, SEWER AND RECYCLED WATER SERVICE

## BACKGROUND:

## Proposed Rates and Charges for FY 2014-15:

A redline version showing the changes to the rates and charges proposed for FY 2014-15 is attached as Exhibit "B". The proposed changes include both updates identified through the rate setting process and changes to the wording and format to better communicate the application of the District's rates to the customer.

Staff has reviewed costs and revenues for the treated water system, the untreated water system and the sewer system (which includes recycled water system). As a result of this review, changes to the water and sewer rates for the Irvine Ranch rate area, Orange Park Acres (OPA) rate area and the Los Alisos rate area recommended for FY 2014-15 include:

## Irvine Ranch Rate Area

Treated Water System:

- The low volume rate will be reduced by \$0.03 from \$0.91/ccf to \$0.88/ccf.
- An increase to the base commodity rate of \$0.07/ccf, from \$1.27/ccf to \$1.34/ccf.
- An additional base commodity rate increase of \$0.02/ccf effective after January 1, 2015 if the dry conditions continue and additional imported purchases are required.
- An increase of \$0.65 to the current monthly service charge, from \$9.85 to \$10.50, which includes monthly user rate contributions of \$0.80/month for water capital infrastructure replacements and \$0.70/month for water capital infrastructure enhancements.

Sewer and Recycled Water System:

• An increase to the current monthly service charge of \$2.10, from \$18.40 to \$20.50, which includes monthly user rate contributions of \$6.70/month for sewer/recycled water capital infrastructure replacements and \$0.70/month for sewer and recycled water capital infrastructure enhancements. The \$6.70/month increase includes a \$1.00/month addition from FY 2013-14 and the first of three annual \$0.65 incremental additions to provide funding for a significant portion of the bio-solids treatment facility.

# OPA Rate Area (ID 156)

# Treated Water System:

The OPA rate area has tiered rates that are not allocation-based conservation rates, but escalate based on set levels of water used per month. Changes in the rates for the OPA rate area are indexed to the changes in the Irvine rate area by agreement until such time as the acquisition balance is paid in full:

- An increase to the base commodity rate of \$0.07/ccf, from \$1.79 to \$1.86/ccf.
- An additional base commodity rate increase of \$0.02/ccf effective after January 1, 2015 if the dry conditions continue and additional imported purchases are required.
- An increase of \$0.65 to the current monthly service charge, from \$18.35 to \$19.00.

## Los Alisos Rate Area (ID 135/235)

Treated Water System:

The rate adjustments for the Los Alisos rate area treated system include a factor aligning Los Alisos meter rates with the Irvine Ranch meter rates.

- An increase to the base commodity rate of \$0.07/ccf, from \$2.24/ccf to \$2.31/ccf.
- An increase of \$0.65 to the current monthly service charge, from \$9.85 to \$10.50, which includes monthly user rate contributions of \$0.80/month for water capital infrastructure replacements and \$0.70/month for water capital infrastructure enhancements.

Sewer and Recycled Water System:

• An increase to the current monthly service charge of \$2.10, from \$18.40 to \$20.50, which includes monthly user rate contributions of \$6.70/month for sewer/recycled water capital infrastructure replacements and \$0.70/month for sewer and recycled water capital infrastructure enhancements. The \$6.70/month increase includes a \$1.00/month addition from FY 2013-14 and the first of three annual \$0.65 incremental additions to provide funding for a significant portion of the bio-solids treatment facility.

The proposed treated tiered rates for both rate areas follow:

A proposed redline version of the schedule of rates and charges is provided as Exhibit "B", and contains all of the proposed rates for all three rate areas.

# User/Replacement and Enhancement Capital Component:

The replacement component was increased for sewer as noted above. The added component is estimated to generate an additional \$1.3 million for the sewer system. Combined with the existing replacement and enhancement rate components, the total capital components area are estimated to generate \$3.8 million and \$15.7 million on the treated water and sewer systems, respectively.

# Comparison to City of Orange Rates:

On August 28, 2006, IRWD and the City of Orange executed an agreement by which IRWD would provide services to the area known as the "Santiago Hills II / East Orange Area". One of the conditions stipulated in this agreement was that the cumulative fixed and commodity charges for water service to an IRWD customer using the median amount of water would not exceed the same charges incurred by a customer in the City of Orange using the median amount of water in the City. Based on the rates as proposed for FY 2014-15, a customer in IRWD using the median amount of water (12 ccf per month) will pay an average of \$22.90 per month for the water service fixed and commodity charges. Based on the most current water rates in the City of Orange, a customer using the IRWD median amount of water (12 ccf per month) will pay an average of \$28.47 per month for the water service fixed and commodity charges or 24% more than a comparable ratepayer in IRWD.

# Proposition 218 Notice:

Proposition 218, enacted in 1996, mandates that proposed increases in "property-related fees" must be noticed to property owners, and that such owners have an opportunity to protest prior to the enactment of the fee increases. While water districts and sewer agencies throughout the state believed, based on court decisions, that water and sewer service was exempt from this requirement, in July 2006, the California Supreme Court issued a decision in the matter of <u>Bighorn</u>, which held that water delivery charges are property-related. Following the Supreme Court's logic, most interpretations of the decision are that both water and sewer charges should be noticed in order to be in compliance with Proposition 218.

Under Proposition 218, the notice to customers must be sent to all property owners. As permitted by statute, the District sent its notices to all of its customers (including tenants) in the District's service area at their billing addresses.

The District received all written protests from property owners in the District at a separate post office box from the rest of the District's mail. As of June 18, 2014, six written protests have been received, representing 0.01% of the 87,035 notices sent, 0.59% were retained as undeliverable. Under Proposition 218, more than 50% of the IRWD customers would have had to protest in order to prevent the Board from adopting the Proposed Rates and Charges.

Copies of all six protest letters received to date are attached as Exhibit "C".

# ENVIRONMENTAL COMPLIANCE:

The establishment, modification, structuring, restructuring or approval of rates, tolls, fares, or other charges by public agencies are exempt from the requirements of the California Environmental Quality Act (CEQA) provided that certain findings are made specifying the basis for the claim of exemption. The necessary findings are contained in the proposed resolution.

# FISCAL IMPACTS:

The District's FY 2014-15 Consolidated Operating Budget totals \$130.6 million, representing a \$13.6 million or 11.6% increase from the Fiscal Year 2013-14 Operating Budget. The proposed adjustments to the District's Schedule of Rates and Charges will generate approximately \$3.5 million of additional revenue for the treated water system and approximately \$5.6 million of additional revenue in the sewer system.

Included in the additional revenue is \$1.3 million generated to provide funding for the bio-solids capital project within the sewer system.

In addition, the District has elected to utilize \$3.0 million of the rate stabilization fund to minimize the rate increase.

## **RESOLUTION NO. 2013 -**

# RESOLUTION OF THE BOARD OF DIRECTORS OF IRVINE RANCH WATER DISTRICT, ORANGE COUNTY, CALIFORNIA ADOPTING CHANGES TO THE SCHEDULE OF RATES AND CHARGES AS SET FORTH IN EXHIBIT "B" TO THE RULES AND REGULATIONS OF IRVINE RANCH WATER DISTRICT FOR WATER, SEWER AND RECLAIMED WATER SERVICE

WHEREAS, the Irvine Ranch Water District (IRWD) is a California Water District organized and existing under the California Water District Law, and all of the lands within the boundaries of said District are located in the County of Orange, State of California; and

WHEREAS, Sections 35423, 35470 and Section 35501 of the California Water Code empower the District to establish, print and distribute equitable rules and regulations and prescribe and collect rates or other charges for water and sewer service; and

WHEREAS, the Board of Directors of IRWD, by adoption of Resolution No. 2009-4 approved and adopted amended "Rules and Regulations of Irvine Ranch Water District for Water, Sewer, Recycled Water, and Natural Treatment System Service," effective February 9, 2009"; and

WHEREAS, Exhibit "B" of said Rules and Regulations sets forth Rates and Charges, which Exhibit "B" may be changed from time to time by adoption of changes to any of the rates and charges or any new rates and charges as may be established and set forth therein; and

WHEREAS, Section 21080(b) (8) of the Public Resources Code provides that the establishment, modification, structuring, restructuring or approval of rates, tolls, fares, or other charges by public agencies are exempt from the requirements of the California Environmental Quality Act (CEQA) provided that certain findings are made specifying the basis for the claim of exemption; and

WHEREAS, Article XIIIB of the Constitution of the State of California, limiting local agencies' appropriations of proceeds of taxes, excludes user charges or fees or regulatory fees from the definition of proceeds of taxes, as long as such fees and charges do not produce revenue exceeding the costs reasonably borne in providing the regulation, product or service, and further excludes appropriations for debt service and appropriations for qualified capital outlay projects from appropriations subject to limitation; and

WHEREAS, the Board of Directors of IRWD deems it advisable and finds that it would be in the best interest of the District to amend or establish certain rates and charges, consistent with applicable constitutional and statutory requirements; and

WHEREAS, Article XIIID of the Constitution of the State of California provides that, in imposing or increasing any property-related fee or charge (which term was held by the California Supreme Court in July, 2006, in the case *Bighorn-Desert View Water Agency v. Virjil*, to include charges for water delivery), an agency shall provide written notice by mail of the proposed fee or charge to the record owner of each identified parcel upon which the fee or charge is proposed for imposition, the amount, basis of calculating, and reason for such proposed fee or charge, and the date, time and location of a public hearing on the proposed fee or charge to be conducted not less than 45 days after the mailing of said notice, and Government Code Section 53755 provides for such notice to be given by mailing to the address where billing statements are customarily sent by the District;

WHEREAS, said mailed notice was given, setting Monday, June 24, 2013, at the hour of 5:00 p.m. of said day in the Board of Directors Room of Irvine Ranch Water District, 15600 Sand Canyon Avenue, Irvine, California, as the time and place for a public hearing on the proposed increases in property-related rates and charges and any proposed new property-related rates and charges set forth in Exhibit "A" to this resolution; and

WHEREAS, at the time set, the duly noticed public hearing was held and all persons interested were given an opportunity to be heard concerning the increases in propertyrelated rates and charges and any proposed new property-related rates and charges;

WHEREAS, this Board of Directors has considered all protests presented to the District by owners of identified parcels against the proposed increases in property-related rates and charges and any proposed new property-related rates and charges;

follows:

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of IRWD as

Section 1. It is hereby found and determined that the number of written protests presented to the District against the proposed increases in property-related rates and charges and any proposed new property-related rates and charges has been tabulated and does not constitute a majority of the number of owners of identified parcels.

Section 2. It is hereby found and determined that the proposed changes to the Schedule of Rates and Charges are within the purposes set forth in Section 21080(b) of the Public Resources Code including but not by way of limitation, the purposes of (1) meeting operating expenses, (2) purchasing or leasing supplies, equipment or materials, (3) meeting financial reserve needs and requirements, and (4) obtaining funds for capital projects necessary to maintain service within existing areas, and therefore, that such changes are exempt from CEQA.

Section 3. It is hereby found and determined that the rates and charges of IRWD are imposed on the basis of demand as determined by measurements including water metering and meter size, equivalent dwelling unit sewage loads or sewage volume and strength characteristics, dwelling units, acreage or other demand-generation characteristics of properties requesting connection, and cost of service restoration, inspection and other services provided for all fees; that such rates, charges and fees are imposed upon the request for or use of services; and that the water user charges satisfy the criteria and requirements of Water Code Sections 370 *et seq.* relating to allocation-based conservation water pricing.

Section 4. It is hereby found and determined that relative to Article XIIIB of the Constitution of the State of California, the user charges and fees and regulatory fees established or increased hereby do not produce revenues exceeding the costs reasonably borne in providing the regulation, product or service and/or are used for debt service or qualified capital outlay projects and accordingly do not constitute proceeds of taxes, the appropriation of which is limited under Article XIIIB, and that the documentation used in making such determinations has been on file in the office of IRWD for not less than 15 days prior to the date hereof, pursuant to Section 7910 of the Government Code of the State of California.

Section 5. The new and/or revised rate(s), fee(s) and/or charge(s) as set forth in Exhibit "A" attached to this resolution and by this reference incorporated herein are hereby adopted, and the corresponding rate(s), fee(s) or charge(s), if any, as set forth in Exhibit B currently in effect, are hereby superseded. Staff is directed to incorporate the hereby adopted new and/or revised rate(s), fee(s) and/or charge(s) into Exhibit "B" to the Rules and Regulations.

<u>Section 6.</u> That the provisions of this Resolution shall be effective upon adoption.

<u>Section 7.</u> That the Secretary is hereby ordered and directed to post a certified copy of this Resolution in a public place within the Irvine Ranch Water District.

Water allocations are based on the number of residents, landscape square footage and actual daily weather and evapotranspiration (ET) data for each of three microclimates within the District rate area. Variances are available for larger than normal landscaped areas, more people living in the home or special medical needs.

## Procedure

See IRWD Rules and Regulations, Section 12.6

## 3. Grounds for Variance

Proof acceptable to the District will be required for each ground(s) of variance.

#### a. Number of people residing in a residential dwelling unit.

Each additional person increases the base by 1.68 ccf/month (indoor usage factor x 0.8)

#### b. Landscape

Increased allocations shall be given for residential lot size beyond the standard base allocation lot size. It is the obligation of the customer to provide to the District acceptable documentation of the actual irrigated landscape area served.

#### c. Medical Needs

- Approval is contingent upon medical documentation.
- Increased allocation will be determined on a case by case basis and based on the type of medical need.

#### d. Licensed Care Facilities (in a residential dwelling unit)

- A current license from appropriate regulatory agency will be required.
- A licensed 24-hour care facility will be allocated increases based on the additional people per dwelling unit formula at 1.8-6 ccf per month per additional person.
- A licensed day care facility (not 24-hour) will be granted one ccf per additional person, or one third of the allotment (rounded to the next highest ccf) of the licensed 24-hour care facility.
- Additional allocation for medical reasons will be determined on a case by case basis.

## e. Fire Control Zones

 Increased Adjustments to allocations will be determined by the District based upon relevant factors such as area, slope, planting material, etc.

## f. Commercial/Industrial/Public Authority

Increases Adjustments to the base allocation will be determined on a case by case basis.
 Relevant factors —will include expansion of productive capacity, existing conservation practices that can be shown to have reduced water usage, severe economic hardship, etc.

## g. New Account Establishment Variance

Landscape Accounts - will be placed on conservation base rate for the first six months.

Commercial and Industrial Accounts - will be placed on conservation base rate for the first six months.

## 4. Limitations

**a.** An approved variance will become effective on the date the request for variance is submitted to the District, but must be submitted within thirty (30) days of receipt of the bill.

**b.** Approvals are valid for a period specified by the District (one year or less), and must be resubmitted on or before the expiration date to remain in effect.

## 5. Effect of Increased Allocations

## a. Residential:

Approved variances will extend each tier of the residential structure, excluding the low volume tier, by the number of increased ccfs by a percentage.

#### b. Non-Residential:

Approved variances will extend each tier of the non-residential structure by a given percentage (or other method) determined on a case by case basis.

# **New Account Fees for Water Service**

This section is applicable to all requests for new or transferred service.

## 1. Charges

A fee of \$1720.00 shall be collected to establish a new account for water and sewer service, or to transfer an existing account to a new location.

#### 2. Residential Deposit

For residential customers, a deposit of \$50.00 may be required until a one year payment history is established.

### 3. Non-Residential Deposit

A deposit of \$100.00 is required until a one year payment history is established.

# **Delinquency and Service Restoration Charges**

All bills and charges for water and, sewer and recycled water service shall be due and payable upon presentation and shall become delinquent twenty-five (25) calendar days thereafter.

#### 1. Delinquency Charges

If payment is not made within twenty-five (25) days after presentation, a late charge will be levied upon the unpaid balance as follows:

For residential and non-residential accounts with an unpaid balance of \$10 or more, a one-time charge of 10% of the unpaid balance plus 1.5% interest will be assessed, and each month thereafter the unpaid balance will be subject to an interest charge of 1.5%.

#### 2. Restoration Trip Charges

When service is discontinued because of delinquency in payment of a water, sewer, or recycled water bill, the service shall not be restored until all charges, including a restoration-trip charge, have been paid.

- (a) Restoration-Trip Charge During Normal Working Hours: The restoration-trip charge applicable for work requested to be performed during normal working hours of the District will be \$70.00.
- (b) Restoration Trip Charge After Normal Working Hours: The restoration trip charge applicable for work — requested to be performed after normal working hours of the District will be \$95.00.

#### 3. Non-Sufficient Funds Checks

A \$20.00 service fee will be charged for each check returned from the bank for non-sufficient funds.

The FOG Program Binder must be available during an inspection. Failure to locate the binder during an inspection, whether misplaced or lost, will trigger the issuance of a new FOG Binder. The \$50.00 replacement cost will be billed to the Food Service Establishment (FSE) at the time of replacement.

#### **Permitting Fees:**

A FOG Wastewater Discharge Permit of two-year duration is \$200.00.

#### Service Call and Follow Up Inspection Fees:

The General Non-Compliance Fee for District follow-up activities due to permit, ordinance, or regulatory non-compliance is \$100.00 per event.

#### Significant Non-Compliance Fees:

A condition where the violation continues after 45 days of notification to the FSE, the fee is \$550.00 per violation and \$550.00 every 45 days thereafter.

#### **Service Installations by District**

 The District may install individual domestic or fire services upon request. The cost for each service will be based on an estimate prepared by District personnel. The requestor will provide a written request accompanied by a drawing to show the location of the proposed service. The Delistrict will provide their an estimate to the requestor and when the check is received from the requestor the work order will be forwarded to the District crews for installation and coordination.

Costs for larger meters will have to be determined at the time of request from Purchasing Dept. Cost of meter includes the strainer if not already built-in to the meter.

- 2. If a meter is downsized on a 2" or smaller service lateral there will be no additional charge or refund. If the meter is downsized from a 3" or larger meter, the charge will be based on the service installation charge less the salvage value of the materials recovered from the larger service. Customer will be responsible for any plumbing modifications downstream of the water meter.
- 3. If a meter is to be upsized from 5/8" X <sup>3</sup>/<sub>4</sub>" to 1", the angle stop will need to be replaced. The cost for District staff to do this work is \$2,000.00 and will be collected along with the standard 1" meter cost. A non-refundable deposit of 5% of the estimated cost of the public potable or recycled water system is required with the submittal of the first plan check to cover the costs of plan checking. The total fee is due and payable prior to final plan approval.

#### **Non-Digital Submittal Surcharge**

A surcharge fee, calculated as 2% of the bondable cost for the potable or recycled water system will be charged for any plans not submitted with a digital format. The fee is due and payable prior to final approval of the plans.

#### **Interim Water Service Charge - New Developments**

A one-time charge of \$35.10 per connection to each pad in a new tract and/or development will be made to builders and developers for unmetered water service available for that period of time after in-tract lines have been connected to the District's water system until the new customer begins metered water service.

Custom lots will be charged \$164.50 per lot due to the extended construction period. Unmetered water service is not permitted for custom lots. Developers for custom lots will be required to apply for a domestic water construction meter prior to starting construction.

#### Sewer Installation Charges

- 1. A \$100 inspection fee will be charged for sewer laterals installed by the applicant, at no cost to the District, in accordance with District approved plans. The fee is to be paid prior to the approval of the plan for the sewer lateral.
- 2. The plan check and inspection fee for public sewer systems will be calculated as 10% of the bondable cost for the public sewer system or a fixed fee as described above. A non-refundable deposit of 5% of the estimated cost of the sewer system is required with the submittal of the first plan check. The total fee will be due and payable prior to final approval of the plans.

#### Non-Digital Submittal Surcharge

A surcharge fee, calculated as 2% of the bondable cost for the public sewer system will be charged for any plans not submitted with a digital format. The fee is due and payable prior to final approval of the plans.

#### **District Closed Circuit Television Inspection Charges**

# **Rate Structure Changes Proposed**

Irvine

On July 1, 2014, the Irvine Ranch Water District is proposing to make several changes to the rates and charges on your bill. The first step and all other proposed changes to the rates and charges allocations and tiers will become effective and operative for all bills sent starting on July 1, 2014.

# **Proposed Commodity Rates**

Commodity charges are based on the volume of water used. For FY 2014-15, RWD is proposing a two-step commodity rate increase for the Irvine Ranch rate area. As shown in the table of proposed rates, the rates are proposed to be increased for each tier, except for the low volume tier which is being decreased. The second step increase is proposed to be applied if customer demands for water exceed the projected water budget, requiring IRWD to make additional purchases of imported water the most expensive source of supply for IRWD.

# 60.07 per ccf (one First and Second Rate Steps: An increase hundred cubic feet of water, or 748 gallons) to the base rate is proposed to occur July 1, 2014. The \$0.07 increase would change the current

base commodity charge for water from \$1.27 to \$1.34 per ccf, which is still one of the lowest water rates in Orange County.

The second step of \$0.02 per ccf to the base rate is proposed to occur January 1, 2015, or later, but only if necessary.

The regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 5:10 p.m. by President LaMar on June 9, 2014 in the District office, 15600 Sand Canyon Avenue, Irvine, California.

Also Present: General Manager Cook, Executive Director of Finance Clary, Executive Director of Engineering and Planning Burton, Executive Director of Operations Sheilds, Executive Director of Water Resources Weghorst, Director of Water Resources Sanchez, Director of Human Resources Roney, Director of Risk Management and Treasury Jacobson, Director of Public Affairs Beeman, Director of Administrative Services Mossbarger, Ms. Christine Compton, Ms. Shannon Reed, Legal Counsel Arneson (by teleconference), Secretary Bonkowski, Mr. Barkev Mererlian, Mr. Jim Reed, Mr. Mike Hoolihan, Mr. Eric Akiyoshi, Mr. Bruce Newell and other members of the public and staff.

# WRITTEN COMMUNICATION:

Secretary Bonkowski said that a letter was just received from Mr. Tom Levy relative to item No. 14 on the Action Calendar, South Orange County Agencies' Metropolitan Water District of Southern California representative candidate nominations (see page 6).

#### ORAL COMMUNICATION

Mrs. Joan Irvine Smith's assistant addressed the Board of Directors with respect to the Dyer Road Wellfield. She said it was her understanding that currently wells 2, 4, C-8, C-9, 10, 13, 14, 15 and 17 will operate in accordance with the District's annual pumping plan. Wells 1, 3, 5, 6, 7, 11, 12, and 16 will be off. This was confirmed by Mr. Cook, General Manager of the District.

On October 31, 2013, the District received its fully executed copy of the Annexation Agreement with the Orange County Water District. This was confirmed by Mr. Cook.

With respect to the Groundwater Emergency Service Plan, IRWD has an agreement in place with various south Orange County water agencies, MWDOC and OCWD, to produce additional groundwater for use within IRWD and transfer imported water from IRWD to south Orange County in case of emergencies. This was confirmed by Mr. Cook.

# **WORKSHOP**

# FISCAL YEAR 2014-14 CAPITAL BUDGET

General Manager Cook said that a revised resolution had been placed before each Director with a change made on the allocation of sources of funds.

Using a PowerPoint presentation, Mr. Eric Akiyoshi reported on the proposed budget. He said that in the current fiscal year, FY 2013/14, budgeted expenditures were originally estimated at \$110.3 million with actual expenditures projected at approximately \$84.2 million (equating to 76% of projected expenditures) through the end of the current fiscal year. Mr. Akiyoshi said that the construction phases for the Baker Water Treatment Plant and the Michelson Water Recycling Plant (MWRP) Biosolids and Energy Recovery Facilities started later than originally scheduled, resulting in capital expenditures this year being lower than originally anticipated.

Mr. Akiyoshi said that in FY 2013/14, the District released approximately 3,016 dwelling units through April 2013 and that in FY 2014/15 the development activity is projected to be similar to the previous fiscal year with development in Hidden Canyon, Baker Ranch, the Great Park neighborhood, and Orchard Hills.

Mr. Akiyoshi said that staff estimates that capital expenditures for FY 2014/15 will be approximately \$153.7 million; the construction work on two projects (the MWRP Biosolids and Energy Recovery Facilities and the Baker Water Treatment Plant) make-up 60% of the projected expenditures.

Mr. Akiyoshi reviewed the flagged project list with both the upsizing of the Syphon Reservoir and the Irvine Lake Pipeline Conversions being added to the list.

Director Withers reported that this item was reviewed at the Engineering and Operations Committee on May 20, 2014. On <u>MOTION</u> by Withers, seconded and unanimously carried, THE FOLLOWING RESOLUTION AS AMENDED WAS ADOPTED BY TITLE:

# FISCAL YEAR 2014-15 GENERAL COUNSEL SERVICES FOR BOWIE, ARNESON, WILES, AND GIANNONE

General Manager Cook reported that Bowie, Arneson, Wiles & Giannone (BAWG) has provided a proposed letter of engagement for the purpose of providing legal services to the District for Fiscal Year (FY) 2014-15, effective July 1, 2014. BAWG's services shall not exceed \$525,000 without additional authorization from the District, of which \$425,000 is for general legal services and \$100,000 for the J127 matter. The proposed hourly rates and the estimated total cost for general legal services for FY 2014-15 will increase by \$10,000 from FY 2013-14. BAWG's hourly rates are based upon a number of factors, including the level of experience of its attorneys.

Director Swan reported that this item was reviewed and approved by the Finance and Personnel Committee on June 3, 2014. He said that he and the Committee are very pleased with the legal services provided by Ms. Arneson. On <u>MOTION</u> by Swan, seconded and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE THE ENGAGEMENT AGREEMENT WITH BOWIE, ARNESON, WILES, AND GIANNONE EFFECTIVE JULY 1, 2014 FOR GENERAL COUNSEL SERVICES IN THE AMOUNT NOT TO EXCEED \$525,000, SUBJECT TO THE NOT-TO-EXCEED AMOUNTS WITHIN SUCH TOTAL AMOUNT AS PROVIDED IN SEPARATE DETAIL.

# WATER SMART SOFTWARE INC. VARIANCE NO. 1

General Manager Cook reported that the Water Smart Program, developed and administered on behalf of IRWD by Water Smart Software Inc., provides enhanced water use information to target

over-allocation customers separately from their water bills. Mr. Cook said that the program is an effective tool that promotes water use efficiency and rate support outreach to customers.

Director Matheis reported that this item was reviewed by the Water Resources Policy and Communications Committee on June 5, 2014 and the Committee is very satisfied with this program. On <u>MOTION</u> by Matheis, seconded and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE VARIANCE NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN IRWD AND WATER SMART SOFTWARE INC. IN THE AMOUNT OF \$98,550.

# **ON-CALL DATABASE ADMINISTRATION CONSULTANTS**

Director of Administrative Services Mossbarger reported that staff currently utilizes database administration resources from LCS Technologies to provide support for the Oracle Financial System and the Oracle Customer Care and Billing (CC&B) implementation project. There is an ongoing need for database administration services for the District's software systems as a result of several major capital projects the District has recently undertaken, such as the CC&B software implementation project, as well as smaller scale software and networking projects. In addition, consultants with the required skills could be retained to fill in for staff vacancies due to back filling regular positions, terminations, or leaves of absence. Staff proposes to retain database administrators through consultant agencies who would provide services on an on-call basis.

Mr. Mossbarger said that staff requested proposals from LCS technologies and Outsource Technical who have provided excellent service and responsiveness on previous District projects. He said that staff recommends that the Board authorize the General Manager to execute two Professional Services Agreements: with LCS Technologies in the amount of \$120,000 and Outsource Technical in the amount of \$60,000. Outsource Technical will serve as a backup or additional resource to supplement LCS Technologies.

Director Swan said that this item was reviewed and approved by the Finance and Personnel Committee on June 3, 2014. On <u>MOTION</u> by Swan, seconded and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE TWO PROFESSIONAL SERVICES AGREEMENTS, ONE WITH LCS TECHNOLOGIES, INC. IN THE AMOUNT OF \$120,000 AND THE OTHER WITH OUTSOURCE TECHNICAL IN THE AMOUNT OF \$60,000 FOR ON-CALL DATABASE ADMINISTRATION SERVICES.

# SOUTH ORANGE COUNTY AGENCIES' METROPOLITAN WATER DISTRICT OF SOUTHERN CALIFORNIA REPRESENTATIVE CANDIDATE NOMINATIONS

General Manager Cook said that the South County Agencies are well into the process to nominate candidates for the open South Orange County Agencies' Metropolitan Water District of Southern California seat. Mr. Cook provided an update on the individuals interested in applying for this position and noted that the first meeting of the Nominating Committee was held today with Ms. Saundra Jacobs elected Chair and Ms. Debby Neeve as Vice Chair. He said that due to scheduling, the Committee will not be meeting until after the July 4<sup>th</sup> holiday. He said that as noted under Written Communications by Secretary Bonkowski, that Mr. Tom Levy provided an interest letter to the Board this evening. He further said that tonight, staff recommends that the Board authorize

IRWD to submit Mr. Bill Campbell as the candidate to the Nomination Committee before the June 16, 2014 submittal date. Following discussion, Director Withers made a motion which Director Matheis seconded to move forward with submitting Mr. Campbell as the candidate to the Nominating Committee. #### FISCAL IMPACTS:

As of May 31, 2014, the book value of the investment portfolio was \$322,019,107, with a 0.45% rate of return and a market value of \$322,090,667. Based on the District's March 31, 2014 quarterly real estate investment rate of return of 12.21%, the District's weighted average return for the fixed income and real estate investments was 2.60%.

As of May 31, 2014, the total notional amount of the interest rate swap portfolio was \$130 million of fixed payer swaps. Cash accrual in May from all swaps was negative \$648,202.

Payroll ACH payments totaled \$2,139,905, and wire transfers, all other ACH payments, and checks issued for debt service, accounts payable, payroll, and water purchases for May totaled \$16,165,585.

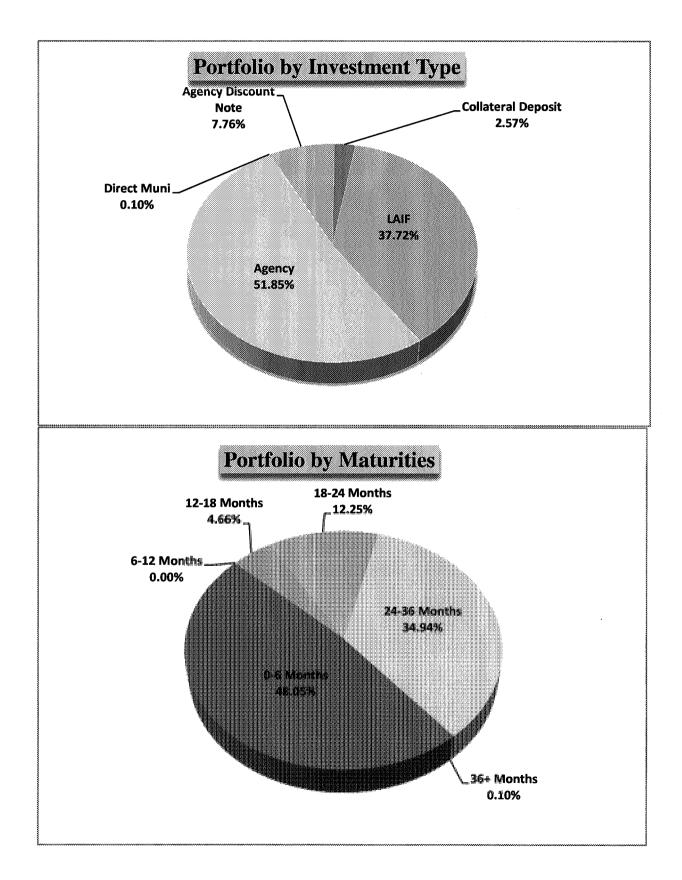

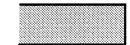

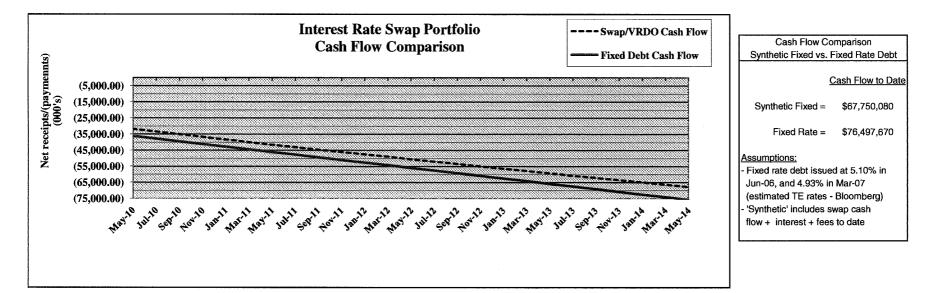

#### APPROVAL OF IRWD'S SHARE OF SOCWA'S FISCAL YEAR 2014-15 OPERATING BUDGET

#### SUMMARY:

Staff has been provided IRWD's share of the South Orange County Wastewater Authority (SOCWA) Fiscal Year (FY) 2014-2015 Operating Budget which reflects a decrease of \$8,206 from the FY 2013-14 Operating Budget. Staff recommends that the Board approve IRWD's share of the SOCWA Operations and Maintenance (O&M) budget in the amount of \$255,208.

#### BACKGROUND:

IRWD is a member agency of SOCWA for the Los Alisos Water Recycling Plant (LAWRP) effluent disposal capacity within SOCWA's Aliso Creek Ocean Outfall. IRWD is responsible to fund a portion of SOCWA's General Fund; Project Committee 2 Water Reclamation Permitting; Pretreatment Program; and Project Committee 21 and 24 Capital Replacement, Operation, and Maintenance expenses. These expenses are allocated based on capacity ownership and a percentage of agencies' effluent flows.

The SOCWA Operations and Maintenance (O & M) budget is subject to the approval of each member agencies' governing body. IRWD's portion of SOCWA's O&M budget for FY 2014-15 is \$255,208 as shown in Exhibit "A". This reflects a decrease of \$8,206 from FY 2013-14 O&M budget.

#### FISCAL IMPACTS:

Sufficient funds are included in IRWD's approved FY 2014-15Operating Budget for these costs. The IRWD portion of the SOCWA capital budget is managed through IRWD's capital program budget, and SOCWA is not planning to perform any capital related projects that pertains to IRWD's portion of the system; therefore, no capital funding is allocated for FY 2014-15.

Not applicable.

#### CONSENT CALENDAR

#### SYPHON RESERVOIR INTERIM FACILITIES BUDGET INCREASE, EXPENDITURE AUTHORIZATION, AND VARIANCE

#### **SUMMARY:**

The Syphon Reservoir Interim Facilities Project is currently under construction. The improvements include a filtration system, chlorination system, and pipeline modifications to connect the Syphon Reservoir to the Zone A recycled water system. Additional budget and Expenditure Authorization are required due to additional design and construction costs for the District's cost-sharing of the recently installed 8-inch sewer across Portola Parkway, electrical modifications, canopy construction, and SCADA integration. Staff recommends that the Board:

- Authorize a budget increase for Project 30374 in the amount of \$189,100 from \$2,732,300 to \$2,921,400;
- Approve an Expenditure Authorization for Project 30374 in the amount of \$189,100; and
- Authorize the General Manager to execute Variance No. 5 in the amount of \$10,500 to URS Corporation, Inc. for the Syphon Reservoir Interim Facilities, Project 30374.

#### **BACKGROUND:**

IRWD purchased Syphon Reservoir from The Irvine Company in 2010 to provide additional recycled water storage. While the long-term storage capacity of the reservoir is being determined, this project will construct chlorination facilities, strainers and pipeline improvements to connect Syphon Reservoir to the Zone A recycled water system. Construction is on-going, and completion is currently on schedule for July 31, 2014. A budget increase and an Expenditure Authorization are required due to additional design and construction costs as described below.

#### Additional Costs:

Additional construction work includes electrical modifications required to include high pressure alarms to the strainer backwash pump and chemical pumps, a flow switch alarm to the safety shower, and construction of a small canopy over the air compressor. The costs for these modifications are approximately \$30,000 and will be processed as change orders under the General Manager's authorization.

IRWD and Crean entered into a Reimbursement Agreement for the cost-sharing of the 8-inch sewer that crosses Portola Parkway serving both IRWD and Crean. This sewer will carry backwash from IRWD's strainers. IRWD's share of the cost is approximately \$75,000.

URS Corporation, Inc. completed additional design work for the electrical modifications mentioned above and an access road realignment. The road was re-designed to provide a safer transition to the existing road that runs along the Highline Canal to the southeast of the reservoir.

hc Syphon Reservoir Interim Facilities CCO

URS also designed a staff-requested canopy to protect the air compressor. URS submitted Variance No. 5 in the amount of \$10,500 for this work. Staff reviewed the variance and found the work effort and cost fair and reasonable; Variance No. 5 is attached as Exhibit "A".

Lastly, additional consultant and staff time to complete construction is required. This work includes SCADA integration to be completed by IRWD's consultant, Vertech, at a fee \$49,900, and staff's construction administration time, which is approximately \$25,000.

#### FISCAL IMPACTS:

Project 30374 (3729) is included in the FY 2013-14 Capital Budget. Staff requests a Budget increase and an Expenditure Authorization as shown in the table below and in Exhibit "B".

#### SAN JOAQUIN RESERVOIR ACTUATOR REPAIR/REPLACEMENT EXPENDITURE AUTHORIZATION

#### SUMMARY:

The San Joaquin Reservoir Actuator Repair/Replacement Project will repair/replace two valves/actuators on the inlet/outlet pipeline of the San Joaquin Reservoir. Staff recommends that the Board approve an Expenditure Authorization in the amount of \$155,700 for the San Joaquin Reservoir Actuator Repair/Replacement, Project 30455.

#### BACKGROUND:

There are five valves with hydraulic actuators on the 60-inch inlet/outlet pipeline of the San Joaquin Reservoir. The valves are required for normal and emergency operation of the reservoir; hydraulic actuators are used to open and close the valves. The 24-inch valve and actuator at elevation 360 feet is inoperable. This project will utilize divers to investigate the 24-inch valve and actuator. If it cannot be repaired in-place, it will be removed from the reservoir, repaired and reinstalled. The 48-inch valve actuator at elevation 380 feet has an actuator piston and hydraulic fluid issue and needs to be replaced. Divers will remove the existing actuator and replace it with a new actuator that was pre-purchased due to a long delivery time. The existing actuator will be repaired and ultimately used to replace the leaking actuator on the 48-inch valve at elevation 450 feet. Staff will perform this replacement when the valve is exposed above the water level.

#### Construction Award:

The project was advertised on May 12, 2014 to a select list of three contractors: Divecorr, Inland Potable Services, Inc. and WV Construction Company. Divecorr notified staff that it would not submit a bid; the other two contractors attended the pre-bid meeting on May 14, 2014 and submitted bids on June 5, 2014. Inland Potable Services, Inc. is the apparent low bidder with a bid amount of \$68,265. A Bid Summary is attached as Exhibit "A". The contract with Inland Potable Services, Inc. is within the approval limits of the General Manager.

#### FISCAL IMPACTS:

The San Joaquin Reservoir Actuator Repair/Replacement Project is included in the FY 2014-15 Capital Budget. Staff requests approval of an Expenditure Authorization as shown in the table below and in Exhibit "B".

#### MICHELSON WATER RECYCLING PLANT PHASE 2 EXPANSION VARIANCE

#### SUMMARY:

The Michelson Water Recycling Plant (MWRP) Phase 2 Expansion is being completed by J. R. Filanc Construction Company. Additional effort is needed by the SCADA consultant to complete remaining tasks associated with the start-up of the Phase 2 Expansion. Staff recommends that the Board authorize the General Manager to execute Variance No. 9 in the amount of \$52,390 with Delta Systems Engineering for supplemental services associated with start-up and commissioning activities.

#### **BACKGROUND:**

Construction of the MWRP Phase 2 Expansion was awarded to Filanc in July 2009 in the amount of \$87,479,450. This project will expand the recycled water production capacity of MWRP to 28 million gallons per day.

#### Variance No. 9:

Delta has been providing SCADA programming and start-up services since the start of the project. Staff requested Delta to perform additional programming tasks to allow better operational control of the new treatment processes. These tasks were outside of Delta's existing scope of work. To address the extended construction schedule and to support the start-up and commissioning activities, staff requested that Delta submit Variance No. 8 to provide a part-time senior SCADA programmer until June 1, 2014. Variance No. 8 has been expended.

Variance No. 9 includes:

- Support hours to May 31, 2014 Variance No. 8 assumed that Delta would provide a senior integrator at 60% of the time; however, the senior integrator was required to be at MWRP 80% of the time;
- Support hours from June 1 to June 27, 2014 IRWD's start-up team requires that Delta's senior integrator be available 80% of his time during this period to perform SCADA programming;
- SCADA support for IRWD's automation staff in the installation of the terminal servers;
- Support and troubleshoot SCADA system performance and optimization issues; and
- Groundwater Well SCADA enhancements operations staff requested enhancements to the Human Machine Interface (HMI) Screens for Groundwater Wells 2 through 10, to include the addition of Well 6 to the HMI Screen, and the addition of a Navigation Screen for all well sites.

Variance No. 9, in the amount of \$52,390 is attached as Exhibit "A" and describes the services in more detail.

Summarized below are detailed project descriptions:

- Engineering Planning Study Reserves are for general planning studies. For the FY 2014-15 the annual "Water Supply Assessment" and "MWDOC/OCWD Capital Facility Coordination" projects are also combined with the Engineering Planning Reserve projects;
- OCSD Capital Outlay Revolving Fund (CORF) and Equity Adjustment: These EAs are typically presented to the Board with this item. However, IRWD and OCSD are currently completing the 5-Year flow monitoring study for the Irvine Business Complex sewer collection system. This study could affect the projected CORF and Equity Adjustment. Staff anticipates bringing a separate item to the Board of Directors in the FY 2014-15;

- OCSD Solids Handling accounts for IRWD leasing solids handling capacity at OCSD;
- Raise Manholes to Grade FY 2014-15 allocates funds to raise manholes to grade during various City street rehabilitation projects that are constructed throughout the year; and
- Great Park Coordination and SAMP Update: These projects provide for the ongoing coordination of capital facilities and development in the Great Park and Great Park Neighborhoods development. Staff anticipates initiating a major SAMP Update for this area in early FY 2014-15.

There are other annual projects included in the FY 2014-15 Capital Budget where the EAs are within the General Manager's authority. These include projects that allocate budget for GIS support applications, and hydraulic modeling.

#### FISCAL IMPACTS:

Projects 11056 (1790), 21056 (1366), 31056 (1593), 20812 (1410), 20947 (5299), 11469 (1520), and 21469 (1167) are included in the FY 2014-15 Capital Budget for the total budgeted amount of \$2,244,600.

#### ENVIRONMENTAL COMPLIANCE:

Projects 11056, 21056, 31056, 11469, and 21469 are exempt as each is considered a planning study, and a ministerial decision under Sections 2150 and 21080 of the Public Resources Code, respectively. IRWD is not the lead agency for project 20812 (OCSD Solids Handling).

The Raise Manhole to Grade Project 20947 is exempt from CEQA as authorized under the California Code of Regulations, Title 14, Chapter 3, Section 15302 C, which provides exemption for projects that involve replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced.

### SILVERADO CANYON DOMESTIC WATER PIPELINE CONSTRUCTION AWARD

### **SUMMARY:**

The Silverado Canyon Domestic Water Pipeline project will construct 7,100 linear feet of 12-inch pipeline from the Fleming Booster Pump Station to the first bridge over Santiago Creek to replace a segment of the existing 50 year old steel pipeline and provide improved fire flow to Silverado Canyon. Staff recommends that the Board:

- Approve an Expenditure Authorization in the amount of \$2,000,300 for Project 11743;
- Find that the irregularity in the bid submitted by Sully-Miller Contracting Company on June 5, 2014 did not affect the amount of the bid or afford Sully-Miller a competitive advantage over the other bidders and waive the irregularity; and
- Authorize the General Manager to execute a construction contract with Sully-Miller in the amount of \$1,742,143 for the Silverado Canyon 12-Inch Domestic Water Pipeline, Project 11743.

### **BACKGROUND:**

Silverado Canyon is served by an existing 8-inch steel pipeline that was installed in 1964 that extends from Fleming Booster Pump Station into the canyon. Three leaks have been repaired on the 50 year old pipeline this past year. This project will replace and upsize approximately 7,100 linear feet of the existing pipeline with a 12-inch PVC pipeline, from Fleming Booster Pump Station to the first bridge over Santiago Creek, as recommended in the Santiago County Water District Facilities Integration Study (January 2008). The replacement will improve the system reliability and fire flow to Silverado Canyon. A project location map is attached as Exhibit "A".

### Construction Award:

The design was completed and the project was advertised for construction on May 16, 2014 to a select list of 13 contractors. Six contractors attended the pre-bid meeting on May 29, 2014. The bid opening was held June 5, 2014 with seven bids received from Sully-Miller, GCI Construction, WA Rasic Construction, Leatherwood Construction, L&S Construction, Vido Artukovich & Son, and Kennedy Pipeline. Sully-Miller is the apparent low bidder with a bid amount of \$1,742,143. The engineer's estimate, prepared by CivilSource, was \$2,148,481. The remaining six bids ranged from \$1,806,959.80 to \$2,821,168.80. The Bid Summary is attached as Exhibit "A".

Staff reviewed Sully-Miller's bid and identified a minor irregularity in the bid. Sully-Miller's bid contained a minor irregularity in the construction schedule consisting of a project duration that exceeds the contract time of 210 calendar days as stated in the Bid Documents. This is an apparent clerical error, as the submitted schedule equals approximately 210 *work* days. The

contract time of 210 *calendar* days will be binding. Staff conferred with legal counsel and legal counsel concurred that there is a sufficient basis for a factual finding by the Board that the irregularity in Sully-Miller's bid is inconsequential and cannot have affected the bid amount or given the bidder a competitive advantage over the other bidders. Staff recommends waiving the bid irregularity and awarding the construction contract to Sully-Miller in the amount of \$1,742,143.

### FISCAL IMPACTS:

Project 11743 (4919) is included in the FY 2014-15 Capital Budget. Staff requests approval of an Expenditure Authorization as shown in the table below and in Exhibit "C". The cost of the pipeline replacement is being split 72.7% to the Replacement Fund and 27.3% to Improvement District 155. The split is based on the construction cost to replace the existing aging 8-inch pipeline with new and the additional construction cost of upsizing the pipeline to 12-inches, respectively.

### ENVIRONMENTAL COMPLIANCE:

This project is exempt from the California Environmental Quality Act (CEQA) and in conformance with California Code of Regulation, Title 14, Chapter 3, Sections 15301 and 15303, a Notice of Exemption was filed with the County of Orange on February 13, 2014. Section 15303 provides exemption for construction and location of limited numbers of new, small facilities or structures, installation of small new equipment and facilities in small structures and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure. Examples of this exemption include water main, sewage, electrical and other utility extensions including street improvements of reasonable length to serve such construction.

### **COMMITTEE STATUS:**

Construction awards are not routinely taken to Committee prior to submittal for Board approval.

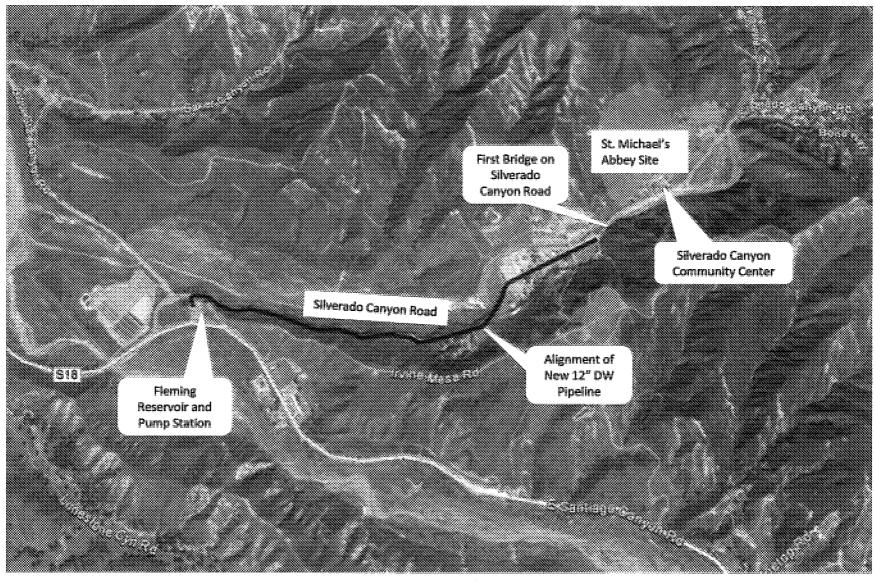

### PORTOLA SPRINGS 16-INCH RECYCLED WATER PIPELINE CONSTRUCTION AWARD

### **SUMMARY:**

This project will construct a permanent 16-inch recycled water pipeline to replace an existing above-ground 16-inch temporary pipeline located on the University of California's Agriculture & Natural Resources' South Coast Field Station between Ridge Valley and Lambert Road. Staff recommends that the Board:

- Authorize a budget increase for Project 30433 in the amount of \$40,200 from \$284,500 to \$324,700;
- Approve an Expenditure Authorization in the amount of \$285,000 for Project 30433; and
- Authorize the General Manager to execute a construction contract with TE Roberts, Inc. in the amount of \$184,665.90 for the Portola Springs 16-inch Recycled Water Pipeline, Project 30433.

### **BACKGROUND:**

The original "Lambert Reach" of the Irvine Lake Pipeline (ILP) was constructed in 1977 to supply ILP water to Lambert Reservoir and to provide irrigation of various agriculture properties in the vicinity. As part of the development of Portola Springs, the ILP was converted to Zone C recycled water and a temporary above-ground pipeline segment was constructed in 2006 to provide a loop connection between the ILP and the new Zone C system, becoming a secondary source to the Zone C reservoir in Tomato Springs.

This project will replace the existing above-ground temporary pipeline with a permanent pipeline located on the University of California's Agriculture & Natural Resources' South Coast Field Station land, between Ridge Valley and Lambert Road. A Location Map is attached as Exhibit "A". The proposed pipeline improvements include approximately 1,200 feet of 16-inch diameter recycled water pipeline and appurtenances, the removal of the existing above ground recycled water pipeline, and the reconstruction of the existing road over the pipe trench.

### Construction Award:

The design was completed and the project was advertised for construction on May 5, 2014 to a select list of 12 contractors. Two contractors attended the pre-bid meeting on May 22, 2014. The bid opening was held June 5, 2014 with four bids received from GCI Construction, Inc., Kennedy Pipeline Company, L&S Construction, Inc. and TE Roberts, Inc. TE Roberts is the apparent low bidder with a bid amount of \$184,665.90.

Staff reviewed TE Roberts' bid and has determined that it is responsive. The engineer's estimate, prepared by MBF Consulting, was \$222,407. TE Roberts was recently added to the list of prequalified

contractors and this will be their first project with IRWD. The remaining three bids ranged from \$253,657.35 to \$286,158.80. Staff recommends awarding the construction contract to TE Roberts in the amount of \$184,665.90. The Bid Summary is attached as Exhibit "A".

### FISCAL IMPACTS:

Project 30433 (4951) is included in the FY 2014-15 Capital Budget. Staff requests a budget increase and Expenditure Authorization to fund the construction as shown in the table below and in Exhibit "C".

This project is exempt from the California Environmental Quality Act (CEQA) and in conformance with California Code of Regulation, Title 14, Chapter 3, Section 15282 in that the installation of the new pipeline and demolition of the existing pipeline as set forth in Section 21080.21 of the Public Resources Code, is less than one mile (or 5,280 ft) in length. 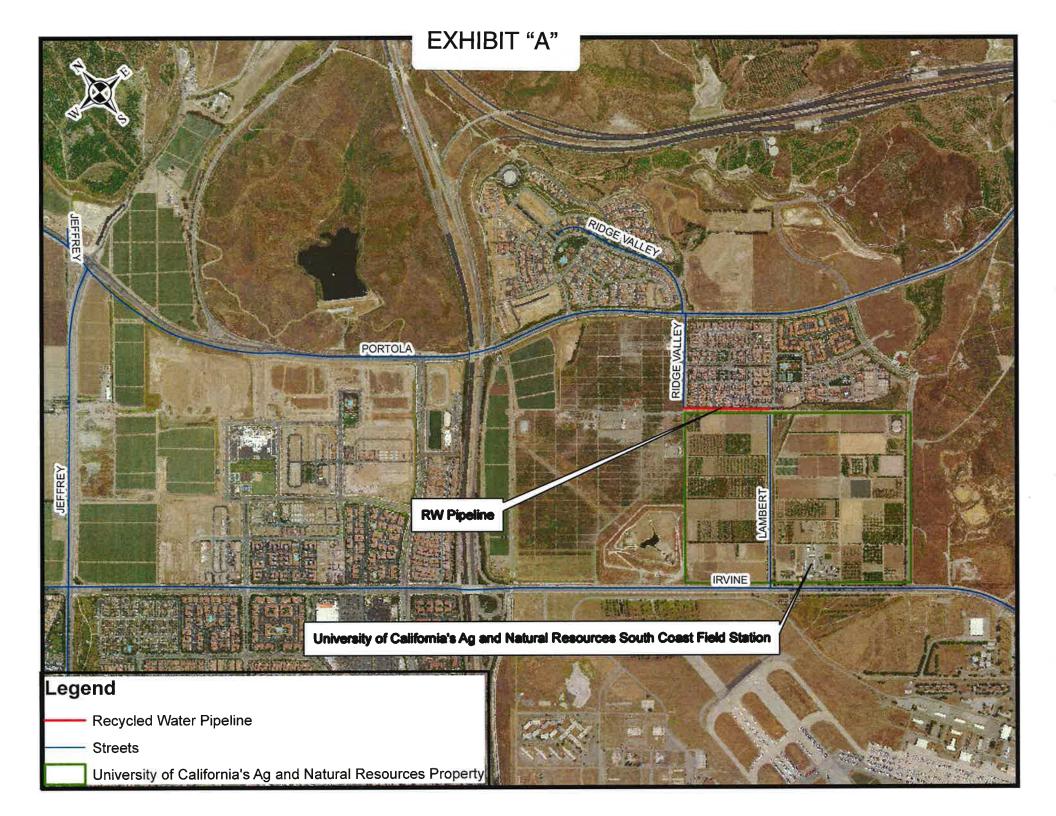

## STRAND RANCH WELL OPTIMIZATION AND MONITORING PROJECT BUDGET INCREASE, EXPENDITURE AUTHORIZATION, <u>CHANGE ORDERS AND VARIANCES</u>

## **SUMMARY:**

On March 10, 2014, the Board approved the Strand Ranch Well Optimization and Monitoring Project (Project) to lower the pumps and install wellhead monitoring and remote telemetry equipment at six Strand Ranch extraction wells. The Project is currently under construction. In March 2014, the Compromise and Release Agreement between IRWD and Bakersfield Well & Pump (BWP) for the replacement of SREX-4 was executed and BWP is preparing to drill and construct a new SREX-4 well (SREX-4R). Additional budget and Expenditure Authorization are required for change order work and to fund the cost of design, construction and construction management for the reconnection and start up of SREX-4R, as well as to perform work related to lowering of the pump and installation of the wellhead telemetry equipment for the new SREX-4R. Staff recommends the Board:

- Authorize a net increase to the FY 2014-15 Capital Budget in the amount of \$153,100 which includes an increase to Project 11794 in the amount of \$211,500, from \$501,600 to \$713,100, and a decrease for Project 11289 in the amount of \$58,400 from \$17,739,700 to \$17,681,300;
- Approve an Expenditure Authorization for Project 11794 for \$211,500;
- Authorize the General Manager to execute Change Order Nos. 2 and 3 with Bakersfield Well & Pump in the amount of \$106,731 for additional cost of stainless steel couplings, work to lower the pump and install wellhead monitoring equipment on SREX-4R and to start up SREX-4R;
- Authorize the General Manager to execute Variance No. 2 with Kennedy/Jenks Consultants in the amount of \$14,536 to provide additional design services to add SREX-4R replacement well to the Strand Ranch Well Optimization and Monitoring Project and to prepare record drawings; and
- Approve Variance No 1 with Dee Jaspar & Associates in the amount of \$28,630 to provide construction oversight services for the replacement of SREX-4R and for the pump lowering and instrumentation installation work for SREX-4R.

## **BACKGROUND:**

On September 30, 2011, IRWD completed construction of the Strand Ranch Recovery Facilities Project including the construction of six new wells and the rehabilitation of one existing well. The seven wells were designed and constructed to provide a total extraction capacity of 36 cfs with the expectation that up to 40 cfs could be recovered on a short-term basis. The well pumps were installed at an elevations based on consideration of the historical range of groundwater levels. The location of the wells is shown in Exhibit "A".

In April and May 2013, six Strand Ranch wells began pumping groundwater and the seventh well, SREX-4, was not in operation yet due to a construction defect that was being resolved. As a result of the ongoing drought conditions and increased regional pumping, static water levels in the Kern Fan area have significantly declined and have fallen below historic record lows. In March 2014, the Board approved the Project to lower the pumps and install wellhead monitoring and remote telemetry equipment at six of the Strand Ranch wells. The Board authorized a sole source contract with BWP for the construction services for the Project up to \$425,000, contingent upon the execution of the Compromise and Release Agreement (Agreement) for the replacement of SREX-4. The Board also authorized a Professional Services Agreement with DJA for construction management services for the Project. The Agreement was executed on March 13, 2014, and a construction contract for the Project was executed with BWP in the amount of \$425,000.

The Agreement included requirements for BWP to abandon the existing SREX-4, drilling and construction of a replacement well and relocating and constructing pipelines and appurtenances consistent with the original design. It did not include reinstalling the pump, motor and well enclosure or making any electrical connections or wellhead equipment testing. In addition, the agreement did not include a requirement for water quality testing that will be required to discharge water from SREX-4R to the Cross Valley Canal.

## Contract Change Order No. 1:

Contract Change Order (CCO) No. 1 in the amount of \$12,349.95 includes the cost of adding enclosures with panel louvers and relays for the telemetry units on the six Strand wells. It also includes additional cost to transport the bowl assemblies for SREX-1, 2 & 6 to BWP's shop to dissemble, inspect and reassemble the equipment. This change order was executed under executive director authority within the existing budget and Expenditure Authorization. However, additional budget for CCO No. 1 is requested in the amount of \$12,349.95 to complete the project.

## Contract Change Order No. 2:

CCO No. 2, in the amount of \$6,400, includes the additional cost to provide and install 316 stainless steel couplings on the line shafts of the six wells. CCO No. 2 is attached in Exhibit "B".

## Contract Change Order No. 3:

CCO No. 3 includes the work associated with repairing and reinstalling the pump, motor and well enclosure for the new SREX-4R, establishing electrical connections, as well as testing the wellhead equipment and discharge piping. This work was excluded in the Agreement. CCO No. 3 also includes the work to lower the pump, install the instrumentation for SREX-4R, and shop inspection of the SREX-6 motor. BWP's cost for this work is \$100,331. CCO No. 3 is attached in Exhibit "B".

## Kennedy/Jenks Consultants Variance:

Kennedy/Jenks Consultants (KJC) completed the design of the facility modifications for the replacement of SREX-4 well. A variance to KJC's professional services agreement is needed to provide additional design services for SREX-4R to lower the pumps and install telemetry equipment, as well as to provide record drawings. KJC's variance request in the amount of \$14,536 is provided as Exhibit "C".

## Dee Jaspar & Associates Variance:

Dee Jaspar & Associates (DJA) is providing construction management services for the Project. Staff recommends DJA also perform daily site inspections, safety monitoring, processing requests for information and submittals, preparing field inspection reports and reviewing record drawings for the drilling and replacement of well SREX-4. DJA has submitted a scope of work and budget for this work in the amount of \$21,000. In addition, DJA has submitted a scope of work and budget for the site inspection and construction management services for the lowering of the pump and installation of wellhead monitoring equipment for the new SREX-4R well in the amount of \$7,630. DJA's variance in the amount of \$28,630 is provided as Exhibit "D".

## FISCAL IMPACTS:

Projects 11794 (Strand Ranch Facilities) and 11289 (Strand Well Optimization and Monitoring) are included in the Fiscal Year 2014-15 Capital Budget. Staff budgeted \$58,400 for IRWD's share of the SREX-4 replacement work under Project 11289 and requests a budget decrease of \$58,400 for Project 11289 and to reallocate these funds to Project 11794 for this work. Staff requests a budget increase and Expenditure Authorization for Project 11794 in the amount of \$153,100, This amount funds the previous Change Order No. 1 work for \$12,349.95, Change Order No. 2 for \$6,400, Change Order No. 3 for \$100,331, a KJC variance for \$14,536, a DJA variance for \$28,630, and additional staff time, water quality testing and contingency. The budget requests and Expenditure Authorization are shown in the table below and in Exhibit "E".

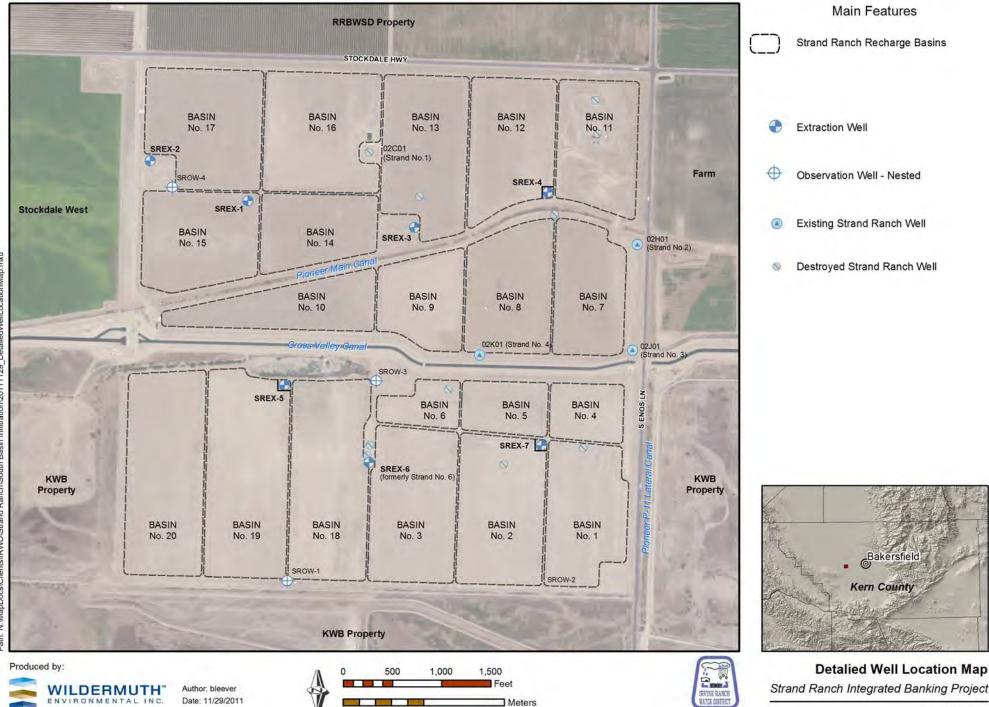

We are pleased to submit our proposal to design modifications to the SREX-4R wellhead facilities to include this well into the Strand Ranch Well Pump Setting Optimization and Monitoring Project, as requested by IRWD. This proposal includes scope, schedule and fee.

## **Project Background**

It is our understanding that Bakersfield Well and Pump (BWP) are constructing SREX-4R as a replacement well for SREX-4, but their scope does not include lowering the pump below the original pump setting or installing remote monitoring improvements. Based on discussions with IRWD, design documents are needed for BWP to lower the pump setting in SREX-4R to accommodate the lowest potential water levels and to provide remote monitoring improvements, consistent with modifications being made at the other six Strand Ranch Recovery Wells. Design documents will include modifications to the design plans and an addendum to the Project Manual. An estimate of probable construction cost will not be required.

Since the final design will be based on the results of drilling, coordination with the Project Hydrogeologists will be required, along with updates to supporting hydraulic analysis to verify the pump setting recommendation for SREX-4R (as provided in the 3 March 2014 Technical Memorandum prepared by Kennedy/Jenks for the Strand Ranch Well Pump Setting Optimization and Monitoring Project). Since this is a replacement well, we assume that well construction for SREX-4R will be the same as the original well SREX-4, including the screened interval, blank casing section (for lower pump setting), and camera tube (for level transducer).

IRWD has requested that Record Drawings for the construction of SREX-4R be included in this scope of work and incorporated into the Record Drawings for the Well Optimization and Monitoring Project.

## **Scope of Work**

The scope of work will be included as Task 6 under the Strand Ranch Well Pump Setting Optimization and Wellhead Telemetry project with the following three subtasks:

Subtask 1 – Coordination with Project Hydrogeologists' and Update of Hydraulic Analysis for SREX-4R

This task includes the following activities:

- Coordination with the Project Hydrogeologist during drilling, including review of well construction specifications, results of pump tests, and updates to lowest pumping level for SREX-4R. We assume the Project Hydrogeologist will develop the well construction specifications and verify the lowest pumping level for SREX-4R. We assume one conference call with IRWD and the Project Hydrogeologist will be sufficient to coordinate this effort.
- Hydraulic analysis to confirm the estimated flows using the existing pump in SREX-4R at the lower pump setting, at two operating levels (i.e., at the top of screen and at the lowest potential pumping level). We assume that the well/aquifer yield for SREX-4R will be confirmed by the Project Hydrogeologist. We assume one conference call with IRWD will be sufficient to review the hydraulic analysis.

 Supplement to 3 March 2014 Technical Memorandum with Updated Hydraulic Calculations for SREX-4R.

Subtask 2 – Modify Design Plans and Prepare Change Order to Project Manual to Incorporate SREX-4R into the Strand Ranch Well Optimization and Monitoring Project Design Documents

We will modify the March 2014 Final Design Plans for the Strand Ranch Well Optimization and Monitoring Project, as follows:

- G-1 Title Sheet Revise Sheet Index to include new Electrical Site Plan for SREX-4R (E-4A).

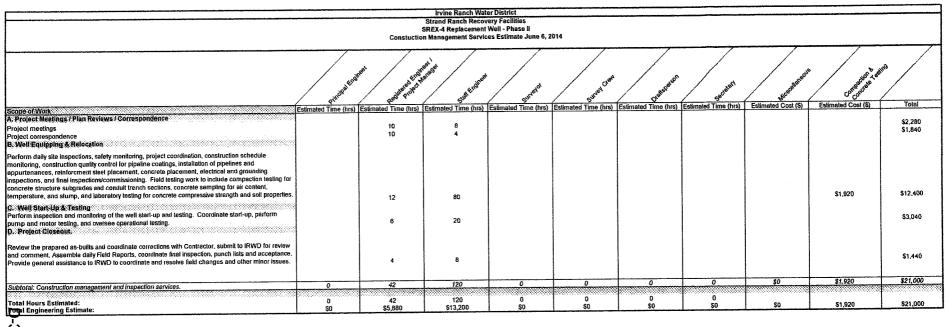
