## PUBLIC HEARING

## PROPOSED CHANGES TO THE SCHEDULE OF RATES AND CHARGES EFFECTIVE JULY 1, 2015

#### **SUMMARY:**

The Fiscal Year (FY) 2015-16 Operating Budget was adopted at the June 8, 2015 Board meeting and at that same meeting the Board adopted a resolution receiving the IRWD Cost of Service Study. The proposed changes to the District's rates and charges were publicly noticed by mail as required under Proposition 218, and protests to the implementation of those rates and charges have been tallied by the District. As of June 18, 2015, seven written protest letters were received by the District, which represents 0.01% of the total customers, substantially less than the 50% which would have been required to prevent the Board from adopting the current proposed rates and charges. Protests may be received up until the commencement of the public hearing; staff will provide an updated report as part of the hearing process.

Pursuant to the requirements of Proposition 218, a Public Hearing on the rates and charges is required. Following the Public Hearing, staff recommends that the Board adopt the proposed changes to the Schedule of Rates and Charges required to fund operating expenses.

## **BACKGROUND:**

## Proposed Rates and Charges for FY 2015-16:

A redline version showing the changes to the rates and charges proposed for FY 2015-16 is attached as Exhibit "B". The proposed changes include both updates identified through the rate setting process and changes to the wording and format to better communicate the application of the District's rates to the customer. As mentioned in the previous meetings, the Orange Park rate area will be merged into the Irvine Ranch rate area effective July 1, 2015.

The budget and rate setting process for FY 2015-16 included several distinct components:

- The Governor issued an Executive Order directing the State Water Resources Control Board (SWRCB) to impose restrictions to achieve an aggregate statewide 25% reduction in potable urban water use through February 2016. The SWRCB identified final regulations to implement the 25% Conservation Standard on May 5, 2015 based on the relative residential per capita water usage (gallons per capita per day, or GPCD) of each water supplier's area for the reporting period of July through September 2014 R-GPCD values. Based on IRWD's 91.4 GPCD, the SWRCB's proposal requires that IRWD achieve a 16% reduction in potable usage.
- Staff modified the FY 2015-16 Operating Budget to incorporate the final regulation into the rate setting process and presented the revised budget and proposed rates along with options on how to achieve the required reductions at a Board Workshop on April 27, 2015. The updated budget was approved by the Board at the May 26, 2015 meeting.
- Carollo Engineers, Inc. presented a draft Cost of Service Study based on the FY 2014-15 operating budget to the Finance and Personnel Committee during the initial budget

budget process. Based on the changes recognized from the state mandate and the potential impact from the continuing drought, the District chose to have Carollo apply the Cost of Service approach to the modified FY 2015-16 operating budget for rate setting. The final study was received by the Board at the June 8, 2015 Board meeting.

All changes from the factors identified were included in the budget and rate setting process. Staff has reviewed costs and revenues for the treated water system, the untreated water system, the sewer system, and the recycled water system. As a result of this review, changes to the water and sewer rates for the Irvine Ranch rate area and the Los Alisos rate area recommended for FY 2015-16 include:

## Irvine Ranch Rate Area

Treated Water System:

- An increase to the low volume rate of \$0.23, from \$0.88 per ccf to \$1.11 per ccf.
- An increase to the base commodity rate of \$0.28 per ccf, from \$1.34 per ccf to \$1.62 per ccf.
- A decrease of \$0.20 to the current monthly service charge, from \$10.50 to \$10.30, which includes monthly user rate contributions of \$1.45 per month for water capital infrastructure replacements and \$0.70 per month for water capital infrastructure enhancements.

Sewer System:

• The sewer rate setting process included one significant shift. Residential customers have historically been placed in one of three tiers based on average water usage (0-5 ccf, 6-10 ccf, or over 10 ccf) over a calendar year. The rate will now be determined based on the three lowest months of usage, which eliminates the additional water used for landscape during summer months from the average since this water does not flow into the sewer treatment system. This shift moved approximately 40% of the District's residential customers from the top tier down to the lower two tiers. The lower tiers for FY 2014-15 would require an increase to make up for the lost revenue from the top tier. Prior to any operational increases for the new fiscal year, the existing tiers would increase and increase doperating costs for the FY 2015-16 are then applied to the adjusted rates:

• The increase to the adjusted monthly service charge is \$1.95, which includes monthly user rate contributions of \$7.35 per month for sewer/recycled water capital infrastructure

replacements and \$0.70 per month for sewer and recycled water capital infrastructure enhancements. The \$7.35 per month user rate contribution includes an additional \$0.65 per month from FY 2014-15 to provide funding for a significant portion of the bio-solids treatment facility.

Recycled Water System:

- The recycled commodity rate is no longer set as a percentage of the potable rate (previously 90%). The rates identified will provide the necessary funding for the recycled system.
- An increase to the low volume rate of \$0.29, from \$0.79 per ccf to \$1.08 per ccf.
- An increase to the base commodity rate of \$0.18 per ccf, from \$1.19 per ccf to \$1.37 per ccf.
- A decrease of \$0.20 to the current monthly service charge, from \$10.50 to \$10.30, for the recycled system.

## Los Alisos Rate Area (ID 135/235)

Treated Water System:

- An increase to the low volume rate of \$0.13, from \$1.51 per ccf to \$1.64 per ccf.
- An increase to the base commodity rate of \$0.08 per ccf, from \$2.31 per ccf to \$2.39 per ccf.
- A decrease of \$0.20 to the current monthly service charge, from \$10.50 to \$10.30, which includes monthly user rate contributions of \$1.45 per month for water capital infrastructure replacements and \$0.70 per month for water capital infrastructure enhancements.

Sewer System:

• The sewer changes mirror those identified for the Irvine Ranch rate area because the District has one sewer system.

Recycled Water System:

• The recycled changes mirror those identified for the Irvine Ranch rate area because the District has one recycled system.

The proposed treated water tiered rates for both rate areas are as follows (per ccf):

A proposed redline version of the schedule of rates and charges is provided as Exhibit "B", and contains the proposed rates for both rate areas.

## User/Replacement and Enhancement Capital Component:

The replacement component was increased for water and sewer as noted above. The added component is estimated to generate an additional \$3.5 million for the systems. Combined with the existing replacement and enhancement rate components, the total capital components are estimated to generate \$5.6 million and \$17.5 million on the treated water and sewer systems, respectively.

## Comparison to City of Orange Rates:

On August 28, 2006, IRWD and the City of Orange executed an agreement by which IRWD would provide services to the area known as the "Santiago Hills II / East Orange Area". One of the conditions stipulated in this agreement was that the cumulative fixed and commodity charges for water service to an IRWD customer using the median amount of water would not exceed the same charges incurred by a customer in the City of Orange using the median amount of water in the City. Based on the rates as proposed for FY 2015-16, a customer in IRWD using the median amount of water (11 ccf per month) will pay an average of \$25.57 per month for water service fixed and commodity charges. Based on the most current water rates in the City of Orange, a customer using the IRWD median amount of water (11 ccf per month) will pay an average of \$27.24 per month for water service fixed and commodity charges.

## Proposition 218 Notice:

Proposition 218, enacted in 1996, mandates that proposed increases in "property-related fees" must be noticed to property owners, and that such owners have an opportunity to protest prior to the enactment of the fee increases. While water districts and sewer agencies throughout the state believed, based on court decisions, that water and sewer service was exempt from this requirement, in July 2006, the California Supreme Court issued a decision in the matter of <u>Bighorn</u>, which held that water delivery charges are property-related. Following the Supreme Court's logic, most interpretations of the decision are that both water and sewer charges should be noticed in order to be in compliance with Proposition 218.

Under Proposition 218, the notice to customers must be sent to all property owners. As permitted by statute, the District sent its notices to all of its customers (including tenants) in the District's service area at their billing addresses.

The District contracted with Davis Farr, Certified Public Accountants to collect and count the rate increase protests. They will provide management with a report prior to the Board meeting on June 22, 2015 (45 days from the date of mailing the Prop 218 notices), and they will be present at the Public Hearing established for approval of the rates to answer questions on the process and final results.

The District received all written protests from property owners in the District at a separate post office box from the rest of the District's mail. As of June 18, 2015, seven written protests have been received, representing 0.01% of the 91,638 notices sent, 0.59% were returned as undeliverable. Under Proposition 218, more than 50% of the IRWD customers would have to protest in order to prevent the Board from adopting the Proposed Rates and Charges.

Copies of all seven protest letters received to date are attached as Exhibit "C".

## ENVIRONMENTAL COMPLIANCE:

The establishment, modification, structuring, restructuring or approval of rates, tolls, fares, or other charges by public agencies are exempt from the requirements of the California Environmental Quality Act (CEQA) provided that certain findings are made specifying the basis for the claim of exemption. The necessary findings are contained in the proposed resolution.

## FISCAL IMPACTS:

The District's FY 2015-16 Consolidated Operating Budget totals \$140.4 million, representing a \$9.7 million or 7.5% increase from the Fiscal Year 2014-15 Operating Budget. The proposed adjustments to the District's Schedule of Rates and Charges will generate approximately \$3.9 million of additional revenue for the treated water system and approximately \$7.7 million of additional revenue in the sewer system.

Included in the additional revenue is \$3.3 million generated to provide funding for replacement capital, including the biosolids project, for both the water and sewer system.

#### **RESOLUTION NO. 2015 -**

## RESOLUTION OF THE BOARD OF DIRECTORS OF IRVINE RANCH WATER DISTRICT, ORANGE COUNTY, CALIFORNIA ADOPTING CHANGES TO THE SCHEDULE OF RATES AND CHARGES AS SET FORTH IN EXHIBIT "B" TO THE RULES AND REGULATIONS OF IRVINE RANCH WATER DISTRICT FOR WATER, SEWER AND RECLAIMED WATER SERVICE

WHEREAS, the Irvine Ranch Water District (IRWD) is a California Water District organized and existing under the California Water District Law, and all of the lands within the boundaries of said District are located in the County of Orange, State of California; and

WHEREAS, Sections 35423, 35470 and Section 35501 of the California Water Code empower the District to establish, print and distribute equitable rules and regulations and prescribe and collect rates or other charges for water and sewer service; and

WHEREAS, the Board of Directors of IRWD, by adoption of Resolution No. 2014-50 approved and adopted amended "Rules and Regulations of Irvine Ranch Water District for Water, Sewer, Recycled Water, and Natural Treatment System Service," effective November 10, 2014 "; and

WHEREAS, Exhibit "B" of said Rules and Regulations sets forth Rates and Charges, which Exhibit "B" may be changed from time to time by adoption of changes to any of the rates and charges or any new rates and charges as may be established and set forth therein; and

WHEREAS, Section 21080(b) (8) of the Public Resources Code provides that the establishment, modification, structuring, restructuring or approval of rates, tolls, fares, or other charges by public agencies are exempt from the requirements of the California Environmental Quality Act (CEQA) provided that certain findings are made specifying the basis for the claim of exemption; and

WHEREAS, Article XIIIB of the Constitution of the State of California, limiting local agencies' appropriations of proceeds of taxes, excludes user charges or fees or regulatory fees from the definition of proceeds of taxes, as long as such fees and charges do not produce revenue exceeding the costs reasonably borne in providing the regulation, product or service, and further excludes appropriations for debt service and appropriations for qualified capital outlay projects from appropriations subject to limitation; and

WHEREAS, IRWD has conducted a cost of service and rate design study through its consultant, Carollo Engineers, and the Board of Directors has received the final study dated June 18, 2015 (the "Cost Study"); and

WHEREAS, the Board of Directors of IRWD deems it advisable and finds that it would be in the best interest of the District to amend or establish certain rates and charges,

consistent with applicable constitutional and statutory requirements and consistent with recommendations described in the Cost Study; and

WHEREAS, Article XIIID of the Constitution of the State of California provides that, in imposing or increasing any property-related fee or charge, an agency shall provide written notice by mail of the proposed fee or charge to the record owner of each identified parcel upon which the fee or charge is proposed for imposition, the amount, basis of calculating, and reason for such proposed fee or charge, and the date, time and location of a public hearing on the proposed fee or charge to be conducted not less than 45 days after the mailing of said notice, and Government Code Section 53755 provides for such notice to be given by mailing to the address where billing statements are customarily sent by the District;

WHEREAS, a mailed notice was given, setting Monday, June 22, 2015, at the hour of 5:00 p.m. of said day in the Board of Directors Room of Irvine Ranch Water District, 15600 Sand Canyon Avenue, Irvine, California, as the time and place for a public hearing on the proposed increases in property-related rates and charges and any proposed new property-related rates and charges set forth in Exhibit "A" to this resolution; and

WHEREAS, at the time set, the duly noticed public hearing was held and all persons interested were given an opportunity to be heard concerning the increases in propertyrelated rates and charges and any proposed new property-related rates and charges;

WHEREAS, this Board of Directors has considered all protests presented to the District by owners of identified parcels against the proposed increases in property-related rates and charges and any proposed new property-related rates and charges;

follows:

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of IRWD as

<u>Section 1</u>. It is hereby found and determined that the number of written protests presented to the District against the proposed increases in property-related rates and charges and any proposed new property-related rates and charges has been tabulated and does not constitute a majority of the number of owners of identified parcels.

Section 2. It is hereby found and determined that the proposed changes to the Schedule of Rates and Charges are within the purposes set forth in Section 21080(b) of the Public Resources Code including but not by way of limitation, the purposes of (1) meeting operating expenses, (2) purchasing or leasing supplies, equipment or materials, (3) meeting financial reserve needs and requirements, and (4) obtaining funds for capital projects necessary to maintain service within existing areas, and therefore, that such changes are exempt from CEQA.

<u>Section 3.</u> The recommendations set forth in the Cost Study (Section 4.3.2 - decoupling of recycled water rates; Section 4.5.1 – low volume credit; and Section 4.5.6 – three month minimum use to establish volumetric sewer service charge blocks) are hereby adopted.

<u>Section 4</u>. It is hereby found and determined that the rates, charges and fees adopted hereby are imposed upon the request for or use of services; that the rates, charges and fees recover and allocate the costs of service in accordance with the criteria and requirements of

the Constitution of the State of California; and that the water user charges satisfy the criteria and requirements of Water Code Sections 370 *et seq.* relating to allocation-based conservation water pricing.

<u>Section 5.</u> It is hereby found and determined that relative to Article XIIIB of the Constitution of the State of California, the user charges and fees and regulatory fees established or increased hereby do not produce revenues exceeding the costs reasonably borne in providing the regulation, product or service and/or are used for debt service or qualified capital outlay projects and accordingly do not constitute proceeds of taxes, the appropriation of which is limited under Article XIIIB, and that the documentation used in making such determinations has been on file in the office of IRWD for not less than 15 days prior to the date hereof, pursuant to Section 7910 of the Government Code of the State of California.

Section 6. The new and/or revised rate(s), fee(s) and/or charge(s) as set forth in Exhibit "A" attached to this resolution and by this reference incorporated herein are hereby adopted, and the corresponding rate(s), fee(s) or charge(s), if any, as set forth in Exhibit B currently in effect, are hereby superseded. Staff is directed to incorporate the hereby adopted new and/or revised rate(s), fee(s) and/or charge(s) into Exhibit "B" to the Rules and Regulations.

<u>Section 7.</u> That the provisions of this Resolution shall be effective upon adoption.

<u>Section 8.</u> That the Secretary is hereby ordered and directed to post a certified copy of this Resolution in a public place within the Irvine Ranch Water District.

## 2. Variances from Ascending Tiered Rate Allocations

Water allocations are based on the number of residents, landscape square footage and actual daily weather and evapotranspiration (ET) data for each of three microclimates within the District rate area. Variances are available for larger than normal landscaped areas, more people living in the home or special medical needs.

## 3. Grounds for Variance

Proof acceptable to the District will be required for each ground(s) of variance.

#### a. Number of people residing in a residential dwelling unit.

Each additional person increases the base by 1.6 ccf/month (indoor usage factor x 0.8)

#### b. Landscape

Increased allocations shall be given for residential lot size beyond the standard base allocation lot size. It is the obligation of the customer to provide to the District acceptable documentation of the actual irrigated landscape area served.

#### c. Medical Needs

- Approval is contingent upon medical documentation.
- Increased allocation will be determined on a case by case basis and based on the type of medical need.

#### d. Licensed Care Facilities (in a residential dwelling unit)

- A current license from appropriate regulatory agency will be required.
- A licensed 24-hour care facility will be allocated increases based on the additional people per dwelling unit formula at 1.6 ccf per month per additional person.
- A licensed day care facility (not 24-hour) will be granted one ccf per additional person of the licensed 24-hour care facility.
- Additional allocation for medical reasons will be determined on a case by case basis.

#### e. Fire Control Zones

 Adjustments to allocations will be determined by the District based upon relevant factors such as area, slope, planting material, etc.

#### f. Commercial/Industrial/Public Authority

 Adjustments to the base allocation will be determined on a case by case basis. Relevant factors will include expansion of productive capacity, existing conservation practices that can be shown to have reduced water usage, severe economic hardship, etc.

#### g. New Account Establishment Variance

Landscape Accounts - will be placed on conservation base rate for the first six months.

<u>Commercial and Industrial Accounts</u> - will be placed on conservation base rate for the first six months.

## 4. Limitations

1

**a.** An approved variance will become effective on the date the request for variance is submitted to the District, but must be submitted within thirty (30) days of receipt of the bill.

**b.** Approvals are valid for a period specified by the District (one year or less), and must be resubmitted on or before the expiration date to remain in effect.

## 5. Effect of Increased Allocations

#### a. Residential:

Approved variances will extend each tier of the residential structure by a percentage.

#### b. Non-Residential:

Approved variances will extend each tier of the non-residential structure by a given percentage (or other method) determined on a case by case basis.

## **New Account Fees for Water Service**

This section is applicable to all requests for new or transferred service.

#### 1. Charges

1

A fee of \$2025.00 shall be collected to establish a new account for water and sewer service, or to transfer an existing account to a new location. <u>July 2014, we increased the establishment fee from \$17.00 to \$20.00. We</u> are now proposing another increase between \$22.00 and \$25.00.

## 2. Residential Deposit

For residential customers, a deposit of \$50.00 may be required until a one year payment history is established.

#### 3. Non-Residential Deposit

A deposit of \$100.00 is required until a one year payment history is established.

## Delinquency, Returned Check and Service Restoration Charges

#### 1. Delinquency Charges

All bills and charges for water, sewer and recycled water service shall be due and payable upon presentation and shall become delinquent twenty-five (25) calendar days thereafter. If payment is not made within twentyfive (25) calendar days after presentation, a late charge will be levied upon the unpaid balance as follows:

For residential and non-residential accounts with an unpaid balance of \$10 or more, a one-time charge of 10% of the unpaid balance plus 1.5% interest will be assessed, and each month thereafter the unpaid balance will be subject to an interest charge of 1.5%.

#### 2. Non-Sufficient Funds Checks

A \$20.00 service fee will be charged for each check returned from the bank for non-sufficient funds.

#### 3. Service Restoration Charges

(a) When service is discontinued because of delinquency in payment of a water, sewer, or recycled water bill, the service shall not be restored until all delinquent charges, late charges and interest charges, and a trip charge as specified in (b)(1) or (2), below, have been paid.

(b) When service is discontinued for any reason, including violation of the Rules and Regulations, service shall not be restored until a trip charge as specified in (1) or (2) below has been paid.

- (1) **Trip Charge During Normal Working Hours**: The trip charge applicable for work requested to be performed during normal working hours of the District will be \$70.00.
- (2) **Trip Charge After Normal Working Hours**: The trip charge applicable for work requested to be performed after normal working hours of the District will be \$95.00.

Unmetered water service is not permitted for custom lots. Developers for custom lots will be required to apply for a domestic water construction meter prior to starting construction.

#### Service Installations by District

#### **Sewer Installation Charges**

- 1. A \$100 inspection fee will be charged for sewer laterals installed by the applicant, at no cost to the District, in accordance with District approved plans. The fee is to be paid prior to the approval of the plan for the sewer lateral.
- 2. The plan check and inspection fee for public sewer systems will be calculated as 10% of the bondable cost for the public sewer system or a fixed fee as described above. A non-refundable deposit of 5% of the estimated cost of the sewer system is required with the submittal of the first plan check. The total fee will be due and payable prior to final approval of the plans.

#### Non-Digital Submittal Surcharge

A surcharge fee, calculated as 2% of the bondable cost for the public sewer system will be charged for any plans not submitted with a digital format. The fee is due and payable prior to final approval of the plans.

#### **District Closed Circuit Television Inspection Charges**

#### Initial TV Inspection Fee

A fee of \$.60 per linear foot as measured from the center line of manholes will be charged for all 6-inch and larger sewer lines to be inspected by a closed circuit television camera. The District will furnish the special camera equipment and manpower to fulfill this inspection requirement. This fee is to be paid along with the other connection, meter, and inspection fees prior to the District signing developer's tract utility plans.

#### Reinspection

Fees for Reinspection by District TV Crew after corrective work is completed. Those portions of the pipeline system that have been corrected must be retelevised.

- District fees for retelevising corrective work will be a flat set-up fee of two hundred fifty dollars (\$250.00) plus \$.60 per foot of sewer line reinspected measured centerline to centerline of manholes.
- Payment for retelevising estimated inspection fees must be received by the District Engineering Inspection Division prior to scheduling the reinspection. Retelevising will not be done until the fees are paid.

## **Cancellation of District's TV Inspection**

If it is determined by either the Contractor or Developer that the job site will not be ready or accessible for the television inspection on the scheduled date, as notified, the Contractor shall notify the District Inspection Division of the necessary cancellation at least 24 hours in advance of the scheduled inspection to avoid being charged a cancellation fee.

- 1. If the District's television crew arrives at the job site and the work is not ready or accessible, the Contractor and owner will be billed for the cancellation fee of two hundred fifty dollars (\$250.00), payable to the District prior to the date of the rescheduled television inspection.
- 2. A rescheduled inspection is to be made through the District's project inspection division.

#### **Optional Developer TV Inspection**

If the Contractor or Owner desires to have a portion of, or the entire job, TV inspected for his convenience, he will be charged a fee of one hundred fifty dollars (\$150.00) plus \$.60 per foot of sewer line inspected measured centerline to centerline of manholes.

We are IRWD customers and the owners of 3 North Cove, Irvine, CA. We received a "Notice of Proposed Water and Sewer Rate Change". While we understand that there is a water shortage we believe that we are being unfairly burdened by the IRWD.

In 2013, we removed the landscaping in our yard and in May of 2014, we replaced the landscaping with desert landscaping that uses very little water. Notwithstanding a water leak that we had in the summer of 2014, we have greatly reduced our water consumption voluntarily. Now we are being told that unless we reduce further we will pay higher rates.

I normally do not get involved with giving feedback to proposed Water and Sewer Rate Changes. I do know you have a demanding job and it can be difficult (basically impossible) to satisfy everyone. But I thought I would give my two cents as I feel the proposed increase in rates is outrageous even given the desperate water climate we find ourselves in today.

Since you are a quasi-governmental agency and have a monopoly on our water services, I was wondering if you had investigated other ways of "cutting back" besides transferring the undue burden of record rate increases on the consumer? Some ideas:

- 1) I have been to your various office and service locations and it seems as if you have excessive office and facility space and it is not being used in the most efficient manner possible. Have you considered downsizing, subleasing, or an outright sale of some your properties in order to operate more efficiently? I am also aware of some excess land near your Michelson facility that could generate substantial income via a sale to the city (for park purposes) or a private developer.
- 2) Have you reviewed how much money is spent on consultants and looked into any ways on negotiating a better rate or cutting back on all but essential items?
- 3) Have you reviewed your staffing to determine if you are overstaffed or just "top heavy" and in need of cutbacks, hiring freeze, or re-assignments?

I would appreciate your discussing some of the options above (if you have not already placed them on the table) instead of hammering the consumer with this historic rate increase.

I appreciate your service and do hope you can find ways mitigate the proposed consumer fee increases by reevaluating operations to make sure you are operating at peak efficient performance.

Dear Board of Directors:

Thank you for your time in considering my letter. I understand that there are many difficult decisions to be made regarding our water resources, and I appreciate the very hard work you do to establish a fair and equitable system in light of our diminishing water supply.

I wish to bring to the Board's attention, the impact of the proposed changes for water service charges. During the last changes on July 1, 2014, IRWD changed the water service charge amongst the  $5/8 \times 3/4$ ", 3/4" and 1" disc meters. Previously, these three disc meters were the same price. As my home has a 1" disc meter, my water bill increased \$8.15 which was an approximately 25% increase.

I would like to point out that the vast majority of IRWD residential customers are tract homes (such as mine) and when we purchased our homes from the builder, we had no choice in the type of water meter installed. Indeed, at the time they were installed, there was no difference in charges between the 3/4" and 1" meter sizes. In fact, I had no idea what size water meter my home contained until my water bill increased 25% and I had to investigate.

I do not believe having a larger water meter has any effect on water conservation. Per my understanding, a larger water meter allows the recipient to have increase water flow *capacity*, but does not inherently cause the recipient to use any more water compared to other meter sizes. Indeed, this is the one charge, in which a customer is entirely helpless as there is nothing a customer can do short of re-plumbing the entire home in order to match a smaller disc meter.

I would like to respectfully request the Board consider returning to the prior system where  $5/8 \times 3/4$ ", 3/4" and 1" disc meters (the three most common disc meters for residential homes) are the same charge. I believe, discriminating amongst the three meter sizes, has absolutely no effect on encouraging customers to conserve water and effectively penalizes customers who had no input or choice in the meter sizes that were placed by the builders in their tract homes.

Again, I would like to thank the Board of Directors for their time and consideration. I understand you perform a thankless and overlooked service, but I certainly appreciate all that you do for us and our community.

In Re: Proposed Rate Increases

I strongly oppose the proposed rate increases outlined in your recent letter.

For April 8, 2014, my water bill was \$36.03. The Low Volume Rate was .910 and the Conservation Base Rate was 1.27. The water service charge was \$9.85 and the Sewer Service Charge was \$16.55.

For April 30, 2015, the water bill was \$48.30, a 34% increase. The Low Volume Rate was .88 and the Conservation Base Rate was 1.34. The water service charge increased to \$11.55 and the Sewer Service Charge increased to 22.55.

The proposed increase in the Low Volume Rate is from .88 to \$1.11, an increase of 26%.

The proposed increase in the Conservation Base Rate is from 1.34 to 1.62, an increase of 21%.

The proposed sewer charge increase is 16%.

As a retiree, my annual increase was 2%. What profession increased their income to absorb increases of over 20%?

I make an effort to keep my water usage in the low volume, and I only move into the conservation rate in the periods of very hot weather. As a retiree, I have been very conscious of conserving water in order to keep my bill low. As rates have been increasing every year, it seems to be an effort in futility.

Again, I STRONGLY oppose these increases.

To: Invine Ranch Water District Board of Directors,

As a current customer of the IRWD I am in receipt of the Board of Director's proposed water and sewer rate changes for 2015-2016 in response to Governor Brown's 25% water reduction mandate. The board is proposing a tier rate structure. I am speculating this tier structure is designed to encourage water conservation by rewarding customers who reduce their water consumption and penalize those customers who exceed allocation levels. My concerns are that this plan when implemented will have the same flaws and lack of logic and common sense application as is evident in the current plan.

I have resided at 12 Evening Shadow, Irvine, CA 92603 for the last 13 months. During this time I have removed all of the soft landscape and replaced with hardscape with no water needed. I have low flow toilets in both bathrooms and completely eliminated the use of a kitchen dishwasher and do my laundry once a week with two full loads. I run my shower only to rinse off and do not allow faucets to run when brushing teeth or shaving. My water conserving activities have resulted in a significant reducing of water usage and well below my allocation levels as evident by my last 4 month of bills for 2015. The reduction was accomplished voluntarily on my part over the 13 months I have lived at 12 Evening Shadow and not due to any government mandate. Not only have my reduction efforts not been rewarded but the IRWD has penalized me by charging me fees higher than neighbors in my community who in some months have used 3 times more water than me and been charged less! Where is the logic and common sense in this situation?

I have included neighborhood bills for the last 4 months. This neighbor lives only 145 steps from my the same main water line, same sewage line and same floor plan. I have always home, shares believed performance recognized repeats itself. I ask myself why should I make the sacrifices I do and the IRWD doesn't recognize my efforts and charges me more for less.

## WORKSHOP

## FISCAL YEAR 2015-16 CAPITAL BUDGET

Using a PowerPoint presentation, Mr. Erik Akiyoshi said that in the current fiscal year, FY 2014-15, budgeted expenditures were originally estimated at \$153.7 million, however, actual expenditures are projected at approximately \$141.4 million (equating to 92% of projected expenditures) through the end of the current fiscal year.

Mr. Akiyoshi reviewed the top 10 budgeted versus projected expenditures including the following budgeted expenditures: Michelson Water Recycling Solids Handling (\$53.9 million [M]); Baker Water Treatment Plant (\$38.7M); Development – Planning Area 51 (Green Park Neighborhoods) (\$8.6M); Business Software (CC&B and Enterprise Asset Management( (\$7.4M); Development – Planning Area 1`8 (Hidden Canyon)(\$4.3M); Orange Park Acres Well (\$3.5M); Orange County

Sanitation District/Capital Outlay Revolving Fund and Equity Adjustment (\$2.7M); Peters Canyon Water Capture (\$2.6M); Water Banking (\$2.4M); and Santiago Canyon Domestic Water Improvements (\$2.1M).

Mr. Akiyoshi compared the FY 2014-15 development activity versus the projected FY 2015-16 development activity and said that the projected releases will be similar to FY 2014-15 with development continuing in Orchard Hills, Portola Springs, Stonegate, Cypress Village, Great Park Neighborhoods (District 1), Baker Ranch and Hidden Canyon.

Mr. Akiyoshi reviewed the three projects which were changed from the Engineering and Operations Committee on May 19, 2015; the FY 2015-16 projected expenditures; the top 10 project groups, the capital budget funding sources; the capital program summary, proposed increased to the Long-Term Capital Program, and flagged projects. Director Swan asked that an item be submitted to the Finance and Personnel Committee meeting relative to Long Term Capital Program. Additionally, he asked that all wells outside IRWD be included in the "flagged projects" list.

## COST OF SERVICE STUDY AND POLICY CONSIDERATIONS

General Manager Cook reported that the District's consultant, Carollo Engineering, Inc., in consultation with staff and legal counsel, has developed the Cost of Service Study. Mr. Cook said that Carollo presented a draft of the Study to the IRWD Board at its meeting on May 26, 2015 and the Boards' comments have been incorporated into this report.

Mr. Christopher Smithson reported that the purpose of the Cost of Service Study is to evaluate the District's rate-setting processes and consider rate structure design components. The objectives of the District's rate structure are to provide water, sewer, and recycled service at rates that are fair and equitable; charge rates that are consistent with industry accepted cost of service principles that satisfy future revenue requirements and that meet all state law requirements (including Proposition 218); and provide these services while fairly and equitably allocating costs appropriately to those customers benefitting from them.

Director Swan reported that this item was reviewed by the Finance and Personnel Committee on December 9, 2014; January 13, 2015; and February 21, 2015 and by the Board on May 26, 2015. President LaMar said that the report was excellent and complimented staff and the consultant on their efforts. On <u>MOTION</u> by Swan, seconded and carried (4-0) (Withers, Matheis, Swan, LaMar voting aye and Reinhart absent), THE BOARD ADOPTED THE FOLLOWING RESOLUTION BY TITLE SUBJECT TO NON-SUBSTANTIVE CHANGES ON THE COST OF SERVICE STUDY:

## WATERSMART SOFTWARE VARIANCE NO. 2

Ms. Amy McNulty reported that the District's WaterSmart Program, developed and administered by WaterSmart Software Inc., provides enhanced water use information to over-allocation residential and commercial, industrial, and institutional (CII) customers separately from their water bills. Ms. McNulty said that this program is an effective tool that promotes water use efficiency and provides rate support outreach to customers. Ms. McNulty said that of the District's total recipient list of over 14,481 over-allocation customers, 11,523 single-family homes receive monthly electronic reports and an additional 2,958 receive hard copy reports through direct mail. Customers who receive hard copy reports through direct mail are encouraged to sign up for the monthly electronic water reports as well as to schedule a home site survey with IRWD staff.

Ms. McNulty said that the existing agreement with WaterSmart Software expires on June 30, 2015 and that Variance No. 2 would continue and expand the program as part of the District's planned drought response plan to meet its 16 percent state-mandated potable use reduction target by February 2016. She said that the expanded program would provide funding for up to 22,000 over-allocation accounts to receive home water reports. An open enrollment feature will be added to allow single-family residence and condominium customers to opt in at any time. This will enable customers to sign up for the reports and for staff to enroll customers during home site surveys.

The proposed Variance No. 2 will also expand the program to include the development and implementation of custom water use portals for up to 6,000 commercial, industrial, and institutional (CII) customer accounts. This expansion will provide access to water usage data by CII building engineers, facility managers and sustainability managers who otherwise often experience a time delay waiting for the data from their accounts payable departments. The CII portal will provide a tool for this customer class to more closely monitor and manage water use at their facilities.

Director Matheis reported that this item was reviewed and approved by the Water Resources Policy and Communications Committee on June 4, 2015. Director Swan asked staff to look for alternatives next year for a more cost effective approach. Director Withers said he would abstain himself from voting on this item due to a potential conflict of interest with a client. Following discussion, on <u>MOTION</u> by Matheis, seconded and carried, (3-0-1) (Matheis, Swan, LaMar voting aye, Reinhart absent and Withers abstaining), THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE VARIANCE NO. 2 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN IRWD AND WATERSMART SOFTWARE INC. IN THE AMOUNT OF \$215,693.

## WATER CONSERVATION PARTICIPATION AGREEMENT

General Manager Cook reported that Tactical Incentives are one of the key elements of IRWD's Water Use Efficiency Program and are cost-effective financial incentives to supplement existing regional rebate programs administered by either Metropolitan Water District of Southern California and/or MWDOC. The incentives are based on IRWD's calculated avoided costs resulting from the installation of the various conservation devices. A new umbrella agreement with MWDOC has been prepared to provide incentives for specified devices and programs for FY 2015-16. Staff has reviewed the water savings and necessary funding levels for the various devices and is proposing a total of \$1,060,000 in total incentive funding of which \$610,000 would be allocated to residential programs and \$450,000 to commercial programs. Following discussion, on <u>MOTION</u> by Matheis, seconded and carried, (4-0) (Withers, Matheis, Swan, LaMar voting aye and Reinhart absent) THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE THE WATER CONSERVATION PARTICIPATION AGREEMENT BETWEEN THE MUNICIPAL WATER DISTRICT OF ORANGE COUNTY AND IRVINE RANCH WATER DISTRICT, SUBJECT TO NON-SUBSTANTIVE

Mr. Cook reported that last week, he, along with staff, met with OCSD staff relative to a number of outstanding issues including flows outside the Irvine Business Complex, permits, and a lease extension for biosolids.

Director Swan reported on his attendance at a Central and West Basin meeting, a Newport Chamber of Commerce meeting, a monthly WACO meeting, and a Southern California Dialogue meeting. He further commented on his attendance at a MWDOC's planning meeting where a discussion was held on MWD's incentives for rebates and noted he did not agree with its modifications relative to corporate accounts.

Director Matheis reported on her attendance at a South Orange County Watershed Executive Committee Meeting. She further reported on Senator Feinstein's newspaper article in the Los Angeles Times that reported the senator will be introducing another bill to provide more water to urban and rural areas which is affected by the drought. She further asked staff to keep abreast of the City of Lake Forest's request for recycled water for use at its lakes which General Manager Cook said is currently being discussed.

Director LaMar said he attended a COAST meeting at the Orange County Fire Department where camera installations in the Santiago Canyon areas for early fire detection was discussed. He further said he attended a monthly WACO meeting.

IRWD's consultant Mr. Bruce Newell and Mr. Jim reported reported on the meetings they attended on behalf of the District.

President LaMar recessed the Board meeting to hold the annual Corporation meetings. Following the Corporation meetings, he reconvened the Board meeting.

As of May 31, 2015, the book value of the investment portfolio was \$262,945,513, with a 0.54% rate of return and a market value of \$262,981,967. Based on the District's March 31, 2015 quarterly real estate investment rate of return of 13.20%, the District's weighted average return for the fixed income and real estate investments was 3.27%.

As of May 31, 2015, the total notional amount of the interest rate swap portfolio was \$130 million of fixed payer swaps. Cash accrual in May from all swaps was negative \$583,220.

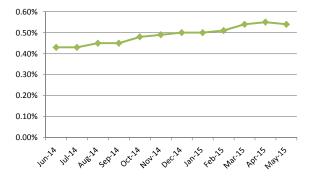

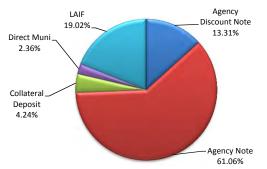

## **Portfolio Distribution**

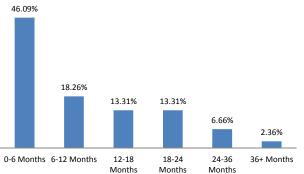

#### CONSENT CALENDAR

#### FY 2015-16 OPERATING BUDGET VENDOR EXPENDITURE COMMITMENTS GREATER THAN \$100,000

#### **SUMMARY:**

Each year, following Board approval of the District's operating budget, staff initiates or renews commitments with vendors for certain products and services included in the approved budget. Staff has provided a list of those vendors with expected commitments totaling \$100,000 or greater in fiscal year (FY) 2015-16 for the Committee's review. The list of vendor commitments excludes contracts/agreements which have been previously approved by separate Board action. Consistent with provisions included in the District's *Policy Regarding Authorization of Expenditures*, staff recommends that the Committee approve the list of vendor expenditure commitments greater than \$100,000 for FY 2015-16 and recommend Board approval of the same.

#### **BACKGROUND:**

On an annual basis, the Board approves the fiscal year operating budget for the District for the upcoming year. Included in the operating budget are expenditures for line items such as chemicals, fuel, hauling of biosolids and other products and services which result in commitments greater than \$100,000. These expenditures typically utilize cooperative agreements for best pricing when applicable, or have been previously competitively bid and in some cases are for products (e.g. certain chemicals) provided by a single supplier.

These commitments are structured as open purchase orders and typically consist of multiple individual transactions during the fiscal year with the cumulative total of the purchase order exceeding \$100,000. The approval structure allows staff to order goods and services on a regular and efficient basis during the fiscal year. These commitments are a "not to exceed" amount and can be cancelled at any time.

A list of the planned vendor commitments exceeding \$100,000 for FY 2015-16 is attached as Exhibit "A". The list includes vendor names, descriptions of the products or service being provided, the basis for pricing (e.g. cooperative agreement, single source, etc.) and estimated annual expense. Excluded from this list are contracts in excess of \$100,000 which have been previously approved by separate Board action and are within their approved contract period, as well as recurring utility bills.

The total planned expenditure amount for the listed vendors for FY 2015-16 is \$2,691,560, representing approximately 1.8% of total planned expenditures in the approved operating budget. Consistent with provisions included in the District's *Policy Regarding Authorization of Expenditures*, staff recommends that the Committee approve the list of vendor commitments greater than \$100,000 for FY 2015-16 and recommends Board approval of the same.

#### FISCAL IMPACTS:

#### METER READING SERVICES CONTRACT AWARD

#### SUMMARY:

The District's contract for meter reading services expires June 30, 2015. Staff issued a request for proposals (RFP) for meter reading services and received responses from four firms. Based on a thorough evaluation of the proposals, staff recommends that the Board authorize the General Manager to execute a five-year contract for meter reading services with Alexander's Contract Services (ACS) effective July 1, 2015 in the amount of \$1,306,800 per year for a total of approximately \$6,534,000 (based on the number of current meters) for the five years.

#### **BACKGROUND:**

The District's contract for meter reading service with ACS, originally awarded in March 2009, expires June 30, 2015. In March 2015, staff issued an RFP to four companies for meter reading services. Proposals were received from four companies, including ACS, Contract Callers, Inc. (CCI), Grid One Solutions, and MeterNet.

#### Selection Process:

Staff completed a thorough evaluation of the proposals using the following criteria and weight:

Proposed Cost	40%
Experience	24%
Qualifications	18%
Service Delivery Approach	18%

The proposal evaluation matrix is attached as "Exhibit A". The most qualified bidder using the above criteria is ACS. Key strengths of ACS are as follows:

- History of providing accurate meter reading services to the District since 2009;
- Fixed price per meter for the duration of the contract with no per meter price increase;
- Responsive to meeting the District's needs with existing resources, equipment, and technology;
- No costs required by the District to integrate meter reads with the existing utility billing system; and
- Provides web-based and mobile technology that allows District staff transparent access to meter read information.

During the evaluation, staff determined that while MeterNet had much lower pricing, they lacked experience with major utilities, only having provided meter reading services for home owners associations. Staff also determined that CCI, MeterNet, and GridOne do not currently have staff

resources available and would be required to hire new resources to provide the service. All three companies would have a long lead time setting up integration of meter reads to the District's billing system and hiring the required meter reading resources to provide effective service.

#### **Optional Field Activity Services:**

Staff asked each proposer to provide pricing for optional field activity services for the following activities 1) Activation/Deactivation of accounts; 2) Shutoff of water account for non-payment, and 3) Restoration of account after shutoff for non-payment. Based on a cost analysis to provide these optional services, staff that determined that the cost does not justify outsourcing the services at this time to a third party provider. The costs for these services are provided in Exhibit "A" for informational purposes only.

#### **Optional Smart Meter Option:**

In addition to traditional meter reading services, ACS also provided an option to provide Smart Meter service to the District's customers. The service would allow customers to manage their daily water consumption by use of an internet based web portal that utilizes the Smart Meter integration Management (SWiM) network. Through use of the web portal, customers can display water usage by day and hour and set up alerts for usage that is above their allocation.

The SWiM network utilizes Smart Meters that are installed at the customer's premise and uses the cellular network to transmit data to the SWiM network data center. The meter data necessary for billing customers is forwarded from the SWiM network to the ACS meter reading service, then to the District's billing system through a current interface. No additional programming is required to implement this service. For every customer who has a Smart Meter placed in service, ACS will provide the District with four free meter reads for existing customer meters.

Several costing options are available for implementing Smart Meters utilizing the SWiM network:

- District Customers agree to opt-in for the SWiM service for an added monthly fee;
- The District supplements the cost of the SWiM service for a reduced monthly fee; and
- The District pays the entire cost of the SWiM service.

Staff is considering a pilot program in the coming months incorporating a limited number of customers for each of the options listed. The cost of the pilot program was included in the FY 2015-16 operating budget.

Staff recommends the award of a five year contract to ACS to perform contract meter reading services. The total amount for the five year contract is approximately \$6,534,000.

Funds for contract meter reading services for FY 2015-16 are included in the approved FY 2015-16 operating budget.

#### MICHELSON WATER RECYCLING PLANT BIOSOLIDS AND ENERGY RECOVERY FACILITIES <u>CONTRACT CHANGE ORDER</u>

#### SUMMARY:

Filanc/Balfour-Beatty (FBB) is constructing the Michelson Water Recycling Plant (MWRP) Biosolids and Energy Recovery Facilities (Biosolids Project). Contract Change Order (CCO) No. 29 will provide foul air pipe supports and a secondary circuit breaker for the switchgear handling the seven centrifuges located at the Solids Handling Building and two motor control centers. Staff recommends that the Board approve CCO No. 29 in the amount of \$225,971.77 with FBB for the Biosolids Project.

#### **BACKGROUND:**

Construction of the Biosolids Project was awarded to FBB in March 2013 in the amount of \$163,513,307. The Biosolids Project will provide biosolids digestion, dewatering, energy production, and on-site sludge drying. The project includes excavation for subsurface structures; installation of 3,009 foundation piles; three egg-shaped digesters; a state-of-the-art odor control system; a biogas conditioning system and power generation using micro-turbines; a fats, oil and grease receiving station; and new utility services. These facilities are being constructed on the land north of IRWD's existing Operations Center, maintenance shops, water quality laboratory, and warehouse.

#### CCO No. 29:

Staff negotiated with FBB to resolve two items contained in CCO No. 29. The two items are as follows:

*Foul Air Pipe Supports in the Solids Handling Building Basement:* During submittal review, it was discovered that the large foul air piping in the basement of the Solids Handling Building required 24 additional pipe supports which were not indicated in the Contract Documents. The supports will hold foul air pipes in various sizes from 16 to 60 inches. This item is for the labor and materials to install the foul air pipe supports and is in the amount of \$119,937.87.

Secondary Circuit Breaker for Transformer T-14: The Contract Documents require that FBB complete an arc flash hazard calculation based on all of the final electrical equipment provided during construction. The arc flash hazard calculation provided by FBB indicates a dangerous level of electrical energy can be released during a faulted condition when the Switchgear-14 main breaker doors are open. The switchgear is for the electrical loads located in the Solids Handling Building. The electrical loads are from the seven centrifuges located in the Solids Handling

Building and two motor control centers. Based on the arc flash calculation, a secondary circuit breaker was recommended. Staff determined that the addition of a 480-volt secondary circuit breaker at Transformer T-14 would enhance safety for staff when accessing the downstream 480-volt switchgear while it is energized.

CCO No. 29 includes the installation of a new 480-volt, 4,000-amp circuit breaker in an outdoor, weatherproof enclosure, a 4,000-amp bus duct between Transformer T-14 and the T-14 secondary breaker, and extension of the T-14 transformer concrete housekeeping pad to support the addition of the T-14 secondary breaker. The cost for this item is in the amount of \$106,033.90.

Staff is reviewing the arc flash study for the remaining portions of the Biosolids Project and anticipates that additional breakers will be required. Once the number, size, and cost of these circuit breakers are finalized, a subsequent change order will be submitted to the Board for approval.

Staff recommends that the Board approve CCO No. 29 in the amount of \$224,971.77, which is attached as Exhibit "A". The Construction Change Order Summary is attached as Exhibit "B". CCO No. 29 does not extend any of the milestone completion dates.

#### FISCAL IMPACTS:

The MWRP Biosolids and Energy Recovery Facilities Project 21146 (4286) is included in the FY 2015-16 Capital Budget. The existing budget is sufficient to fund CCO No. 29.

#### ENVIRONMENTAL COMPLIANCE:

The MWRP Biosolids and Energy Recovery Facilities is subject to the California Environmental Quality Act (CEQA) and in conformance with the California Code of Regulations Title 14, Chapter 3, Article 7, a Supplemental Environmental Impact Report (SEIR), SCH # 2011031091, was certified by IRWD at its October 22, 2012 meeting. The City of Irvine Planning Commission approved a conditional use permit for the IRWD Biosolids Project at its December 6, 2012 meeting.
