# LAKE FOREST RECYCLED WATER SERVICES ON BAKE PARKWAY AND TOLEDO WAY FINAL ACCEPTANCE

# **SUMMARY:**

The Lake Forest Recycled Water Services on Bake Parkway and Toledo Way is complete. The District's contractor, T.E. Roberts, Inc., has completed the required work and all punch list items. The project has received final inspection and acceptance of construction is recommended.

# **BACKGROUND:**

The City of Lake Forest's irrigation system for the center median and parkways on portions of Bake Parkway, Toledo Way, and Jeronimo Road consists of five two-inch domestic water services. This project converted the existing irrigation system to recycled water, saving approximately 12 acre-feet per year of potable water; the project constructed three new recycled water services and combined two irrigation areas resulting in fewer meter charges. The City of Lake Forest completed plumbing modifications downstream of the new meters and will install beautification improvements to the area in a collaborative effort on this high-profile project.

Staff completed the design in May 2018. T.E. Roberts, Inc. was awarded the construction contract on July 24, 2018 and completed construction of the pipeline on November 8, 2018.

# CULVER DRIVE RECYCLED WATER PIPELINE REPLACEMENT BUDGET INCREASE, CONTRACT CHANGE ORDER, AND FINAL ACCEPTANCE

# SUMMARY:

The Culver Drive Recycled Water Pipeline Replacement constructed a 12-inch recycled water pipeline to replace an eight-inch pipeline in Culver Drive between University Drive and Ethel Coplen Way in Irvine. Construction is complete and the contractor, E. J. Meyer, has completed all punch list items. The project has received final inspection and acceptance of construction is recommended. Staff recommends that the Board:

- Authorize a budget increase in the amount of \$275,000, from \$717,000 to \$992,000;
- Authorize the General Manager to execute Contract Change Order No. 1 with E.J. Meyer Company in the amount of \$178,690.17;
- Authorize the General Manager to file a Notice of Completion; and
- Authorize the payment of the retention 35 days after the date of recording the Notice of Completion for the Culver Drive Recycled Water Pipeline Replacement project.

# BACKGROUND:

The Zone A recycled water system in Culver Drive, between University Drive to the south and Ethel Coplen Way to the north, supplies recycled water to the Rancho San Joaquin Golf Course and the City of Irvine's landscaped parkway along southbound Culver Drive. This pipeline segment is composed of eight-inch asbestos cement pipe (ACP) and is approximately 1,200 feet long; it was originally installed in 1976 and has had several repairs in recent years. A forensic analysis on a sample section concluded that the pipe exhibited corrosion of the interior or leaching of the lime component of the ACP, likely caused by high pH levels in recycled water. Hydraulic modeling of the Zone A recycled water system also determined a need to increase the segment's pipe diameter from eight inches to 12 inches to meet maximum velocity criteria.

The design of the 12-inch replacement polyvinyl chloride (PVC) pipeline was completed in June 2018 and a construction contract was awarded to E.J. Meyer Company on July 24, 2018. At this time, all work has been completed and the pipeline is now in service. The location of the replacement pipeline is shown in Exhibit "A".

# Contract Change Order No. 1:

E.J. Meyer submitted a change order for additional work and costs due the following:

• Lost pipe installation production was caused by the City of Irvine's shortening of work hours. The City of Irvine changed the start time of the work from 7:00 a.m. to 9:00 a.m. Consent Calendar: Culver Drive Recycled Water Pipeline Replacement Budget Increase,

to mitigate traffic delays of up to 45 minutes on southbound Culver Drive between Michelson Drive and University Drive due to school traffic (UC Irvine and University High School). The amount of this portion of the change order was \$136,251.25.

- Unknown and differing site conditions, including additional work required to connect an unknown lateral at the golf course meter vault, and the contractor encountering two-sack slurry fill within the pipe alignment during pipeline installation. The amount of this portion of the change order was \$36,399.12.
- Final quantity adjustment for paying in the amount of \$6,039.80.

Staff recommends the Board authorize the General Manager to execute Contract Change Order No. 1 with E.J. Meyer Company in the amount of \$178,690.17 for the Culver Drive Recycled Water Pipeline Replacement. Contract Change Order No. 1 is attached as Exhibit "B".



# SEAWATCH RECYCLED WATER MAIN REHABILITATION - FINAL ACCEPTANCE

# **SUMMARY:**

The Seawatch Recycled Water Main Rehabilitation is complete. The District's contractor, T.E. Roberts, Inc., has completed the required work and all punch list items. The project has received final inspection and acceptance of construction is recommended.

# **BACKGROUND:**

A ten-inch polyvinyl chloride and ductile iron pipeline supplies recycled water to the Crystal Cove development in Newport Beach; it is the sole supply for Zones E through G in the community. Staff completed a total of 17 repairs on the pipeline since its installation in 2003; the failures have commonly occurred at the pipe bells of polyvinyl chloride pipe. This project rehabilitated 3,900 feet of the pipeline with cured-in-place-pipe and replaced 740 feet of the pipeline with new polyvinyl chloride pipe.

Staff completed the design in January 2018. T.E. Roberts, Inc. was awarded the construction contract on March 13, 2018 and completed construction of the pipeline on December 3, 2018. The delay in completing the work within the original contract time can be attributed to a late start due to numerous submittal corrections on the liner material, repairs to pipe segments lined with completed cured-in-place pipe lining as post-lining video inspection revealed seven locations with liner installation issues such as folds in the liner and air pockets behind the liner and host pipe, and installation of a 600-foot segment of polyvinyl chloride pipeline via trench excavation method within Seawatch due to a failure of the liner during hydrostatic pressure testing.

# 2019-2020 STATE REGULATORY ADVOCACY AND CONSUTLING SERVICES

# SUMMARY:

In June 2018, the District contracted with Cliff Moriyama Consulting for State regulatory advocacy and consulting services. IRWD's current contract with Cliff Moriyama Consulting expires on December 31, 2018. Staff recommends the Board approve a sole-source Professional Services Agreement with Cliff Moriyama Consulting for State regulatory advocacy and consulting services for the 2019-2020 legislative session. The new contract would be in effect from January 1, 2019, to December 31, 2020, and would have a not-to-exceed value of \$100,000, covering a \$4,000 monthly retainer plus reimbursement of direct expenses. The proposed new agreement reflects no increase in the amount of the monthly retainer from the current agreement.

# **BACKGROUND:**

IRWD continues to be a leader in water resources policy and governance. During the 2017-2018 legislative session, the District engaged in a number of State policy discussions regarding water infrastructure, water recycling policy, direct potable reuse regulations, supply reliability and governance. Many of these discussions took place in the regulatory arena, and are expected to carry over into 2019 and 2020.

Some of the regulatory policy areas expected to be of priority for IRWD over the 2019-2020 legislative session are summarized as follows:

- Department of Water Resources' (DWR) and the State Board's implementation of the "Making Water Conservation a California Way of Life" legislation;
- DWR's "The Open and Transparent Water Data Act (AB 1755, Dodd) Implementation Plan;"
- DWR's "California Water Plan: Update 2018;"
- DWR's "Public Draft of Stormwater Targets for Groundwater Recharge and Direct Use in Urban California;"
- State Board's development of a "Cross Connection Policy Handbook;"
- State Board's proposed "Environmental Laboratory Accreditation Program Regulations:"
- State Board's proposed "Mercury TMDL and Statewide Mercury Control Program for Reservoirs" regulations;
- State Board's proposed regulations on "Prohibiting Wasteful Water Use Practices;" and
- State Board's "State Wetland Definition and Procedures for Discharges of Dredged or Fill Material to Waters of the State" regulations.

Cliff Moriyama Consulting has been and is proposed to continue assisting the District in advocating on these regulations and other matters on behalf of the District before State agencies. Cliff Moriyama has provided the District with a high level of service, knowledge, credibility and access in Sacramento. Additionally, Cliff Moriyama has assisted the District in its ongoing efforts to build and maintain relationships with key policy makers and regulators within State agencies.

To aid IRWD in its state regulatory advocacy efforts, staff recommends that the Board authorize the General Manager to execute a Professional Services Agreement with Cliff Moriyama Consulting for a 24-month period, beginning January 1, 2019, through December 31, 2020. Entering into a 24-month contract with Cliff Moriyama Consulting would allow the District to maintain continuity in its current Sacramento representation before State agencies throughout the entire 2019-2020 legislative session.

Attached as Exhibit "A" is the scope of work proposed by Cliff Moriyama Consulting for the 2019-2020 legislative session.

# FISCAL IMPACTS:

The current contract with Cliff Moriyama Consulting, which will expire on December 31, 2018, included a \$4,000 monthly retainer plus reimbursement of direct expenses. The proposed contract would run from January 1, 2019, through December 31, 2020, and is proposed at \$4,000 per month plus reimbursable direct expenses. If approved by the Board, the new contract will be charged against the FY 2018-2019, FY 2019-2020 and FY 2020-2021 Operating Budgets. The total requested contract authorization is for \$100,000.

Dear Ms. Compton:

It has been a pleasure working for the Irvine Ranch Water District in 2018. I also appreciate the opportunity to submit a proposal for consideration by the District to continue my regulatory advocacy work in 2019. As we discussed and witnessed in 2018, the regulatory landscape in California can be extremely challenging for a water district. I believe Cliff Moriyama Consulting can continue to build a strong regulatory advocacy foundation to help the District meet those challenges head-on.

Cliff Moriyama Consulting (CMC) is a full service legislative and regulatory advocacy and strategic planning firm. As the owner of the firm, I have more than 25 years of experience working with the California Legislature and a wide array of California natural resources and environmental regulatory agencies including the State Water Resources Control Board, California Department of Fish and Wildlife, Department of Water Resources, Natural Resources Agency, and the California Environmental Protection Agency. Attached is a brief biography.

CMC will continue to use its resources and expertise to advocate on your behalf on the numerous regulatory issues identified in 2018 and anticipated in 2019. At a minimum, CMC will do the following:

- Identify and prioritize regulatory agencies of interest. An initial list of agencies include the State Water Resources Control Board, Department of Water Resources, and the California Water Commission. Additional agencies could include the Department of Fish and Wildlife, California Natural Resources Agency, and the California Environmental Protection Agency.
- Inform key personnel in the various agencies of CMC's role in representing the District. Such action could include introductory meetings with District and agency personnel.

- Identify and prioritize specific regulatory issues within each agency of interest.
- Develop and implement action plans to deal with high priority regulatory issues. Action plans will include metrics in order to gauge progress and meet deadlines.
- Develop and implement action plans to deal with other identified regulatory issues.

In order to provide these services, CMC proposes a general retainer of \$4,000 a month, plus expenses (e.g. pre-approved travel, postage, etc.).

CMC anticipates having three lobbying clients as we enter the 2019-2020 Legislative Session – California Building Industry Association (CBIA), Dart Container Corporation (Dart), and The Gualco Group, Inc. (TGG). As it relates to potential conflicts of interest between CMC's anticipated clients and the District, I believe there are none based on the scope of work and the issues we are working on for CBIA and Dart. As for TGG, I also believe no conflict of interest exists because the work we will be doing for the TGG clients will focus on the Legislature and legislation.

However, if CMC is asked by TGG to work on a regulatory matter for one of the subcontracted clients, I will commit to the District that we will review the situation together and determine if a potential conflict exists. If that is the case, CMC will decline to work on that issue in an advocacy role. Our goal is to provide the best possible professional regulatory advocacy program for the District and make sure that a potential conflict of interest does not stop us from reaching that goal.

Thanks again for your interest in Cliff Moriyama Consulting. I look forward to the opportunity to continue to work with you and the Irvine Ranch Water District. Please contact me if you have any questions.

# 2019 – 2020 STATE LEGISLATIVE ADVOCACY SERVICES

# SUMMARY:

On October 8, 2018, IRWD issued a Request for Qualifications (RFQ) for state legislative advocacy services. The District received six responses to the RFQ; staff and the Water Resources Policy and Communications Committee interviewed the top three qualified firms/teams. Based on the analysis of the proposals and the interviews, the highest ranked team was The Oñate Group/Quintana, Watts & Hartmann team, and staff recommends that the Board authorize the General Manager to:

- Execute a Professional Services Agreement with The Oñate Group for state legislative advocacy services. The contract term would be January 1, 2019, through December 31, 2020 covering the 2019-2020 legislative session and would include a \$5,000 monthly retainer plus reimbursement of reasonable direct expenses. The not-to-exceed amount of the contract would be \$125,000; and
- Execute a Professional Services Agreement with Quintana, Watts & Hartmann for state legislative advocacy services. The contract term would be January 1, 2019, through December 31, 2020 covering the 2019-2020 legislative session— and would include a \$5,000 monthly retainer plus reimbursement of reasonable direct expenses. The not-to-exceed amount of the contract would be \$125,000.

# BACKGROUND:

IRWD issued an RFQ for state advocacy services on October 8, 2018, with Statements of Qualifications (SOQs) due on November 2. The District received six responses, from which the top three firms/teams were selected for interviews. The list of the firms invited to respond to the RFQ and the list of firms that submitted SOQs is attached as Exhibit "A".

On November 13 and 19, staff and the Water Resources Policy and Communications Committee, interviewed The Gualco Group, Public Policy Advocates/London & Gonzalez Advocacy and The Oñate Group/Quintana, Watts & Hartmann teams for the provision of state legislative advocacy service to the District. While all three firms/teams are well-qualified, The Oñate Group/Quintana, Watts & Hartman team demonstrated the most comprehensive strategy for accomplishing IRWD's state policy objectives, and presented the strongest qualifications related to state advocacy on California water policy and on behalf of public agencies.

# Qualifications of The Oñate Group/Quintana, Watts & Hartman Team:

The Oñate Group/Quintana, Watts & Hartman team is an advocacy team comprised of two Sacramento lobbying firms: The Oñate Group and Quintana, Watts & Hartmann. The two firms combined have nearly 40 years of experience in legislative affairs.

The contract term would be January 1, 2019, through December 31, 2020—covering the 2019-2020 legislative session—and would include a \$5,000 monthly retainer plus reimbursement of reasonable direct expenses.

# FISCAL IMPACTS:

The current contract with O'Haren Governmental Affairs, the District's current state legislative advocate, will expire on December 31, 2018. The current contract included a \$6,500 monthly retainer plus reimbursement of direct expenses.

The proposed contracts with The Oñate Group and Quintana, Watts & Hartman would cover the period of January 1, 2019, through December 31, 2020, at a total of \$10,000 per month plus reasonable reimbursable direct expenses. If approved by the Board, the new contracts would have a not-to-exceed amounts of \$125,000 each and will be charged against the FY 2018-2019, FY 2019-2020 and FY 2020-2021 Operating Budgets.

Coalition to Abolish Slavery & Trafficking \$10M Budget Requests – David Quintana and his team have represented this group in the legislative and budget arenas for four years. After several years of success in the budgetary realm, the team overcame substantial hurdles when \$10 million was not included in the 2018 budget. After the exclusion of the funding, the team activated grassroots support and stakeholders - and worked with various key legislators to speak to this issue in budget floor speeches and to have legislation introduced to call attention to the matter (both Democratic and Republican bills were introduced). Ultimately, the money was included in the supplemental budget bill passed at the end of session.

<u>Description of the work plan and approach, including strategy, tools and techniques, proposed for meeting IRWD's</u> legislative and regulatory advocacy needs:

Overall, we would expect significant refinement of the general work plan as included below, based on discussion with IRWD leadership and staff, but we believe that the following will serve as a good basis for such discussions.

## Daily:

- Keep abreast of newly introduced or amended legislation as well as Capitol and key organizations'/associations' dynamics - in order to anticipate and engage in legislative and/or Administration issues of interest or concern to IRWD.
- Convey key or urgent information to IRWD staff as necessary and respond to IRWD inquiries/direction as necessary.

# Weekly/Bi-Weekly:

- Attend the majority of weekly ACWA Monday morning lobby group meetings and report information of significance to IRWD.
- During legislative session monitor issues that come before the relevant legislative committees (water, local government, etc.) and attend and represent IRWD's positions when necessary and appropriate.
- As desired, set weekly or bi-weekly focused update calls with appropriate IRWD staff. Regular topics to be addressed in these meetings would likely include review of status of bills of interest, discussion of Administration activities of interest and status of funding opportunities.
- Provide updated bill tracking list, reflecting district positions, etc.

#### Monthly:

- If desired, would provide verbal (phone) and/or written updates or reports to appropriate IRWD legislative or external affairs board committees.
- Review ACWA legislative committee materials, coordinate with IRWD as necessary prior to

- meetings in light of committee materials, attend ACWA legislative committee meetings to the maximum extent possible (understanding these are roughly every three weeks).
- Potentially participate in other organizations' meetings Including Water Reuse and CMUA to the greatest extent possible as necessary to advance IRWD's interests.

## Annually/Semi-Annually:

- Engage in strategic planning with District leadership and staff as desired and appropriate including discussion of Sacramento priorities.
- Provide an in-person update to the board or appropriate committee, as requested.
- Work with IRWD to schedule board member visits with area legislators in the Capitol as desired/appropriate.

# Other/Ongoing as Necessary and Appropriate:

- Regularly update IRWD's legislative delegation on significant district updates, issues, concerns and positions with respect to Sacramento issues and/or issues about which they may receive questions from their constituents at the local level.
- Provide ongoing implementation of other tasks as directed by IRWD including drafting correspondence, coordinating meetings, special project facilitation, etc.

#### Client list and a discussion of potential conflicts, etc.

Attached, please find the current client list for each firm.

Overall, we do not anticipate substantial conflicts with existing clients. However, with respect to potential conflicts, should they arise, IRWD could be assured that:

- We will proactively alert you to any significant conflicts that may arise and seek to determine a resolution of the situation that is satisfactory to all involved parties.
- In a case where either QW&H or The Oñate Group have a conflict, but the other does not, we would anticipate having the firm without a conflict represent IRWD on the issue of concern.
- Should a conflict arise that affects both firms, we would work with IRWD to develop a solution to the issue, even if that involves a temporary outsourcing of that issue to another firm.

# Key legislative, regulatory and administration contacts:

The firms can confidently note experience with the key legislative committee staff members with the Senate Natural Resources and Water Committee and the Assembly Water, Parks and Wildlife Committees. Additionally, we have worked with the environmental water quality committees in each house.

We also have experience with other key committee staff related to water policy, including the Appropriations Committees. Moreover, we are familiar with leadership staffers Kip Lipper and Alf Brandt.

With respect to the Administration, we note the transitional nature of the Governor's office at this time, but do

have a positive relationship with DWR's Kasey Schimke, who has remained in the legislative role for some time,

We can also speak to significant familiarity with key IRWD area legislators, including Assemblymember Daly and Senators Moorlach, so we would have a running start with respect to relationship-building on that front.

With respect to the regulatory aspect, we do acknowledge Cliff Moriyama's lead role in that realm – and also note some past positive experience with Mr. Moriyama.
