## **BOARD WORKSHOP**

## PROPOSED DIRECTOR DIVISION BOUNDARIES CRITERIA

## **SUMMARY:**

The purpose of this Board Workshop is to discuss the criteria to be used by IRWD when drawing proposed director division boundaries. The discussion will also cover procedures through which the public can submit conceptual maps and additional comments on the proposed districting process.

## **BACKGROUND:**

Pursuant to Water Code section 35180, IRWD uses an at-large method to elect the members of its Board of Directors. The at-large method allows for voters from the entire service area to elect each of the five members of the Board of Directors. The California Voting Rights Act favors a by-division method of election instead of an at-large method of election for electing members of local government governing bodies. A by-division method divides a service area into separate divisions and allows the voters from each division, as opposed to voters from the entire service area, to elect a member of the board of directors. In a by-division method of election, the elected individual serves as the division's representative on the board and must reside in that division.

Since 2017, Elections Code section 10650 has authorized special districts such as IRWD to move from an at-large method of election to a by-division method of election in furtherance of the purposes of the California Voting Rights Act. Elections Code section 10010 governs the process for evaluating and transitioning to a by-division method of election. The first step in initiating the process is the adoption of a resolution of "Intent to Initiate the Process of Establishing Divisions and Elections by Divisions." The IRWD Board of Directors adopted a resolution of "Intent to Initiate the Process of Establishing Divisions and Elections by Divisions" on April 2, 2018.

Pursuant to Elections Code section 10010, the IRWD Board of Directors held two public hearings held on June 4, 2018, and June 18, 2018, to invite and solicit public comment on the proposed move to by-division elections, the composition of divisions and the sequence of elections before the drawing of a draft map or maps of proposed director division boundaries. At the June 18 hearing, the Board authorized a board workshop on August 13, 2018 to discuss criteria to be used by the District when drawing proposed director division boundaries.

## Criteria for Division Boundaries:

While a number of federal and state laws govern the drawing of director division boundaries, the Unites States Constitution establishes the fundamental principle which governs the drawing of director division boundaries. Above all else, the Constitution requires that divisions be equal, or nearly equal, in total population. Federal courts have ruled that this means that the population difference between the most and least populous divisions may not exceed ten percent. California

Elections Code section 22000 further suggests that divisions should be drawn to be, "as far as practicable, equal in population" using the population numbers from the last federal decennial census.

Provided that the approximate equality in population (based on the last decennial census) requirement is met, the Elections Code also allows for consideration of: 1) topography, 2) geography, 3) cohesiveness, contiguity, integrity, and compactness of territory, and 4) communities of interests of the division" when determining where director division boundaries are placed.

Staff will present proposed for the Board's consideration criteria for use by the District when drawing proposed director division boundaries. Additionally, staff will present information on how the public can submit additional comments on the composition of possible divisions and submit conceptual maps for consideration as the potential division area maps are drawn. The draft PowerPoint presentation slides are attached as Exhibit "A".

## FISCAL IMPACTS:

Due to the adoption of a resolution of "Intent to Initiate the Process of Establishing Divisions and Elections by Divisions" and by undertaking the Elections Code section 10010 process to evaluate by-divisions elections, the District is incurring costs of a demographer and special legal counsel in addition to potentially other costs.







# Required and Permissible Redistricting Criteria

- Must meet the Federal Voting Rights Act.

  - Cohesiveness, contiguity, integrity, and compactness of territory
  - Communities of interest





## Proposed Criteria for Drawing Division Boundaries

- 1) Each director division shall contain a nearly equal number of inhabitants as reflected in the most recent decennial census.
- 2) Divisions shall be drawn in a manner that complies with the Federal Voting Rights Act,
- 3) Divisions shall consist of contiguous territory,
- 4) Divisions will be in as compact a form as possible given the other criteria set forth.
- 5) Division boundaries will respect communities of interest as much as possible.
- 6) Division boundaries will consider jurisdictional boundaries as much as possible.
- Division boundaries will observe topography and geography such as man-made and natural geographic features insofar as practicable.
- 8) Division boundaries will attempt to allow the voters to retain current Directors if they choose by avoiding placing Directors in the same division insofar as this does not conflict with federal or state law requirements.
- 9) To the extent proposed divisions do not contain equal population as reflected in the most recent decennial census, population growth since the last decennial census and anticipated population growth before the next decennial census may be considered so long as population deviation remains within the parameters allowed by law.

The regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 5:00 p.m. by President Reinhart on July 23, 2018 in the District office, 15600 Sand Canyon Avenue, Irvine, California.

## PUBLIC HEARING

## SEWER TAXES IN THE NEWPORT NORTH SERVICE AREA

General Manager Cook reported that on June 18, 2018, the Board adopted Rates and Charges for Fiscal Year 2018-19, which included monthly sewer charges of \$25.75 for a residential single family home and \$19.30 per unit for multiple family dwelling units. The Newport North customers will have the same rate, but the method of collection differs in that they pay their sewer fees on an annual basis by means of the County tax rolls. The Orange County Special Assessment Report provides a listing of the parcels and the tax revenue generated. That resolution directs the filing of a report containing a description of such parcels and the corresponding charges for each fiscal year.

President Reinhart said this was the time and place for a hearing on the sewer taxes in the Newport North area, and declared the hearing open. He asked the Secretary how the hearing was noticed. Secretary Bonkowski reported that the report was filed with her on July 5, 2018, and the notice of the filing of the report and the time and place of this hearing was published in the Newport Beach-Costa

## PUBLIC HEARING (Continued)

Mesa Daily Pilot on July 8, 2018 and July 15, 2018. She said that a notice was also posted in the District office on July 5, 2018.

On <u>MOTION</u> by Swan, seconded by Matheis and unanimously carried, THE AFFIDAVIT OF POSTING AND THE PROOF OF PUBLICATION PRESENTED BY THE SECRETARY WAS RECEIVED AND FILED.

President Reinhart requested Legal Counsel Collins to describe the nature of the proceedings.

Legal Counsel Collins said that pursuant to the requirements of the Health and Safety Code of the State of California, a public hearing on the report is required.

President Reinhart asked Secretary Bonkowski whether she had received any written communications concerning this matter, and she stated that she had not. President Reinhart asked if there was anyone present who wished to address the Board concerning the report and the proposed collection of sewer charges on the tax roll. There was no one present who wished to be heard. President Reinhart further inquired if there were any comments or questions from members of the Board of Directors. Director Swan provided a brief overview of the process noting that the Newport North customers will have the same rate, but the method of collection differs in that they pay their sewer fees on an annual basis by means of the County tax rolls. # SEWAGE TREATMENT MASTER PLAN BUDGET INCREASE AND CONSULTANT SELECTION

Executive Director of Engineering and Water Quality Burton reported that the District's service area and water recycling plants have experienced a number of changes since completion of the master plan in 2003 which is prompting staff to prepare a new master plan that will evaluate the sewer system through buildout. Mr. Burton said that the new Sewage Treatment Master Plan (STMP) will: 1) characterize sewage for such constituents as organic content and nutrients; 2) evaluate and account for impacts associated with increased loadings as a result of conservation; 3) determine future sewage conveyance requirements to MWRP and LAWRP; 4) identify future treatment processes and their associated capacities at MWRP and LAWRP; 5) identify beneficial uses of sewage; 6) evaluate alternatives for minimizing sewage diversion to Orange County Sanitation District; and 7) identify ways of managing the sewage collection and treatment systems in the most cost effective manner.

Mr. Burton said that staff received proposals for the STMP from AECOM, Black & Veatch, HDR, and Jacobs (formerly CH2M). He said that the HDR proposal far exceeded the other proposals in all aspects including project team, project understanding, and project approach which provided a clear, concise methodology for completing the work and included a comprehensive and fully detailed scope of work that defined its approach to performing each step of the project. He said that after reviewing the proposals, staff met with HDR to discuss and negotiate the final scope, schedule, fee, and hourly billing rates. HDR's fee is in the range of the other three proposals received, which ranged from \$836,735 to \$1,089,530. HDR has extensive experience providing engineering services for the District including the 2003 Wastewater Treatment Master Plan, LAWRP 2005 Upgrades, Recycled Water Salt Management Plan, and several other studies and evaluations.

Director Withers reported that this item was reviewed by the Engineering and Operations Committee on July 17, 2018. On <u>MOTION</u> by Withers, seconded and unanimously carried, THE BOARD APPROVED A BUDGET INCREASE IN THE AMOUNT OF \$209,000, FROM \$921,300 TO \$1,130,300, FOR PROJECT 05427 AND IN THE AMOUNT OF \$104,500, FROM \$454,300 TO \$558,800, FOR PROJECT 07141; AND AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH HDR IN THE AMOUNT OF \$1,070,600 FOR ENGINEERING SERVICES FOR THE SEWAGE TREATMENT MASTER PLAN, PROJECTS 05427 AND 07141.

## CULVER DRIVE RECYCLED WATER PIPELINE REPLACEMENT CONSTRUCTION AWARD

Executive Director of Engineering and Water Quality Burton reported that this project will construct a 12-inch recycled water pipeline to replace the existing eight-inch asbestos cement pipeline in Culver Drive between University Drive and Ethel Coplen Way in Irvine. Mr. Burton said that the asbestos cement pipe (ACP) is approximately 1,250 feet and has had several repairs. He said that during a previous repair, a sample portion of the ACP was removed and staff retained HDR to perform a forensic analysis on the pipe sample. HDR's analysis concluded that the pipe exhibited corrosion of the interior or leaching of the lime component of ACP, which is likely caused by high pH levels in recycled water from MWRP, and recommended replacing the pipeline. He said that hydraulic modeling of the Zone A recycled water system reflected a need to increase the segment's pipe diameter from eight inches to 12 inches to meet maximum velocity criteria. This project will abandon the existing eight inch ACP and install a replacement

12-inch PVC pipeline in the roadway, where it will be offset approximately six feet from the west curbface. In addition, three replacement services will be constructed and connected to the existing onsite private plumbing just downstream of the existing meters. Construction will start within the street intersection of Culver and University Drives, to precede the City of Irvine's upcoming street improvement project for this intersection, and progress northerly. Mr. Burton said that five contractors attended the pre-bid meeting and five contractors submitted bids on July 28, 2018. E.J. Meyer Company is the apparent low bidder with a bid amount of \$707,777; the engineer's estimate was \$779,610. On <u>MOTION</u> by LaMar, seconded by Matheis, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH E.J. MEYER COMPANY IN THE AMOUNT OF \$707,777 FOR THE CULVER DRIVE RECYCLED WATER PIPELINE REPLACEMENT, PROJECT 10588.

## GENERAL MANAGER'S REPORT

General Manager Cook reported that the District received a final ruling on the OCWD v. IRWD lawsuit and will be discussed at the upcoming Strategic Planning Workshop in Closed Session.

Mr. Cook reported on his attendance at the Southern California Water Coalition quarterly luncheon in Cabazon that he attended with Directors Withers and LaMar. He said following the luncheon he met with Palo Verde Irrigation District staff in Blythe.

Mr. Cook announced that he and staff had a lunch meeting with Ms. Wendy Chambers, the District's new Executive Director of Operations, who will start work in mid-August.

## DIRECTORS' COMMENTS

Director Withers said that he will be attending an OCSD Board meeting this Wednesday.

Director Matheis reported on her attendance at an ISDOC Executive Committee meeting, an Association of California Cities summer event, and an OCWA lunch meeting.

Director Swan reported on his attendance at Newport Chamber of Commerce meetings, a briefing and tour with Yorba Linda Water District Board members, a tour of the District's Biosolids facility, a Master Gardener's composting workshop, an Association of California Cities Orange County summer event, and an OCWA lunch meeting.

Director LaMar reported on his attendance at an Association of California Cities Orange County summer event and a Syphon Reservoir Improvements Project Natural Communities Coalition Coordination meeting, and that this coming Wednesday and Thursday he will be in Sacramento attending an ACWA selection Committee meeting to review candidates for its Executive Director position.

Director Reinhart reported on his attendance at a briefing with Yorba Linda Water District Board members, a MWDOC Administration and Finance Committee meeting, and a SOCWA Board Meeting.

Director Swan said that he will visit the Baker Treatment Plant and listen to the noise levels as a followup to Mr. Alexander's comments this evening. General Manager Cook said that he will prepare a summary of the noise studies performed at this site and distribute to the Board for review.

## **REVIEW OF IRWD 2018 GOALS AND TARGET ACTIVITIES**

General Manager Cook reported that the foundational documents, the IRWD Mission, Vision and Values Statement and the IRWD Strategic Objectives, are provided in the agenda package and asked if the Board wished to discuss or make recommendations for refining these documents. Following a comment from Director Swan relative to changing conditions on the current goals and activities, he asked for a status update relative to purchasing land in Kern County be added to the August Supply Reliability Programs Committee meeting.

## GROUNDWATER WORKPLAN UPDATE

Using a PowerPoint presentation, Principle Engineer Akiyoshi provided an update on the groundwater workplan. Mr. Akiyoshi reported on the changed conditions since 2014 including well site acquisition in future Tustin Legacy Park, expansion of an existing well site on Redhill, maintaining existing Well No. 52, and implementation of an annual well rehabilitation program. He also reported on state-mandated 16% demand reduction for the District; demands in response to drought and wet years; pace of development, and OCWD policies and programs. Director Withers arrived at 11:13 p.m.

Using graphs, Mr. Akiyoshi reported on historical water use and groundwater production. He also reviewed future water demand projections and calculating groundwater production requirements.

## RECESS AND CLOSED SESSION

At 11:55 a.m., President Reinhart recessed the Board meeting to hold a Closed Session with legal counsel Casey relative to existing litigation – Government Code Section 54956.9(d)(1) IRWD v. OCWD Case No. 30-2016-00858584-CU-WM-CJC.

## **RECONVENE AND OPEN SESSION**

Following the Closed Session, the meeting was reconvened at 1:04 p.m. with five Directors present. President Reinhart said no action was reported in Closed Session.

## WATER USE EFFICIENCY AND POTENTIAL IMPACTS ON IRWD OPERATIONS

Using a PowerPoint presentation, General Manager Cook reported that during the 2013-2017 statewide drought, many utilities in California implemented successful conservation programs and subsequently experienced operational impacts due to declining sewer flows. Mr. Cook said that in 2018, legislation was passed designed to make water use efficiency a "way of life" in California with long-term reductions in water use, and that potential impacts on utility operations has become a topic of discussion throughout the state.

Director of Water Resources Sanchez reported that with the statewide drought conditions, outdoor use and incentives for turf replacement with drought tolerant plants have been implemented. Using a graph, Ms. Sanchez provided trends on the residential gallons per capita per day from 1988 through 2017 throughout the District's service area. She reviewed measures the District has taken to reduce indoor and outdoor demands since 1990. With charts and graphs, she further reviewed the percentages of water used by residential customers comparing indoor use versus outdoor use.

Using graphs, Executive Director of Engineering and Water Quality Burton reported on actual and projected trends of the Michelson Water Recycling Plant influent flows from 2010 to 2018.

Director of Recycling Operations Zepeda reported on the operations and potential impacts including: 1) distribution system status; 2) collection system's sewer gravity mains; 3) inspection and maintenance program for sewers with performance indicators; and 4) treatment plant influent water quality trends.

General Manager Cook reviewed various studies completed from 2014 through current along with ongoing studies including a potable reuse potential reuse conceptual study, a water efficiency study, and a sewage treatment master plan. Mr. Cook further reported that there have been no significant negative impacts on operations due to conservation during the drought; indoor use is demand hardened; water efficiency programs focus on outdoor use; and proactive operation and maintenance programs are in place to avoid and minimize any potential impacts.

There being no further discussion, President Reinhart adjourned the meeting at 2:07 p.m.

## SUMMARY:

During recent discussions with the California Public Employee Retirement System (CalPERS) regarding IRWD's pay schedules, IRWD was informed by CalPERS that certain job classifications were not listed on these Board-adopted Salary Schedules in accordance with CalPERS regulations. Staff recommends that the Board adopt a resolution approving corrected versions of the Schedules of Positions and Salary Rate Ranges (Salary Schedules), which were effective July 1, 2016, October 1, 2016, July 1, 2017, and July 1, 2018.

## **BACKGROUND:**

In recent years, the Board adopted the following revised and superseding Salary Schedules:

- Resolution No. 2016-16, adopting a Salary Schedule for General Employees and Supervisors, Managers, and Confidential Employees effective July 1, 2016 (July 1, 2016 Salary Schedule);
- Resolution No. 2017-2, adopting a Salary Schedule for Supervisors, Managers, and Confidential Employees effective October 1, 2016 (October 1, 2016 Salary Schedule);
- Resolution No. 2017-16, adopting a Salary Schedule for General Employees and Supervisors, Managers, and Confidential Employees effective July 1, 2017 (July 1, 2017 Salary Schedule); and
- Resolution No. 2018-17, adopting a Salary Schedule for Managers, Exempt Supervisors, Confidential, and Exempt Employees effective July 1, 2018, and Resolution No. 2018-18, adopting a Salary Schedule for General Employees and Non-Exempt Supervisors (collectively, the July 1, 2018 Salary Schedule).

In July 2018, during discussions with CalPERS regarding IRWD's pay schedules, IRWD was informed that certain job classifications were not properly listed on the above Salary Schedules that had been previously adopted by the Board. Specifically, IRWD discovered the following inaccuracies:

• The Assistant Asset Manager classification (salary grade U15.E) was reclassified to Asset System Manager (salary grade U17.E) by the General Manager effective August 15, 2016. However, the reclassification was not reflected in the Salary Schedules until adoption of the July 1, 2018 Salary Schedule; Action Calendar: Adoption of Corrected District Schedules of Positions and Salary Rate Ranges for 2016, 2017 and 2018 August 13, 2018 Page 2

- The Electrical and Automation Manager classification (salary grade U19.E) was eliminated and replaced with the two new classifications of Automation Manager (salary grade U17.E) and Electrical and Instrumentation Manager (salary grade U17.E) by the General Manager effective August 15, 2016. However, the reclassification was not reflected in the Salary Schedules until the adoption of the July 1, 2018 Salary Schedule;
- Three Assistant Director classifications (salary grade U23.E.) were reclassified to newly titled Director classifications (salary grade U27.E) by the General Manager effective January 13, 2017. However, the reclassification of these three positions (specifically, Director of Water Operations, Director of Recycling Operations, and Director of Maintenance) was not reflected in the Salary Schedules until the adoption of the July 1, 2018 Salary Schedule;
- The Recycled Water Development Manager classification (salary grade U19.E.) appears to have been inadvertently deleted on the July 1, 2018 Salary Schedule; and
- The Collection System Supervisor classification, while properly reflected on the July 1, 2018 Salary Schedule under salary grade S32.N, is also inadvertently listed under the incorrect salary grade of S30.N.

While the changes to the positions and salary grades listed above were allowable under the General Manager's authority, CalPERS requires that each employment position and pay rate be identified in a publicly available pay schedule (CalPERS Regulations, 2 CCR 570.5). Inaccuracies in IRWD's current and historic Salary Schedules can result in CalPERS being unable to approve a pay rate amount for purposes of final retirement calculation, and can potentially impact employees' pension benefits. To remedy these issues, staff recommends that the Board adopt a resolution with corrected and superseding versions of the July 1, 2016, October 16, 2016, July 1, 2017, and July 1, 2018 Salary Schedules, as follows:

## Corrected July 1, 2016 Salary Schedule (Schedule I to Board Resolution):

- Add Asset System Manager (effective August 15, 2016);
- Add Automation Manager (effective August 15, 2016);

#### ACTION CALENDAR

#### ENTERPRISE SERVER AND STORAGE REPLACEMENT

#### SUMMARY:

Staff requested proposals from three firms for enterprise server and storage replacement equipment. Based on a thorough evaluation of the proposals, staff recommends that the Board approve a General Plant expenditure of \$303,000 with Sirius Computer Solutions for purchase, installation, and configuration of enterprise server and storage replacement equipment.

#### **BACKGROUND:**

The current enterprise server and storage equipment, purchased and installed in 2011, provides server processing and storage for the District's enterprise applications and files, is nearing end of service. The applications include Oracle Financials (EBS), Oracle Business Intelligence (BI), Oracle Customer Care and Billing (CC&B), Maximo, and Micro Focus file storage services.

Staff requested proposals for enterprise server and storage equipment from three pre-qualified vendors that are certified providers of Nutanix server and storage equipment. Nutanix is a leader in hyper-converged systems which provide both virtual memory processing and storage services. The District currently uses virtualized servers as part of its existing infrastructure and hyper-converged systems, which are the newest enterprise technology. Proposals were received from Carahsoft Technology Corp, Sirius Computer Solutions, and Nutanix Inc. The results were as follows:

Nutanix, Inc.	\$674,000
Carahsoft Technology Corp.	\$709,000

Sirius Computer Solutions had the best overall pricing for the enterprise server and storage replacement equipment, providing the District significant discounts from list pricing; and has extensive experience providing equipment installation and implementation services to the District.

#### FISCAL IMPACTS:

Funds for the enterprise server and storage replacement are included in the Fiscal Year 2018-19 Capital Budget for General Plant replacement.

#### ENVIRONMENTAL COMPLIANCE:

This item is not a project as defined in the California Environmental Quality Act Code of Regulations, Title 14, Chapter 3, Section 15378.

### LAND PURCHASE AGREEMENT AND <u>TEMPORARY EASEMENT WITH THE CITY OF BAKERSFIELD</u>

#### SUMMARY:

The City of Bakersfield (City), in cooperation with the County of Kern and the California Department of Transportation (Caltrans), is developing the Centennial Corridor Improvement Project (Project) that includes construction of a roundabout that will impact a small portion of IRWD's Strand Ranch property. Staff and special legal counsel have worked with the City and its legal counsel to prepare an agreement that would accommodate the needs of the City while avoiding impacts to the Strand Ranch. Staff recommends that the Board authorize the General Manager to execute an agreement with the City, subject to changes approved by legal counsel, which would facilitate:

- The City's purchase of fee simple title to a 1.46 acres of the Strand Ranch property;
- IRWD providing a temporary construction easement on 0.30 acres of the Strand Ranch; and
- Construction of mitigation work by the City on the Strand Ranch.

## **BACKGROUND:**

The City's Project will construct a new road alignment and provide route continuity and traffic congestion relief for State Route 58 to Interstate 5. As part of the Project, a roundabout will be constructed at the intersection of the Stockdale Highway and State Route 43 (Enos Lane) which will impact a small portion of the Strand Ranch. On April 20, 2018, the City sent an offer letter to IRWD indicating that the Project will require fee title to approximately 1.46 acres of the Strand Ranch and a temporary construction easement (0.3 acres) within the Strand Ranch. With the property purchase, IRWD would also transfer title of 0.95 acres within Enos Lane and Stockdale Highway. The approximate location of the proposed Stockdale Highway – Enos Lane Roundabout Project is shown in Exhibit "A".

## Land Appraisal and Evaluation of Project Impacts

Upon receiving the City's initial offer, staff retained Alliance Appraisal to provide an assessment of the land value. Staff also contracted with Dee Jaspar & Associates (DJA) to evaluate proposed impacts from the Project on Strand Ranch facilities and operations. In addition, staff performed an in-house evaluation of an Alta Survey of the Strand Ranch and the Project construction drawings.

#### Alliance Appraisal Estimate for the Centennial Project Take:

Alliance performed an appraisal of the fair market value of the Project's proposed 1.46-acre take of the Strand Ranch property and the proposed 0.3-acre temporary easement. Alliance estimated the value to be \$36,800 in conformance with Standards Rule 2 of the Uniform Standards of Professional Appraisal Practice. Alliance's appraisal confirmed the City's fair market value of the land and construction easement in its offer of \$36,800.

## Dee Jaspar & Associates Evaluation of Project Impacts:

On May 30, 2018, DJA performed an analysis of the Project's impact on the Strand Ranch. DJA determined the proposed right-of-way take will impact the existing fencing around the Strand Ranch Facility and will encroach onto the toe of the outboard slope of the levee in the northeast corner of a recharge basin. This encroachment would eliminate the area needed for maintenance of the levee and the current setback of the levee away from the existing roadways. DJA evaluated three alternatives for mitigating the Project's impacts on the Strand Ranch levees and recommended the construction of a 395-foot long, six-foot tall masonry block wall to allow for slope maintenance and to provide protection against seepage. DJA provided a preliminary cost estimate of the mitigations, permitting, bid administration, surveying, construction inspection and a 15% contingency. Exhibit "B" presents a layout of the proposed masonry wall on the Strand Ranch Property Centennial Corridor Right of Way.

## Alta Survey and Centennial Project Plan Review:

Prior to providing the City with a counteroffer for the Centennial Corridor, staff evaluated an existing Alta survey of the Strand Ranch and the Project's construction drawings. The evaluation determined there were no unanticipated issues associated with the proposed take.

#### IRWD's Counteroffer:

On July 25, 2018, staff and legal counsel submitted a counteroffer to the City that included the independent appraisal of the land and temporary easement, reimbursement of IRWD's costs to evaluate the project take, and a requirement that the Project include the construction of a masonry wall to mitigate the Project's impact on the affected Strand Ranch recharge basin. IRWD's counteroffer included a total cost to the City of \$172,567 if IRWD were to perform construction of the wall, or \$60,690 if the City assumed responsibility for construction of the wall. The City agreed to perform the construction and accepted the terms of IRWD's counteroffer.

#### Right of Entry License Agreement:

On July 27, 2018, IRWD executed a Right of Entry License Agreement (Right of Entry) to allow the City access to the Strand Ranch property to continue development of the Project and to assist the City with qualifying for a Caltrans grant. The Right of Entry included provisions that the Action Calendar: Land Purchase Agreement and Temporary Easement with the City of Bakersfield August 13, 2018 Page 3

City place \$36,800 into escrow as partial consideration for the transaction, and a requirement for the City to construct, at its cost, the masonry wall for mitigation. The Right of Entry also reserved IRWD's right to include other just compensation. The Right of Entry anticipated that some form of an agreement of property acquisition would be considered by IRWD's Board on August 13, 2018, which is prior to a hearing on August 15, 2018 when the City is scheduled to consider adopting a resolution of necessity for taking a portion of the Strand Ranch property by eminent domain.

## Agreement for Acquisition of Real Property:

On August 3, 2018, the City provided a draft Agreement for Acquisition of Real Property and Joint Escrow Instructions that provides for the City's purchase of 1.46 acres and a 0.30-acre temporary construction easement in the amount of \$36,800 that requires the City to construct, at its cost, a masonry wall to mitigate the Project's impact. The agreement also provides for \$23,890 to cover IRWD's costs for its appraisal, engineering evaluation, legal fees and estimated construction inspection costs. The terms of the draft agreement were consistent with those included in IRWD's counteroffer and the Right of Entry agreement. Staff and special legal counsel have negotiated the final Agreement for Acquisition of Real Property and Joint Escrow Instructions that is included as Exhibit "C". Staff recommends that the Board authorize the General Manager to execute the agreement subject to changes approved by legal counsel.

## FISCAL IMPACTS:

Under the City's proposal, IRWD will receive \$36,800 in compensation for providing the permanent fee title interest and temporary construction easement to the City. IRWD will also receive \$23,890 for payment of other costs including IRWD appraisal, engineering evaluation, legal fees and inspection work. The City will also construct a masonry wall as mitigation for the Project's impact.

#### **ENVIRONMENTAL COMPLIANCE:**

This project is exempt from the California Environmental Quality Act as authorized under the California Code of Regulations, Title 14, Chapter 3, Section 15301 which provides exemption for minor alterations of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. A Notice of Exemption for the project was filed with the County of Kern.

#### COMMITTEE STATUS:

This item was not reviewed by committee in order to accommodate the City's schedule to execute the Agreement for Acquisition of Real Property.





Location: Stockdale Hwy. - Enos Ln. Roundabout Project




This figure shows the approximate location of the proposed Stockdale Hwy. - Enos Ln. roundabout project.

#### AGREEMENT FOR ACQUISITION OF REAL PROPERTY AND JOINT ESCROW INSTRUCTIONS

THIS AGREEMENT FOR ACQUISITION OF REAL PROPERTY AND JOINT ESCROW INSTRUCTIONS ("Agreement") is entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2018 by and between the **CITY OF BAKERSFIELD** (hereinafter called "Buyer"), and **IRVINE RANCH WATER DISTRICT**, **A CALIFORNIA WATER DISTRICT** (hereinafter called "Seller") for acquisition by Buyer of certain real property hereinafter
set forth. Buyer possesses eminent domain authority and Buyer's staff will recommend the adoption of a
resolution of necessity if the parties are unable to complete a negotiated acquisition of the Property by Buyer.

IT IS HEREBY MUTUALLY AGREED BETWEEN THE PARTIES AS FOLLOWS:

1. <u>AGREEMENT TO SELL AND PURCHASE</u>. For valuable consideration, the receipt of sufficiency of which are hereby acknowledged, Seller agrees to sell to Buyer and settle all related claims, including but not limited to, compensation for the acquisition Property and damages to the remainder, and Buyer agrees to purchase from Seller, upon the terms and for the consideration set forth in this Agreement, all of the following:

- a. A fee simple interest in that certain real property situated in the City of Bakersfield, County of Kern, State of California, and identified as Caltrans Parcel No. 87759-1 which consists of Parcel 1 containing 63,659 square feet more or less and Parcel 2 (located underneath the highway) containing 41,342 square feet more or less (collectively, the "Fee Acquisition"). ; and
- A temporary construction easement in, on, over and above that certain real property situated in the City of Bakersfield, County of Kern, State of California, and identified as Caltrans Parcel No. 87759-2 which consists of Parcel 1 containing 423 square feet more or less and Parcel 2 containing 809 square feet more or less (collectively, the <u>"Temporary Construction Easement</u>")

The Fee Acquisition is legally described on "EXHIBIT A-87759-1 (legal)" and depicted on "EXHIBIT A-87759-1 (plat)", and the Temporary Construction Easement legally described on "EXHIBIT A-87759-2 (legal)" and depicted on "EXHIBIT A-87759-2 (plat)", which exhibits are attached hereto and by this reference made a part hereof. The Fee Acquisition and the Temporary Construction Easement are collectively referred to in this Agreement as the "Property."

2. <u>PURCHASE PRICE</u>. Subject to Paragraph 5 below, the total purchase price ("<u>Purchase Price</u>"), payable in cash through escrow, shall be the sum of

The Purchase Price is consideration in full for ACE's acquisition of the roadway easement 207EE-RE and improvements located thereon (including irrigated landscaping and wooden fencing), a six-month License, and for entering into this Agreement, which sum will be paid at close of escrow

3. <u>CONVEYANCE OF TITLE</u>. Seller agrees to convey by grant deed to Buyer in the form set forth in EXHIBIT C attached hereto ("<u>Grant Deed</u>") fee simple title to the Fee Acquisition free and clear of all recorded and unrecorded liens, encumbrances, assessments, easements, leases, and taxes EXCEPT:

a. Non-delinquent taxes for the fiscal year in which this transaction closes which shall be

cleared and paid in the manner required by Section 4986 of the Revenue and Taxation Code, if unpaid at the close of this transaction; and

- b. Quasi-public utility, public alley, public street easements, and rights of way of record (except rights in any such items conveyed under this Agreement); and
- c. Exceptions 1 through 41 as set forth on pages 4 through 13 of that certain Preliminary Report issued by Chicago Title Company dated April 11, 2018 and given Title No. FWKN-TO16000171, a copy of which is attached hereto as EXHIBIT "E."

Seller additionally agrees to convey by to Buyer the Temporary Construction Easement in the form set forth in EXHIBIT "D" attached hereto ("Easement Deed").

4. <u>TERM OF TEMPORARY CONSTRUCTION EASEMENT</u>. The term of the Temporary Construction Easement is for a period of 48 months, commencing on July 27, 2018 and terminating on July 27, 2022 ("<u>Termination Date</u>"). Buyer will provide at least 48 hours advance written notice before any entry on Grantor's property.

5. <u>EXTENSION OF TERM OF TEMPORARY CONSTRUCTION EASEMENT; ADDITIONAL COMPENSATION.</u> In the event construction of the Project is not completed on or before the Termination Date, the Buyer shall provide written notice to Seller not less than ninety (90) days prior to the Termination Date of its election to extend the temporary construction easement and the Termination Date. Such extension shall be documented in the parties' written amendment to this Agreement and just compensation to Seller for said extension shall be paid by Buyer to Seller in the amount of \$250/month, prorated to the day.

6. <u>TITLE INSURANCE POLICY</u>. Escrow Agent shall, following recording of the Grant Deed to Buyer referenced in Paragraph 3, provide Buyer with ALTA American Land Title Association Policy of Title Insurance in the amount of \$36,800.00 issued by Chicago Title Company showing the title to the Fee Acquisition vested in Buyer, subject only to the exceptions set forth in Paragraph 3 of this Agreement and the printed exceptions and stipulations in said policy. Buyer agrees to pay the premium charged therefore.

7. <u>ESCROW</u>. Buyer agrees to open an escrow in accordance with this Agreement at an escrow company of Buyer's choice. This Agreement constitutes the joint escrow instructions of Buyer and Seller, and Escrow Agent to whom these instructions are delivered is hereby empowered to act under this Agreement. The parties hereto agree to perform all acts reasonably necessary to close this escrow, which shall close within ninety (90) days following the opening of escrow, unless extended by written agreement between the parties.

Seller shall execute and deliver the Grant Deed and Easement Deed (collectively, the "Deeds") to Escrow Agent concurrently with this Agreement, or as soon as possible thereafter when said Deeds are available. After opening of escrow, Buyer will deposit an executed Certificate of Acceptance with Escrow Agent. Buyer agrees to deposit the purchase price within ten (10) days prior to the anticipated close of escrow. Buyer and Seller agree to deposit with Escrow Agent any additional instruments as may be reasonably necessary to complete this transaction.

All funds received in this escrow shall be deposited with other escrow funds in a general escrow account(s) and may be transferred to any other such escrow trust account in any State or National Bank doing business in the State of California. All disbursements shall be made by check from such account.

# 8. <u>CONDITIONS TO THE CLOSE OF ESCROW; ESCROW AGENT AUTHORIZATIONS</u>

Unless waived, the parties' timely performance of each of the obligations required by the terms of this Agreement shall be a condition to the close of escrow. Upon satisfaction that all the conditions have been met, escrow agent is authorized to, and shall:

a. Pay and charge Seller, upon Seller's written approval, for any amount necessary to clear title

to satisfy Paragraph 3 of this Agreement;

- b. Pay and deduct from the amount shown in Paragraph 2 above, any amount necessary to satisfy any delinquent taxes together with penalties and interest thereon, and/or delinquent or non-delinquent assessments or bonds except those which title is to be taken subject to and in accordance with the terms of this Agreement;
- c. Pay and charge Buyer for all recording fees incurred in this transaction including payment of reconveyance fees and forwarding fees for partial or full reconveyances of deeds of trust or release or mortgage by Buyer;
- d. Pay and charge Buyer for any escrow fees, charges, and costs payable under Paragraph 7 of this Agreement;
- e. Record the Deeds in the office of the County Recorder, disburse funds and deliver the Deeds when conditions of this escrow have been fulfilled by Buyer and Seller.

The term "close of escrow", if and where written in these instructions, shall mean the date that necessary instruments of conveyance are recorded in the office of the County Recorder. Recordation of instruments delivered through this escrow is authorized if necessary or proper in the issuance of said policy of title insurance.

All time limits within which any matter herein specified is to be performed may be extended by mutual agreement of the parties hereto. Any amendment of, or supplement to, any instructions must be in writing.

TIME IS OF THE ESSENCE IN THESE INSTRUCTIONS AND ESCROW IS TO CLOSE AS SOON AS POSSIBLE, BUT IN NO EVENT LATER THAN NINETY (90) DAYS FOLLOWING THE OPENING OF ESCROW UNLESS EXTENDED BY THE PARTIES' WRITTEN AGREEMENT.

9. <u>ESCROW FEES, CHARGES AND COSTS</u>. Buyer agrees to pay all Buyer's and Seller's usual fees, charges, and costs which arise in this escrow. Seller shall be responsible for the costs to clear title as set forth Paragraphs 3 and 6.

10. <u>TAX EXEMPT AGENCY</u>: All parties hereto acknowledge that the Buyer is public entity and exempt from payment of any real property taxes. Therefore, Seller acknowledges that Seller is solely responsible for payment of any/all real property taxes due through the date of close of escrow, if any, including any pending supplemental bills.

In the event that the current year's property tax bill has been issued at the time of close of escrow, escrow holder is authorized and instructed to pay and/all installments, currently due, along with any delinquencies. Escrow holder is instructed to NOT prorate said taxes. Any potential refund due to the seller, for partial tax period ownership, will be at the sole discretion of the Kern County Tax Collector and be refunded by the County as per their guidelines. Buyer and Escrow holder are not responsible for same.

In the event the close of escrow occurs after July 1 and before the new tax bill has been issued, Escrow holder is authorized and instructed to prorate taxes based on the last available tax bill and forward the prorated amount to the Buyer at close of escrow. Buyer will accept responsibility to forward said proration's to the Kern County Tax Collector once the bills are created. Seller herein agrees to forward to Buyer any tax bills they receive from the County of Kern.

11. <u>FULL AND COMPLETE SETTLEMENT.</u> Subject to the last sentence in this Paragraph 11 and Buyer's obligations as set forth throughout this Agreement, Seller hereby acknowledges that, together with the Additional Reimbursements set forth in Paragraph 12 and the Curative Work set forth in Paragraph 13, the compensation paid to Seller through this Agreement constitutes the full and complete settlement of any and

all claims against Buyer, by reason of Buyer's acquisition of the Property, specifically including, but not limited to, any and all damage to Seller's remainder property by reason of the acquisition of the Property or the installation of the Project in the manner proposed, the value of improvements pertaining to the realty, leasehold improvements, any and all claims of rental or leasehold value and loss of business goodwill (excluding relocation benefits, if any), and any and all claims in inverse condemnation and for precondemnation damages, and any and all other claim that Seller may have, whether or not specifically mentioned here, relating directly or indirectly to the acquisition by Buyer of this subject Property and construction of the Project. Seller and Buyer, and each and all of their individual collective agents representatives, attorneys, principals, predecessors, successors, assigns, administrators, executors, heirs, and beneficiaries, hereby release the other party, and each of them, from any and all obligations, liabilities, claims, costs, expenses, demands, debts, controversies, damages, causes of action, including without limitations those relating to just compensation, damages, which any of them now have, or might hereafter have by reason of any matter or thing arising out or in any way relating to any condemnation action affecting the subject Property and construction of the Project. Seller expressly reserves its right to pursue any and all claims for damage, liability, or expense due to or arising out of the negligent or intentional willful tortious conduct on the part of the Buyer, and its agents, contractors, subcontractors, and/or employees, resulting in physical damage to real or personal property or personal injury.

12. <u>ADDITIONAL REIMBURSEMENTS.</u> Buyer will pay to Seller appraisal costs in the amount of \$5,000, the payment of which is a condition to the close of escrow.

13. <u>CURATIVE WORK.</u> It is understood and agreed by and between the parties hereto in addition to payment of the Purchase Price shown in Paragraph 2 and additional reimbursements shown in Paragraph 12, the Buyer will, at Buyer's sole cost and expense, cause a 6' high block retaining wall along the toe of the slope being impacted by the Project (approximately 395 lf) to be constructed in the manner set forth in EXHIBIT "B" attached hereto, or in some other manner approved by Seller's General Manager in his reasonable discretion. All work performed under this Agreement shall conform to all applicable building, fire and sanitary laws, ordinances and regulations relating to such work and shall be completed in a good and workmanlike manner. The construction of the work set forth in this Paragraph shall be completed in a reasonable time, but need not be completed by the close of escrow.

14. <u>POSSESSION.</u> Buyer shall be entitled to possession of the Property as of July 27, 2018.

15. <u>RENTAL AND LEASEHOLD INTEREST.</u> Seller warrants that there are no third parties in possession of any portion of the Property as lessees, tenants at sufferance, trespassers, or invitees, and that there are no oral or written recorded or unrecorded leases or other agreements concerning all or any portion of the Property exceeding a period of one month.

16. <u>WARRANTIES, REPRESENTATIONS, AND COVENANTS OF SELLER</u>. Except as otherwise provided in the Agreement, the sale of the Property is "AS-IS" except for the following representations and warranties of Seller to Buyer made as of the closing.

- a. Until the closing, Seller shall not do anything which would impair Seller's title to any of the Property.
- b. Until the closing, Seller shall, upon learning of any fact or condition which would cause any of the warranties and representations contained in this Section of the Agreement not to be true as of closing, immediately give written notice of such fact or condition to Buyer.

17. <u>MUTUAL INDEMNITY</u>. Buyer shall indemnify, defend, and hold harmless Seller and Seller's officers, agents and employees against any and all liability, claims, actions, causes of action or demands whatsoever against them, or any of them, before administrative or judicial tribunals of any kind whatsoever, arising out of, connected with, or caused by Buyer or Buyer's employees, agents, independent contractors, companies, or subcontractors use of the Property. Seller shall indemnify, defend, and hold harmless Buyer and Buyer's officers, agents and employees against any and all liability, claims, actions, causes of action or demands

whatsoever against them, or any of them, before administrative or judicial tribunals of any kind whatsoever, arising out of, connected with, or caused by Seller or Seller's employees, agents, independent contractors, companies, or subcontractors use of the Property or Seller's remaining Property.

18. <u>COUNTERPARTS</u>. This Agreement may be executed in counterparts, each of which so executed shall, irrespective of the date of its execution and delivery, be deemed an original, and all such counterparts together shall constitute one and the same instrument.

19. <u>CONTINGENCY</u>. It is understood and agreed between the parties hereto that the completion of this transaction, and the escrow created hereby, is contingent upon the specific acceptance and approval of the Buyer herein. The execution of these documents and the delivery of same to Escrow Agent constitutes said acceptance and approval.

20. <u>BROKERS AND FINDERS</u>. The parties acknowledge and represent that Buyer shall pay no commission to any broker or finder in connection with the purchase and sale of The Property.

21. <u>JURISDICTION AND VENUE</u>. This Agreement shall be governed by and constructed in accordance with the laws of the State of California. The parties consent to the jurisdiction of the California Courts with venue in Kern County.

22. <u>ASSIGNMENT</u>. The terms and conditions, covenants, and agreements set forth herein shall apply to and bind the heirs, executors, administrators, assigns and successors of the parties hereto. Buyer may freely assign any or all of its interests or rights under this Agreement or under the Escrow without the consent of Seller.

23. <u>COOPERATION.</u> Each party agrees to cooperate with the other in the closing of this transaction and, in that regard, to sign any and all documents which may be reasonably necessary, helpful, or appropriate to carry out the purposes and intent of this Agreement including, but not limited to, releases or additional agreements.

24. <u>ENTIRE AGREEMENT, WAIVER AND MODIFICATION</u>. This Agreement is the entire Agreement between the parties with respect to the subject matter of this Agreement. It supersedes all prior agreements and understandings, whether oral or written, between the parties with respect to the matters contained in this Agreement. Any waiver, modification, consent or acquiescence with respect to any provision of this Agreement shall be set forth in writing and duly executed by or on behalf of the party to be bound thereby. No waiver by any party of any breach hereunder shall be deemed a waiver of any other or subsequent breach.

25. <u>NOTICE</u>. Notices to the parties to the Agreement shall be sent by email or facsimile transmission and addressed as follows:










Figure 3 - Alternative #2 Layout

Alternative #2 involves constructing a six-foot tall masonry block wall along the proposed right-of-way line as shown in Figure 3.




