#### MINUTES OF REGULAR MEETING – April 27, 2020

The regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 5:05 p.m. by President Matheis on April 27, 2020 via teleconference pursuant to the provisions of the Governor's Executive Orders N-25-20 and N-29-20 due to COVID19. Members of the public did not attend this meeting in person.

#### IRVINE RANCH WATER DISTRICT STRATEGIC MEASURES

In response to Director Reinhart's inquiry relative to non-potable sales by tiers, General Manager Cook said that he will provide an analysis to the Board to review. In response to his additional question relative to imported water purchases, General Manager Cook will follow up with him relative to the calculations for this chart. There being no further comments, on MOTION by Reinhart, seconded by Matheis, and unanimously carried on a roll call vote (5-0) Withers, Matheis, Reinhart, Swan, and LaMar voting aye, and 0 noes, THE BOARD RECEIVED AND FILED THE REPORT.

#### MID-CYCLE CAPITAL BUDGET UPDATE FOR FISCAL YEARS 2019-20 AND 2020-21

Using a PowerPoint presentation, Mr. Mitch Robinson provided a presentation on the Mid-cycle Capital Budget Update for FY 2019-20 and 2020-21 and highlighted these changes to the total budget and the forecasted expenditures for FY 2020-21 and proposed adding 25 new projects to the Capital Budget. Mr. Robinson said that the total budget for the additional projects is \$20.6 million and increases the forecasted expenditures for FY 2020-21 by \$4.6 million.

Following the presentation, Director Reinhart said that this item was reviewed by the Engineering and Operations Committee on April 21, 2020. On MOTION by Reinhart, seconded by Matheis, and unanimously carried on a roll call vote (5-0) Withers, Matheis, Reinhart, Swan, and LaMar voting aye, and 0 noes, THE BOARD RECEIVED AND FILED THE MID-CYCLE CAPITAL BUDGET UPDATE FOR FISCAL YEARS 2019-20 AND 2020-21 AND APPROVED THE FISCAL YEARS 2019-20 AND 2020-21 MID-CYCLE CAPITAL BUDGET PROJECT ADDITIONS.

#### SANTIAGO RESERVOIR IMPROVEMENTS

Using a PowerPoint presentation, Principal Engineer Moeder reported on the purpose and background of the improvement project. Using a chart, he provided a history of IRWD retaining AECOM for the design of the Outlet Tower Replacement project, which it completed the Preliminary Design Report for the project in February 2019. Also, the District retained GEI to perform a condition assessment of the Santiago Reservoir spillway which identified the need to replace the nearly 90-year-old spillway. He said that given the necessity of the project, IRWD contracted with GEI to develop hydraulic design criteria for a replacement spillway and to identify and evaluate multiple spillway replacement alternatives.

Mr. Moeder said that subsequently, staff from IRWD and Serrano Water District agreed to merge the outlet tower and spillway replacement projects into a single project to streamline the project execution since the improvements are in the same area and the projects contain overlapping activities including extensive coordination with the Division of Safety of Dams (DSOD), geotechnical and geological investigations and testing, permitting, and environmental

compliance. He said that to complete the design of the combined project, staff requested that AECOM and GEI prepare an overall coordinated design for the Santiago Reservoir improvements. This collaboration will capture, and efficiently build upon, the work previously completed by each firm and will ensure that the design is advanced in the most expeditious manner.

Mr. Moeder said that at the request of staff from IRWD and Serrano Water District, AECOM and GEI prepared a proposal for completing a combined project that includes the following primary components: 1) geotechnical and geological investigations and laboratory testing; 2) erodibility study for Santiago Creek; 3) hydrologic and hydraulic analyses; and 4) preliminary and final design services for the proposed inclined outlet structure, outlet works facilities, and spillway.

Mr. Moeder reviewed the project schedule and said that the Phase II Spillway Assessment report, which DSOD reviewed and with which it agrees, identified the need to replace the spillway by the end of 2029. AECOM and GEI's combined comprehensive scope of work is based on a detailed design schedule that targets completing the design by summer 2023 and constructing the improvements over a two-year period. This schedule provides completing the spillway replacement and other improvements in advance of the 2029 deadline and includes an acceptable margin of time to address unknown geotechnical or design issues, extended DSOD review periods, extended environmental or regulatory coordination, and construction delays.

Mr. Moeder said that this item was reviewed by the Serrano Water District / IRWD Committee on April 15, 2020. Both IRWD and Serrano agreed that the project needs to proceed expeditiously, but Serrano requested additional time to review and discuss the project and the consultant selection recommendation with its full Board of Directors. Serrano anticipates having those discussions in the next several months with the goal of providing confirmation of the project and the consultant selection to IRWD by June.

At the Committee meeting, IRWD expressed its interest to proceed with the consultant selection recommendation along with several initial design activities, recognizing that it would be a sole source award. By adopting this approach, work on the project can continue while Serrano completes its internal discussions with its Board of Directors. General Manager Cook asked that the recommended motion be modified to authorize AECOM to proceed with initial scope items in the not-to-exceed amount of \$300,000 to allow for progress of the initial design activities. Serrano Water District's General Manager Jerry Vilander thanked staff, the General Manager and the Board for all the collaborative efforts and said that Serrano would need a three-month delay for a peer review of this project with his Board.

Director Swan reported that this item was reviewed by the Serrano Water District / IRWD Committee on April 15, 2020. President Matheis then thanked Mr. Moeder on his presentation. There being no further comments, on MOTION by Swan, seconded by Matheis, and unanimously carried on a roll call vote (5-0) Withers, Matheis, Reinhart, Swan, and LaMar voting aye, and 0 noes, THE BOARD AUTHORIZED A BUDGET INCREASE FOR PROJECT 01813 IN THE AMOUNT OF \$123,890,000, FROM \$15,417,000 TO \$139,307,000, AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH AECOM IN THE AMOUNT OF \$4,989,380 FOR ENGINEERING DESIGN SERVICES FOR THE SANTIAGO RESERVOIR IMPROVEMENTS, PROJECT 01813, AND AUTHORIZED AECOM TO PROCEED WITH INITIAL SCOPE ITEMS WITH

THE UNDERSTANDING THAT WORK WILL PROCEED ON THE INITIAL SCOPE ITEMS FOR AMOUNT NOT TO EXCEED \$300,000.

#### GENERAL MANAGER'S REPORT

General Manager Cook reported that business is ongoing, the District is well-equipped, and no illnesses related to the coronavirus have been reported to date. Mr. Cook said Recycling Department staff is checking if foreign material has been flushed into the system, and to date, staff is not seeing an increase from previous months. He said that Director Colston's staff is preparing outreach material for when businesses reopen since their buildings have probably not been occupied. He said that the email migration to Outlook went very well over the weekend, and complimented Mr. Randy Williams along with his staff for a job well done.

Mr. Cook introduced Mr. Tom Malone, the District's new Director of Administration Services.

Mr. Cook said that he spoke with the District's consultant, Mr. Bruce Newell, and he had nothing to report tonight.

He further asked that the Board meeting be adjourned in Tom Ash's memory, who passed on Easter Sunday. He said that Tom, a former IRWD employee, primarily worked on water conservation issues and always spoke highly of IRWD.

#### **DIRECTORS' COMMENTS**

Director Withers reported on his attendance at two ACC-OC webinars, one on working at home and labor laws, and the second relative to social distancing. He further thanked Mr. Randy Williams on his efforts with the email migration.

Director Swan reported on his virtual attendance on April 14 at an OCBC meeting, MWDOC Board and Committee meetings, Newport Beach Chamber of Commerce meetings, a WACO Planning Committee meeting, a MWDOC/OCWD Joint Planning Committee meeting, a scoping session relative to the Kern Fan Project, and a PPIC meeting relative to headwaters. In response to his comment relative to the COVID-19 virus not being transmitted in recycled water, General Manager Cook said that Public Affairs staff could include an educational article on the process of using recycled water in the toilets in office buildings.

Director LaMar reported on his attendance at three ACWA meetings on April 13, April 20, and April 27, a MWDOC Public Affairs and Legislative Committee meeting, a MWDOC/OCWD Joint Planning Committee meeting, an ACWA Federal Affairs meeting on April 22, a Natural Communities Coalition meeting on April 22, an ACWA task force meeting on April 23 relative to disadvantaged communities, an ACWA State Legislative meeting on April 23, and a training course on COVID-19.

Director Reinhart reported on his attendance at all MWDOC and OCWD meetings, but said he was unable to attend the MWDOC/OCWD Joint Planning meeting.

Director Matheis reported that she watched a safety webcast, and a Board of Supervisors webcast. She said she is very proud of IRWD during this time, and further complimented Mr. Randy Williams on the email migration and training assistance he gave her to get up to speed

with webinars, etc. along with General M times due to the COIVD-19 pandemic.	Manager Cook and the Board during these challenging

#### CONSENT CALENDAR

#### 2020 LEGISLATIVE AND REGULATORY UPDATE

#### **SUMMARY:**

This report provides an update on the 2019-2020 legislative session, regulatory issues, and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate. Staff recommends the Board consider the following actions/positions:

• AB 2968 (Rodriguez) – County Emergency Plans: "SEEK AMENDMENTS".

#### **BACKGROUND:**

Normally, the months of April and May are a very busy time of year in Sacramento. The Legislature is ordinarily active hearing and amending bills. This year, the California Legislature recessed the 2020 legislative session on March 16 in response to COVID-19. They originally suspended the session until April 13 and then extended the suspension until May. The Assembly returned and resume legislative activity on May 4. As of the writing of this report, the State Senate currently plans to return on May 11, although that date may be extended.

While both houses plan on resuming normal legislative activities, the process will be anything but normal. Both houses are in the process of developing procedures on how they will resume legislative activities while ensuring social distancing and encouraging remote public engagement. Currently, they expect to limit in-person testimony on bills to testimony by bill sponsors only and are asking that all others provide testimony via telephone.

One of the other COVID-19 impacts on the legislative session is the fact that the Legislature is planning on dealing with only those urgent and time sensitive matters this year. Leadership in both houses have asked their members to limit the number of bills moving through the legislative process and to limit active bills to those that must be acted upon this year. It seems that urgent bills are those that deal with COVID-19 response, wildfires, homelessness, and housing.

Until the suspension, the last day for policy committees to hear fiscal bills was April 24, while May 1 was the policy committee deadline for non-fiscal bills. The last day for fiscal committees to meet and act on bills introduced in their house was May 15. While the Legislature will likely change the legislative calendar when it returns, one deadline the Legislature is unable to change is the June 15 constitutional deadline to enact a budget. Staff discussed the impact of COVID-19 on this year's legislative session and the State budget with the Water Resources Policy and Communications Committee (Committee).

A copy of the 2020 Legislative Matrix is provided as Exhibit "A". Links to the bills discussed below are included within each discussion, unless a separate exhibit is noted.

2020 State Legislative Update:

Climate Resilience Bond or Economic Stimulus Bond:

At the beginning of the 2020 legislative year, there was political will to pass and place on the November 2020 ballot a climate resilience bond. As the statewide COVID-19 response and associated economic impact continue, the current public health emergency is impacting the likelihood that a climate resilience bond will be placed on the November 2020 ballot. As the probability for a climate resilience bond decreases, there is an increased likelihood that the Governor and the Legislature will transition the discussions on a climate resilience bond into an economic stimulus bond.

Recently 20 members of the Assembly and Senate sent a letter to the Administration. The letter shows that members of the Legislature are focusing on how the Administration is "architecting" California's economic recovery and how investments in infrastructure can aid in that recovery. A copy of this letter is provided as Exhibit "B".

Staff discussed how IRWD is preparing to engage should an economic stimulus bond become the State's priority with the Committee on May 7, 2020.

Legislation Related to De-energization Events:

To reduce the risk of catastrophic wildlife, electric utilities has begun to institute Public Safety Power Shutoffs (PSPS). A PSPS event is a de-energization event in which the power in high-risk areas is turned off to reduce the likelihood of a wildfire starting from downed power lines and related equipment. IRWD, like many other water and sewer providers, has been affected by PSPS events.

To prepare for a loss of electricity, IRWD has set up generators at all of its critical facilities to ensure that IRWD has the power to keep water and sewer systems operational. While IRWD is prepared to continue operating during these PSPS and other de-energization events, the District's backup generators are regulated by various air quality regulations which place limits on the runtimes of backup generators and the testing that can be performed on them.

There are two bill that would be beneficial to IRWD with regard to PSPS events:

- AB 2182 (Rubio, D- West Covina) Emergency Backup Generators: Water and Wastewater Facilities Exemption: AB 2182 would exempt the operation of a backup generator at a critical facility during a de-energization event from any local, regional, or state regulation limiting the runtime of the generator. The bill would also allow generators to be tested and maintained consistent with the National Fire Protection Association's standards. The bill is sponsored by the Association of California Water Agencies. AB 2182 will not be moving forward this year. IRWD had a "support" position on AB 2182, and
- <u>SB 1099 (Dodd, D-Santa Rosa) Emergency Backup Generators: Critical Facilities:</u> SB 1099 would require air districts to adopt a rule to allow critical facilities with a permitted emergency backup generator to use that generator during a de-energization event of other

loss of power. It would also require those generators to be tested and maintained consistent with the National Fire Protection Association's standards. The bill includes water and wastewater facilities in the definition of critical facilities and is co-sponsored by the California Municipal Utilities Association (CMUA) and the Las Virgenes Municipal Water District. Senator Dodd is currently planning to move forward with SB 1099 this year. CMUA and Las Virgenes Municipal Water District are working on amendments to the bill. IRWD has a "support" position on SB 1099.

Staff provided the Committee with an update on this legislation.

Legislation Related to Fees on Residential Housing Development:

One of the prominent topics of discussion during the 2019 legislative year was the lack of affordable housing in California. At the end of the legislative year, the discussion on housing affordability turned to the fees assessed on new housing development. The discussion on fees was spurred by a report issued by the University of California, Berkeley's Terner Center— the "Residential Impact Fees In California: Current Practices and Policy Considerations to Improve Implementation of Fees Governed by the Mitigation Fee Act," (the "Terner Study").

In response to Terner Study's release, Assemblymember Timothy Grayson (D-Concord) amended AB 1484 to propose a number of changes to the laws governing fees charged to new housing developments, including connection fees. Staff engaged with IRWD's associations and industry partners to seeks the removal of connections fees from the scope of AB 1484; however, the legislative year ended before Assemblymember Grayson could work on AB 1484 further. Over the legislative recess, Assemblymember Grayson held a series of roundtables throughout the state to gather information on the fees charged on new residential housing developments.

On February 24, 2020, Assemblymember Grayson in conjunction with Assemblymembers David Chiu (D-San Francisco), Rob Bonta (D-Oakland), Todd Gloria (D-San Diego), and Jesse Gabriel (D-San Fernando Valley) held a press conference announcing a package of eight bills meant to address development fees on housing developments. In addition to AB 1484, the package includes:

- <u>AB 1924 (Grayson) Housing Development Fees:</u> AB 1924 would require that a fee imposed on a housing development project be proportionate to the square footage of the proposed unit or units;
- <u>AB 3144 (Grayson) Housing Cost Reduction Incentive Program:</u> AB 3144 would provide state funding to reimburse local governments who waive impact fees on affordable projects;
- <u>AB 3145 (Grayson) Housing Development Fees and Exactions Cap:</u> AB 3145 would establish a development fee cap on housing development fees based on the median home price in a city or county. The bill would prohibit a city or county from imposing a fee above 12 percent of the city's or county's median home price unless the Department of Housing and Community Development approves the fee;
- <u>AB 3146 (Bonta/Grayson) Housing Data:</u> AB 3146 would require\_cities and counties to report a wide variety of housing data to the Department of Housing and Community

Development, including the number of new housing units that have been issued a completed entitlement, a building permit, or a certificate of occupancy;

- <u>AB 3147 (Gabriel) Fees for Development Projects:</u> AB 3147 would repeal the 120-day statute of limitations on challenging new fees or service charges. The stated goal of the bill is to permit impacts fees and connections fees to be paid under protest, if the developer believes the fee to be unreasonably high;
- <u>AB 3148 (Chiu) Affordable housing Fee Reductions:</u> AB 3148 would require a city, county, special district or other local agency, except a school district, to reduce the fees imposed on affordable housing units by 25-75 percent; and
- AB 3149 (Gloria) Mitigation Fee Act: AB 3149 was amended on May 4. The bill now requires a city or county to mail a notice of the time and place of the public meeting at which service charges and fees are being considered to be mailed to any interested party 45 days, instead of 14 days, prior to the meeting. The bill also requires that the city or county make available to the public, including on its internet website, all of the data indicating the amount of cost, or estimated cost, required to provide the service for which the fee or service charge is levied demonstrating the requisite relationship between the amount of the fee and the need for the public facilities. This information must be made public at least 30 days, instead of 10 days, prior to the meeting.

In addition to this package of bills, AB 2722, authored by Assemblymember McCarty (D-Sacramento, would prohibit a noncompliant local agency that imposes any fees or charges on a qualified development shall not require the payment of those fees or charges until 20 years from the date of the final inspection, or the date the certificate of occupancy is issued, whichever occurs first. The bill defines a "noncompliant local agency" as a local agency that did not meet its regional housing needs during the most recent complete regional housing needs assessment cycle and for the current regional housing needs assessment cycle, the local agency meets either of the following.

Staff discussed these bills with the Committee.

#### Additional 2020 State Legislation of Interest to IRWD:

There are a number of other bills of interest to the District, including:

- <u>AB 2968 (Rodriguez) County Emergency Plans:</u> AB 2968 would require the California Office of Emergency Services (OES) to establish best practices for counties developing and updating a county emergency plan. The bill would require that OES review each county's plan and determine if the plan sufficiently covers the following elements:
  - Whether the plan is consistent with the office's proposed best practices;
  - Whether the plan protects and accommodates vulnerable populations during natural disasters;
  - Whether the plan has established procedures for alerting, evacuating, and sheltering individuals during an emergency; and

o Any other necessary and appropriate element, as determined by the office.

Staff recommends the Board adopt a "seek amendments" position on AB 2968, and authorize staff to seek amendments that would ask OES to determine if the plans sufficiently establish proceeds for coordinating emergency response with other local agencies, including water agencies, and other essential utility providers.

Staff discussed the following bills with the Committee:

- Executive, legislation and regulatory actions related to discontinuation of water service;
- SB 1386 (Moorlach) Local Government- Water Assessments, Fees and Charges;
- State-proposed COVID-19-related legislation.

#### 2020 State Regulatory Update:

While the Legislature has been quiet for the past month and a half, State regulatory agencies have continued to move forward with key water-related regulations. The State Water Resources Control Board adopted its proposed Urban Water Report Regulation on April 22. Staff discussed these regulations with the Committee.

In addition, the following is a list of some of the State regulations and agency reports staff is monitoring, tracking or planning to engage in over the next three to 12 months. As the next drafts of the regulations or report are released for public review and comment, staff will engage, as appropriate. Staff also provided an oral update to the Committee on new developments related to these regulations.

The pending regulations and reports actively being tracked include the:

- California Plumbing Code Update;
- CalRecycle's SB 1383 Regulations;
- Department of Water Resources (DWR) and the State Board's implementation of the "Making Water Conservation a California Way of Life" legislation;
- State Board Electronic Annual Report;
- State Board's AB 401 Implementation/Low Income Rate Assistance Report and the Office of Environmental Health Hazard Assessment's "A Framework and Tool for Evaluating California's Progress in Achieving the Human Right to Water;"
- State Board's Chromium-6 Drinking Water Economic Feasibility Analysis;
- State Board's development of a "Cross Connection Policy Handbook;"
- State Board's proposed "Environmental Laboratory Accreditation Program Regulations:"
- State Board's proposed "Mercury TMDL and Statewide Mercury Control Program for Reservoirs" regulations;
- State Board's proposed definition of "Microplastics in Drinking Water";

• State Board's Safe and Affordable Drinking Water Fund Implementation and Safe and Affordable Funding for Equity and Resilience (SAFER) Program;

- State Board's "Water Loss Performance Standards Regulations;"
- State Board's Water Rights Enforcement Policy; and
- State Board's "Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California" and draft "Toxicity Provisions."

#### 2020 Federal Legislative Update:

IRWD's federal advocacy efforts in 2020 continues to largely focus on seeking federal funding for the Kern Fan Groundwater Storage Project and advocating for increased funding authorization for the federal Water Storage Program. As the nation's attention has shifted to COVID-19, staff and the District's advocates have been tracking the federal legislation dealing with the coronavirus. Staff updated the Committee on these efforts and on the ongoing efforts related to positioning the Kern Fan Groundwater Storage Project for federal funding this year.

#### 2020 Federal Regulatory Update:

On April 21, the U.S. Environmental Protection Agency (EPA) and the Department of the Army published a final rule defining "waters of the United States" (WOTUS), which are waters that are federally regulated pursuant to the Clean Water Act. This final rule represents the culmination of the second step of a two-step process the EPA has undertaken to revise the definition of WOTUS, in adherence with the direction provided by an executive order signed by President Trump February 28, 2017.

In April 2019, IRWD submitted comments to the EPA on the proposed rule. IRWD requested amendments for specified exclusions from the definition of WOTUS. The final rule clearly defines four categories of water regulated at WOTUS. Those waters are:

- Territorial seas and traditional navigable waters;
- Perennial and intermittent tributaries to territorial seas and traditional navigable waters;
- Certain lakes, ponds and impoundments; and
- Wetlands adjacent to jurisdictional waters.

Additionally, the final rule excludes the following from the definition of WOTUS:

- Groundwater, including groundwater drained through subsurface drainage systems;
- Ephemeral features that flow only in direct response to precipitation, including ephemeral streams, swales, gullies, rills, and pools;
- Diffuse stormwater runoff and directional sheet flow over upland;
- Ditches that are not traditional navigable waters, tributaries, or that are not constructed in adjacent wetlands, subject to certain limitations;
- Prior converted cropland;

- Artificially irrigated areas that would revert to upland if artificial irrigation ceases;
- Artificial lakes and ponds that are not jurisdictional impoundments and that are constructed or excavated in upland or non-jurisdictional waters;
- Water-filled depressions constructed or excavated in upland or in non-jurisdictional waters incidental to mining or construction activity, and pits excavated in upland or in non-jurisdictional waters for the purpose of obtaining fill, sand, or gravel;
- Stormwater control features constructed or excavated in upland or in non-jurisdictional waters to convey, treat, infiltrate, or store stormwater run-off;
- Groundwater recharge, water reuse, and wastewater recycling structures constructed or excavated in upland or in non-jurisdictional waters; and
- Waste treatment systems.

Overall, the final rule, which is scheduled to take effect on June 22, provides greater clarity around which waters are WOTUS.

Dear Ms. O'Leary and Mr. Steyer,

First, thank you. Governor Newsom and his Administration's leadership through the COVID-19 crisis have saved countless lives. We laud the establishment of his Task Force on Business and Jobs Recovery and offer some initial thoughts, and a willingness to assist, in developing a resilient recovery plan in concert with our leadership.

The massive financial disruption unleashed by COVID-19 necessitates immediate relief across a wide variety of job sectors, especially those hit hardest by social distancing orders, like the retail, entertainment and hospitality industries. Hundreds of thousands of workers have been impacted and are falling into poverty without an inclusive and comprehensive safety net — and this descent will only worsen without direct and sustained intervention.

In architecting our economic recovery in California, we would urge you to consider a recovery plan that in the short-term prioritizes the essentials - food, housing and job security. For the long-term, the investments we make and the additional jobs we create must be high-quality and durable enough to survive a dynamic future of work under increasingly high-risk climate and public health conditions.

These risks are not hypothetical. In recent weeks, superstorms from Texas to North Carolina to Florida have destroyed lives and communities already decimated by COVID-19. Climate

disasters will likely compound the crisis in California in the coming months as we enter megadrought and wildfire season.<sup>i</sup>

We know that rolling back critical environmental protections is not the path forward. By failing to meet our climate goals, we would not only bankrupt our state – we would drive countless species into extinction and erode the foundation that makes California golden. Now more than ever, we must uphold California's commitment to a livable and prosperous future.

Based on past stimulus efforts, as well as the success of various housing, education, transportation, water, disaster and resource bonds, we know the clean economy – transportation, housing, energy, water, manufacturing, waste, and natural and working lands – is one of the most cost-effective, resilient job creation sectors economy-wide. ii Given our fiscal limitations, we also encourage you to consider policy changes that incentivize clean economy job creation.

We will be submitting a more detailed framework in the coming weeks and look forward to working with you to refine details, but until then, please consider focusing on three core areas to achieve a resilient recovery:

- Leveraging All Available Sources of Funding by significantly augmenting climate resilience bond proposals; renewing federal assistance for state and local governments, joint powers authorities, transportation agencies, special districts and businesses through state financing authorities like the Infrastructure Bank; enhancing tax increment financing mechanisms; and unlocking private capital through creative public asset securitization.
- Accelerating Job Creation through Expedited Project Delivery by reducing barriers to
  entry, such as discriminatory fees and interconnection delays, that stifle the creation of highquality jobs from clean economy projects for long-term energy storage, distributed
  generation, microgrids and other renewable and zero-emission grid resilience projects;
  permitting and procurement challenges for the electric vehicle supply chain, from lithium
  recovery to electric vehicle charging infrastructure; and impediments to construction for preapproved, shovel-ready projects like transit-oriented affordable housing, water resilience and
  waste recycling.
- Ensuring a Just Recovery by focusing on keeping workers employed, with livable wages and benefits, providing improved support to small businesses, broadening the social safety net and targeting state benefits toward the most disadvantaged communities that already face immense challenges to their environment, health, education and opportunity.

Thank you for your consideration. We look forward to partnering on a just and resilient recovery.

# REGISTRAR OF VOTERS INFORMATION REQUEST AND CANDIDATE STATEMENT WORD LIMIT FOR THE ELECTION OF THE BOARD OF DIRECTORS

#### **SUMMARY:**

Members of IRWD's Board of Directors are elected on a staggered basis to four-year terms every two years during the general elections held in even numbered years. Prior to each general election at which a member of the Board is to be elected, the Office of the Registrar of Voters requests that the District submit a "Transmittal of Election Information" form. Staff recommends the Board authorize the District Secretary to file the "Transmittal of Election Information" form for each general election providing the Registrar of Voters with the requested information, selecting a 200-word limit for Candidate Statements of Qualifications, and indicating that the District will not pay for the Statements of Qualifications.

# **BACKGROUND:**

While IRWD currently uses an at-large method to elect the members of its Board of Directors, beginning with the November 2020 general election the Board of Directors will be elected through division-based elections. Despite the change to division-based elections, the members of the Board will still be elected on a staggered basis to four-year terms every two years during the general elections held in even numbered years. The Board members from Divisions 1 and 4 will be elected in 2020 and the Board members from Divisions 2, 3 and 5 will be elected in 2022.

## Registrar of Voters "Transmittal of Election Information" Form:

Prior to each general election at which a member of the Board is to be elected, the Office of the Registrar of Voters requests that the District submit a "Transmittal of Election Information" form. Provided as Exhibit "A" is a letter from the Office of the Registrar of Voters and a copy of the "Transmittal of Election Information" form for the November 2020 general election.

The Transmittal of Election Information" form requests that the District:

- Confirm the District's boundaries and the boundaries of the District's divisions;
- Provide the Registrar of Voters with the number of directors to be elected in that election, and the divisions from which they are to be elected;
- Provide the Registrar of Voters with a list of incumbents; and
- Select either a 200- or 400-word limit for Candidate Statements of Qualifications and indicate whether the District will or will not pay for those statements.

For many years, the District has submitted this form and provided the requested boundary, election, and incumbent information. Historically, the District has authorized 200 words and has elected not to pay for candidate statements.

Staff recommends the Board authorize the District Secretary to file the "Transmittal of Election Information" form for each general election confirming the District political and division boundaries, providing the Registrar of Voters with the requested information, selecting a 200-word limit for Candidate Statements of Qualifications, and indicating that the District will not pay for the Statements of Qualifications.

### **SUMMARY:**

The Bonita Canyon Recycled Water Zone D to B Pressure Reducing Station Supply Pipeline Replacement is complete. IRWD's contractor TE Roberts has completed all required work and punch list items. The project has received final inspection and acceptance of construction is recommended.

# MICHELSON WATER RECYCLING PLANT EMERGENCY RECYCLED WATER DIVERSION TO SAN DIEGO CREEK FINAL ACCEPTANCE:

The Michelson Water Recycling Plant (MWRP) Emergency Recycled Water Diversion to San Diego Creek project is complete. IRWD's contractor PCL Construction completed all required work and punch list items. The project has received final inspection and acceptance of construction is recommended.

#### BACKGROUND:

In September 2018, the Regional Water Quality Control Board approved an MWRP permit amendment allowing the emergency discharge of dechlorinated tertiary effluent to San Diego Creek under certain emergency conditions. This project constructed the facilities needed to accomplish the emergency diversion to the creek. Facilities include a sodium bisulfite storage and feed system for dechlorination, concrete chemical containment structure, flow metering, conveyance piping and valving, and associated chlorine analyzers and instrumentation. The design utilizes the existing MWRP effluent pumps to deliver tertiary recycled water to the new dechlorination facility prior to its discharge into San Diego Creek through the existing 24-inch stormwater pump station outlet pipeline. Initial operational testing of the diversion system was completed in February 2020 by diverting tertiary effluent back to the MWRP headworks. The District has agreed to perform additional operational testing in the coming months to demonstrate system compliance to the Regional Board including a final test diversion to the San Diego Creek.

HDR completed the design in September 2018. PCL was awarded the construction contract on December 11, 2018, mobilized in February 2019 and completed construction of all improvements on February 20, 2020. There were four contract change orders with PCL for a total cost of \$146,709.64 or 14.95% of the original contract amount as shown in the Contract Change Order Summary provided as Exhibit "A".

#### ENVIRONMENTAL COMPLIANCE:

The IRWD Board of Directors approved the Michelson Water Recycling Plant Final Environmental Impact Report (FEIR) on February 27, 2006. Section 15164 of the CEQA Guidelines provides for the preparation of an addendum to a previously certified EIR if some changes or additions to the project are necessary but none of the conditions described in CEQA call for preparation of a subsequent EIR have occurred. IRWD Board of Directors approved Addendum No. 1 to the FEIR in March 2008, Addendum No. 2 to the FEIR was approved in August 2009, and Addendum No. 3 to the FEIR was approved in June 2010. Addendum No. 4 to the EIR, which evaluated the environmental effects of the emergency recycled water diversion to San Diego Creek, was approved by IRWD's Board on March 26, 2018. ## PELICAN HILL GOLF CLUB SEWER REHABILITATION FINAL ACCEPTANCE

#### **SUMMARY:**

The Pelican Hill Golf Club (PHGC) Sewer Rehabilitation project is complete. IRWD's contractor Sancon Engineering Inc. has completed the required work and all punch list items. The project has received final inspection and acceptance of construction is recommended.

#### BACKGROUND:

Sections of three sewer pipelines that convey sewage flow through the PHGC and an additional pipeline segment within the Pelican Hill Community Homeowners Association were observed having epoxy liner failures, severe material pitting, and calcium accumulation attributed to groundwater infiltration via pipeline cracks.

IRWD retained Psomas to perform analysis of the sewer pipelines within the PHGC and the segment within the Homeowners Association and prepare design plans for the rehabilitation of deficient pipelines using a cured-in-place pipeline.

Psomas completed the design in October 2019, and Sancon Engineering was awarded the construction contract in January 2020. Sancon mobilized during PHGC maintenance course closures beginning in March 2020 and due to closures related to recent state health mandates, was able to accelerate construction efforts and complete the project ahead of schedule. Construction of all improvements were completed on April 9, 2020. During the course of the project, one contract change order was issued, as shown in Exhibit "A".

# REVISED IRWD POLICY PRINCIPLES REGARDING METROPOLITAN WATER DISTRICT'S INTEGRATED WATER RESOURCES PLAN AND LOCAL RESOURCES PROGRAM

#### **SUMMARY:**

Metropolitan Water District is currently updating its Integrated Water Resources Plan (IRP) which will identify new regional targets for local water resource development. These new targets will affect the updating and implementing of Metropolitan's Local Resources Program, which provides incentives to water agencies for the development of water recycling, groundwater recovery, and seawater desalination projects. To help guide IRWD's advocacy efforts related to ongoing policy discussions on Metropolitan's IRP and Local Resources Program, staff presented an updated draft policy position paper to the Board on March 9, 2020. Since that time, staff has continued to revise the position paper based on input provided by the Board. Staff recommends the Board adopt the revised IRP and Local Resources Program policy principles.

# **BACKGROUND:**

In 2004, IRWD began producing policy papers on topics of interest to the District. Because of IRWD's standing in the water industry, the opinion of the District is regularly solicited on issues of vital interest to the industry and the community. To keep these position papers current for explaining IRWD's position, staff occasionally recommends that the Board review the papers and, when appropriate, adopt new policies or incorporate revisions.

Currently, Metropolitan is updating its IRP which will affect the future development of local water supplies in Southern California. Following is an overview of Metropolitan's efforts to update its IRP and Local Resources Program as well as revised IRWD policy principles to help guide associated policy discussions.

# **Integrated Water Resources Plan:**

Metropolitan's IRP establishes a long-term strategy to provide its service area with cost effective and reliable water supplies. The last update to the IRP was in 2015 and the plan is due to be revised again in 2020. The 2015 IRP established goals to achieve additional water use efficiency and conservation, to stabilize and maintain imported water supplies, and to develop additional local water supplies. Metropolitan's new 2020 IRP is expected to identify new regional targets for local water resource development. These new targets will affect the updating and implementation of Metropolitan's Local Resources Program.

# **Local Resources Program:**

Metropolitan provides financial incentives through its Local Resources Program for the development of water recycling, groundwater recovery, and seawater desalination projects that offset a demand, or prevent adding a new demand, on Metropolitan for imported water supplies. Sliding scale payments made through the Local Resources Program are based on actual project unit costs that exceed Metropolitan's prevailing Full-service Tier-1 Treated Water Rates. Local Resources Program incentives are contingent upon the approval of Metropolitan's Board of Directors. Upon completion of the 2020 IRP, Metropolitan is expected to revise the program.

# **Guiding Metropolitan Policy Issues:**

Developing Metropolitan's 2020 IRP and updating its Local Resources Program will require addressing significant policy issues associated with the following:

- An unexpected future where member agencies may collectively require fewer imported water supplies;
- Climate change impacts to an over-allocated Colorado River;
- Uncertainties of a long-term solution to conveyance in the Sacramento-San Joaquin Delta make it difficult to predict Metropolitan's future water supplies;
- Accumulating risks that a major earthquake will occur in the Delta that would dramatically reduce water supplies to Southern California;
- Local groundwater aquifers within Metropolitan's service area could be utilized as another method for storing water;
- Emerging contaminants are impacting local groundwater basins creating short-term and increased dependence on Metropolitan;
- Some member agencies will be "rolling off" of Metropolitan through the development of local supplies;
- The continued development of local supplies could strand capacity in Metropolitan's water treatment facilities; and
- Metropolitan's variable revenue structure may not be effective at covering all of Metropolitan's costs into the future.

#### Revised IRWD Policy Principles:

To help guide IRWD's advocacy efforts related to ongoing policy discussions on Metropolitan's IRP and Local Resources Programs, staff presented an updated policy position paper to the Board on March 9. Since that time, staff has continued to revise the paper based on input provided by the Board. The revised policy paper is provided as Exhibit "A". This policy paper is intended to replace IRWD's existing policy paper on Metropolitan's Local Resources Program that was adopted on September 2018. The existing IRWD policy position paper is provided as

# IRVINE RANCH WATER DISTRICT POLICY POSITION METROPOLITAN WATER DISTRICT'S INTEGRATED WATER RESOURCES PLAN AND LOCAL RESOURCES PROGRAM

May 11, 2020

# Issue Summary:

Metropolitan Water District of Southern California plans for the future through the development and implementation of its Integrated Water Resources Plan (IRP). The purpose of the plan is to formulate a long-term strategy to provide Metropolitan's service area with cost effective and reliable water supplies. The last update to the IRP was in 2015, and Metropolitan plans to revise the plan again in 2020. The 2015 IRP established goals to achieve additional water use efficiency and conservation, to stabilize and maintain imported water supplies, and to develop additional local water supplies. The new 2020 IRP is expected to update these goals and identify new regional targets for local water resource development. These new targets will affect the updating and implementation of Metropolitan's Local Resources Program. There are numerous changing conditions, some of which are described below, that will influence Metropolitan's efforts to update both the IRP and Local Resources Program.

#### Changing Conditions:

Metropolitan has historically implemented a regional approach to planning that has ensured its ability to provide reliable and high-quality water to its member agencies. The ability to continue with this approach into the future is being affected by the following changing conditions:

- An unexpected future where member agencies may collectively require less imported water supplies;
- Climate change impacts to the State Water Project (SWP) and an over-allocated Colorado River;
- Increased environmental constraints and uncertainties of a long-term solution to conveyance in the Sacramento-San Joaquin Delta make it difficult to predict the availability of Metropolitan's future water supplies;
- Accumulating risks that a major earthquake will occur in the Delta that will dramatically reduce water supplies to Southern California;
- Emerging contaminants are impacting local groundwater basins creating short-term, increased dependence on Metropolitan;
- Some member agencies will be reducing dependence on Metropolitan by developing local supplies;
- The development of base-loaded local supplies is stranding capacity in Metropolitan's water treatment facilities and reducing demands for its imported supplies; and
- Metropolitan's variable revenue structure may not be effective at covering all of Metropolitan's costs into the future, creating financial instability.

# Scenario Planning:

IRWD supports Metropolitan's proposed scenario planning approach to the 2020 IRP. Throughout that process, Metropolitan should: (1) protect existing imported water supply infrastructure and deliveries; (2) minimize potential stranding of conveyance, treatment, and storage assets; and (3) carefully evaluate new water supply projects to improve regional water supply reliability.

# Local Resources Program Overview:

In the 1990s, Metropolitan developed the Local Resources Program out of concern that its member agencies were becoming too reliant on imported water supplies and that supply diversification would benefit all of Metropolitan's service area. The intent of the program was to incentivize new local water supplies to be developed by Metropolitan's member agencies. This program has provided incentives to water agencies to develop water recycling, groundwater recovery, and desalination projects that offset a demand or prevent adding a new demand on Metropolitan for imported water supplies. The incentive program has also indirectly increased regional water supply reliability, decreased the burden on Metropolitan's infrastructure, reduced costs, and freed up conveyance capacity in Metropolitan's system.

# Ongoing Policy Discussions:

Currently, Metropolitan and its member agencies are engaged in policy discussions related to how the changing conditions described above will affect the update to Metropolitan's IPR and the Local Resources Program. The Municipal Water District of Orange County is involved in the discussions and seeking input from its member agencies on the issues. To help guide IRWD's advocacy efforts related to the ongoing policy discussions on Metropolitan's IRP and Local Resources Programs, staff has prepared the following policy principles.

# Integrated Resources Plan Policy Principles:

- 1. Metropolitan should continue its regional approach to water resources planning and work to ensure its financial stability while maintaining the ability to provide reliable, cost effective and high-quality water supplies to its member agencies.
- 2. Metropolitan should evaluate previous approaches taken in the preparation of IRPs and develop a new approach that provides flexibility in dealing with current and future conditions and uncertainties.
- 3. Metropolitan's new approach to the 2020 IRP should balance regional and member agency water supply reliability in a way that allows Metropolitan to maintain rate and financial stability.
- 4. Metropolitan's 2020 IRP should encourage member agencies to take responsibility for complying with water conservation legislation and to implement projects that augment Metropolitan supplies during major droughts and supply interruptions.

- 5. To reduce risks to its imported supplies, Metropolitan should invest in the proposed Delta Conveyance Project, support subsidence related repairs to the California Aqueduct, and develop new innovative programs on the Colorado River.
- 6. Metropolitan should take actions to stabilize demands for its imported supplies to help maintain rate and financial stability.
- 7. Should Metropolitan be unable to maintain financial stability, it should consider enhancing its variable revenue structure with a fixed rate component that ensures it can cover its full cost of regional service.
- 8. Metropolitan should anticipate future reductions in its imported supplies and plan cost effective and timely regional recycled and other water supply projects.
- 9. In preparing its 2020 IRP, Metropolitan should consider the feasibility, risk and ease of implementation of local supply projects when accounting for the potential benefits of the projects on regional water supply reliability.

# **Local Resources Plan Policy Principles:**

- 1. Metropolitan should consider limiting use of its Local Resources Program until average annual demands for water from Metropolitan have increased to levels that reduce risk to its financial stability.
- 2. Metropolitan should discourage base-loaded local projects and other supplies that strand capacity in Metropolitan's water treatment facilities and increase risk to rate and financial stability.
- 3. Metropolitan should incentivize local projects that provide extraordinary and other supplies that augment Metropolitan supplies during major droughts and supply interruptions. Metropolitan should also take an active role in ensuring that state mandates do not discourage the use of supplies from such projects.
- 4. Metropolitan should prioritize providing its incentives to local projects located in areas of that have less access to local supplies, such as South Orange County and northern portions of Metropolitan's service area.
- 5. Metropolitan should not provide incentives for local projects that result in the local communities subsidizing other areas of Metropolitan's service area.
- 6. To increase demands for its supplies, Metropolitan should consider reallocating Local Resource Program funds to reduce overdraft in groundwater basins within Metropolitan's service area.
- 7. Metropolitan should only consider providing incentives to local groundwater treatment projects up to the lowest cost and effective treatment of regulated constituents impacting the supplies.

# IRVINE RANCH WATER DISTRICT POLICY POSITION UPDATES TO METROPOLITAN WATER DISTRICT'S LOCAL RESOURCES PROGRAM

# September 10, 2018

# **Issue Summary:**

Metropolitan Water District of Southern California (Metropolitan) encourages the development of local water resources in its service area through the implementation of the Local Resources Program (LRP). This program provides incentives to water agencies for the development of water recycling, groundwater recovery and seawater desalination projects that offset a demand or prevent adding a new demand on Metropolitan for imported water supplies. The development of local water supplies is seen by Metropolitan as a way to reduce the need to increase imported water supplies. The incentive program also indirectly increases regional water supply reliability, decreases the burden on Metropolitan's infrastructure, reduces costs and frees up conveyance capacity in Metropolitan's system.

Metropolitan is considering making revisions to its Local Resources Program to deal with both near-term and long-term policy issues that are interrelated to its Integrated Resources Plan. The Municipal Water District of Orange County is engaged with Metropolitan in the policy discussions and seeking input from its member agencies on the issues. To help guide IRWD's advocacy efforts related to the ongoing LRP discussions, staff has prepared this Policy Position Paper.

# Background:

In 2014, Metropolitan issued guidelines for agencies to use when applying for LRP incentives for water recycling, groundwater recovery, and seawater desalination projects. These guidelines provide details on the program, general requirements and the application process. In July 2017, Metropolitan adopted policy principles that guide Metropolitan's role in regional implementation of Integrated Water Resources Plan targets for local resources. These principles identify that Metropolitan should have multiple approaches for developing local resources in cooperation with other agencies. To date, the LRP program remains the primary method that Metropolitan utilizes to encourage local water resource development.

Currently, Metropolitan offers three LRP incentive payment structures for the development of water recycling, groundwater recovery, and seawater desalination projects. The three options are described as follows:

Option 1: Sliding scale incentives up to \$340 per acre-foot over 25 years;

Option 2: Sliding scale incentives up to \$475 per acre-foot over 15 years; or

Option 3: Fixed incentives up to \$305 per acre-foot over 25 years.

Sliding scale payments are based on actual project unit costs that exceed Metropolitan's prevailing Full Service Tier-1 Treated Water Rate. Fixed incentives are negotiated such that Metropolitan's maximum obligation would not exceed 90% of Metropolitan's commitment to provide funding under Option 1. LRP incentives remain contingent upon the approval of the Metropolitan Board of Directors.

There are numerous opportunities that are available to Metropolitan to update its LRP and to develop new approaches to encourage local resource development. The following policy

principles provide a basis for IRWD's advocacy for making such improvements and for developing new approaches.

# **Policy Principles:**

- 1. Metropolitan should consider the needs of its member agencies in implementing incentive programs other than the LRP to encourage water supply projects located both in and outside of Metropolitan's service area that improve the water supply reliability of Metropolitan and its member agencies.
- 2. Metropolitan should establish criteria for prioritizing LRP incentives to local resource projects in areas with reduced water supply reliability as compared to other areas of Metropolitan's service area (e.g., South Orange County and the northern areas of Metropolitan's service area). Such criteria should ensure regional supply benefits while addressing local supply reliability issues.
- 3. LRP funding should not be provided to projects that result in local communities subsidizing other areas of Metropolitan's service area. Such reverse subsidization occurs whenever LRP incentives are unable, within a short period of time, to bring the cost of water down to the Full Service Tier-1 Treated Rate offered by Metropolitan.
- 4. LRP funding should not result in significant impacts to Metropolitan treatment facilities. Any such impacts should be justified through an actual improvement in local agency water supply reliability rather than just simply replacing one supply for another.
- 5. LRP funding should also be offered to agencies for projects that will result in reductions in demands for untreated water from Metropolitan with incentives being provided down to the cost of Full Service Tier-1 Untreated Rate offered by Metropolitan such as recycled water storage projects.
- 6. Metropolitan should index its LRP incentives to inflation to improve the feasibility and life cycle costs of local resource projects.
- 7. Metropolitan should expand the LRP or develop other incentives programs to encourage storm water and urban runoff capture and reuse projects that do not result in reductions in supplies to others.
- 8. A new incentive program should be implemented by Metropolitan that promotes development of extraordinary supplies from projects located outside Metropolitan's service area. Such projects can reduce Metropolitan's need to improve the reliability of its imported supplies by augmenting supplies during periods of droughts, emergencies and water supply allocations. Metropolitan incentives would be paid at the time water from such a project is imported to Metropolitan's service area for use by the local agency.
- 9. Incentives should be provided to fund large "on-site" reuse projects that defer or avoid Metropolitan's capital and/or operational costs. Such incentives could be provided to

customers such as large-scale industrial facilities where the feasibility of implementing onsite reuse projects depends on receiving incentive funding.

10. Metropolitan should provide LRP incentives to desalination projects through separate funding initiatives that do not impair the ability of non-desalination related local projects to receive funding under existing Metropolitan limits for LRP investments.
