#### RESOLUTION OF THE BOARD OF DIRECTORS OF IRVINE RANCH WATER DISTRICT COMMENDING THE HONORABLE JOHN M. W. MOORLACH FOR AUTHORING SENATE BILL 1386

WHEREAS, Senator John M. W. Moorlach has served the Orange County community well over his distinguished career in public service, serving as the Orange County Treasurer-Tax Collector from 1995 to 2006, representing the 2<sup>nd</sup> District on the Orange County Board of Supervisors from 2006 to 2015, and representing the 37<sup>th</sup> District in the California State Senate since 2015; and

WHEREAS, he has been a Certified Public Accountant since 1978, and has provided important insights and leadership on matters of public finance throughout his career in public service; and

WHEREAS, he represents the residents and communities within the service area of the Irvine Ranch Water District in the California State Senate, and has been a champion of the senatorial district that he represents in the California Legislature; and

WHEREAS, when he learned that the Irvine Ranch Water District and 80 other local governments were sued to challenge the long-standing method of funding the water service and that these lawsuits threaten to force all of California's public retail water service providers to charge fire protection agencies directly for property-related water costs, he understood the principles of infrastructure financing that were involved and stepped forward to author SB 1386 to address the issue; and

WHEREAS, Senator Moorlach and his staff in the California State Senate successfully shepherded this legislation through the Legislature, and secured the governor's signature, in the face of unprecedented challenges as the Legislature adapted to considerable limitations resulting from COVID-19; and

WHEREAS, his efforts to see this legislation signed into law are important to ensuring adequate funding to cover the costs of water service that aids in extinguishing fires that threaten property;

NOW, THEREFORE, BE IT RESOLVED, THAT the Board of Directors of the Irvine Ranch Water District wishes to commend and express its sincere appreciation to Senator John M. W. ### ASSET MANAGEMENT CAPITAL IMPROVEMENT PROGRAM CONSULTANT SELECTION

Using a PowerPoint presentation, Principal Engineer Akiyoshi reported that the Asset Management Capital Improvement Program (CIP) will provide a comprehensive approach for planning capital replacement and rehabilitation (R&R) projects. IRWD currently plans for R&R projects through individual studies, regular operational capital project meetings between Engineering and Operations teams, and updates to the Water Resources, Sewer Treatment, and Sewage Collection Master Plans. Mr. Akiyoshi said that staff anticipates implementing the Asset Management CIP in multiple phases to consolidate capital-related R&R project planning. This will optimize efficiencies, coordination, timing, and financing of capital-related R&R improvements for vertical and linear facilities.

Mr. Akiyoshi said that Phase 1 of the program focuses on developing a five-year risk-based prioritized CIP for pump stations, lift stations, tanks, and wells. The scope of work includes a desktop condition assessment, ranking facilities based on likelihood of failure, developing consequences of failure and levels of service expectations, calculating facilities' remaining useful lives, estimating replacement costs, and producing a five-year prioritized CIP project list.

Mr. Akiyoshi said that staff invited seven consultants to propose on the project and received proposals from five consultants: Black and Veatch, Kennedy Jenks, HDR, GHD, and Brown and Caldwell. Based on team experience, displaying innovative ideas for proposed tools, and articulating a clear approach to risk assessment, three consultants: Black and Veatch, Kennedy Jenks, and HDR were selected for interviews. All the firms presented qualified teams and well-thought-out approaches to the project and scope of work. He said that while all the teams were well qualified, Black and Veatch presented a well-balanced team, clear project approach, and excellent understanding that meets IRWD's goals and objectives for this project.

Following discussion, Director Reinhart said that this item was reviewed and approved by the Engineering and Operations Committee on September 15, 2020. On <u>MOTION</u> by Reinhart, seconded by Swan and unanimously carried by a roll call vote (5-0) Withers, Matheis, Reinhart, Swan, and LaMar voting aye, and 0 noes, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH BLACK & VEATCH IN THE AMOUNT OF \$423,281 AND APPROVED THE ADDITION OF PROJECTS 11686, 11687, AND 11688, EACH IN THE AMOUNT OF \$225,500 FOR A TOTAL OF \$676,500, TO THE FISCAL YEAR 2020-21 CAPITAL BUDGET FOR THE ASSET MANAGEMENT CAPITAL IMPROVEMENT PROGRAM PROJECT.

#### ASSOCIATION OF CALIFORNIA WATER AGENCIES 2021 LEGISLATIVE PLANNING

Government Relations Officer/Deputy General Counsel Compton reported that each year ACWA's State Legislative Committee solicits legislative proposals from ACWA members, which it considers at its Annual Planning Meeting held in the fall. The ACWA State Legislative Committee will meet on October 30, 2020, to prepare for the first year of the 2021-2022 State Legislative Session.

Ms. Compton said that water agencies currently have no means of proactively seeking a court judgment that their rates and charges are legal and comply with the requirements of Proposition 218 and other laws. For certain local agency actions, existing law provides that a local agency may file a validation action – a lawsuit filed in Superior Court seeking a finding that a certain action is legal. She said that the potential legislative concept, which was prepared by staff and is provided as an exhibit seeks to provide that same validation action option to retail water suppliers for property-related water, wastewater, and sewer fees and charges. If retail water suppliers had the option of filing a validation action, a water supplier could have avoided future challenges to its rates years after they had been set and collected because a court would have already reviewed them and ruled of their legality.

Ms. Compton said that due to timing, this item was not reviewed by a Committee. In response to Director Swan's inquiry, Legal Counsel Collins explained the validation process to the Board. Following discussion, on <u>MOTION</u> by LaMar, seconded by Reinhart, and unanimously carried by a roll call vote (5-0) Withers, Matheis, Reinhart, Swan, and LaMar voting aye, and 0 noes, THE BOARD AUTHORIZED STAFF TO SUBMIT THE LEGISLATIVE PROPOSAL TO THE ASSOCIATION OF CALIFORNIA WATER AGENCIES LEGISLATIVE BEFORE THE OCTOBER 2, 2020, DEADLINE FOR CONSIDERATION AS AN ACWA-SPONSORED LEGISLATION AND THAT THE BOARD ADOPT A "SUPPORT" POSITION ON THE CONCEPT PUT FORTH IN THE LEGISLATIVE PROPOSAL FORM.

#### GENERAL MANAGER'S REPORT

General Manager Cook reported that there is one new case of an employee with COVID-19, and that of the other five previous cases all employees have returned to work.

He further said that he just received word that the Governor signed AB 1386 (Moorlach), which the District is supporting that specifies that fire hydrants are part of the system of public improvements included in the definition of water for purposes of Proposition 218.

Director Swan reported that he attended several meetings including a WACO Planning meeting, a Southern California Dialogue meeting, Newport Chamber of Commerce meetings, a Kern Fan Project meeting, and MWDOC Board and Committee meetings. He further asked that the General Manager provide a detailed project cost updates for the Syphon Reservoir.

Director LaMar reported on his attendance at ACWA meetings, a South Orange County Water Agencies meeting, a Natural Communities Coalition meeting, and a Scripps Water Advisory group meeting.

Director Reinhart reported on his attendance at OCWD and MWDOC Board and Committee meetings, and a South Orange County Water Agencies meeting.

Director Matheis said that she attended her general meetings, a Santiago Aqueduct Commissioners' Quarterly meeting, and MWDOC meetings.

#### CONSENT CALENDAR

### 2020 LEGISLATIVE AND REGULATORY UPDATE

#### SUMMARY:

This report provides an update on the 2019-2020 legislative session and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate. Staff recommends that the Board receive and file the report.

#### **BACKGROUND:**

During the 20219-2020 legislative session, 3,374 Assembly bills and 1,474 Senate bills were introduced. At the end of 2020 legislative year, a number of bills were passed and sent to the Governor. Governor Newsom had until midnight on September 30, 2020, to sign or veto bills sent to him at the end of session. Unless a signed bill contained an urgency measure or language delaying its effective date, the bill will take effect on January 1, 2020.

The State Legislature will reconvene to begin the 2021-2022 legislative session on December 7, 2020, unless a special session is called.

A copy of the 2020 Legislative Matrix is provided as Exhibit "A". Links to the bills discussed below are included within each discussion, unless a separate exhibit is noted.

#### 2020 State Legislative Update:

Staff has provided an update on the bills, which were still awaiting action by the Governor as of the last update provided to the Board on September 14, 2020. A status report on each bill is provided below, as of the writing of the staff report. Staff provided an oral update on the Governor's final action of each of these bills to the Water Resources Policy and Communications Committee on October 1.

# ELECTION OF THE INDEPENDENT SPECIAL DISTRICTS OF ORANGE COUNTY 2021-2022 OFFICERS

# SUMMARY:

Last month, the Independent Special Districts of Orange County (ISDOC) sought candidates to serve as the association's officers and on its Executive Committee for the 2021-2022 term. The deadline for candidate nominations was September 11, 2020. ISDOC received only one nomination for the offices of First Vice President, Second Vice President, Third Vice President, Secretary and Treasurer. Pursuant to the ISDOC bylaws, the one candidate nominated for those offices will serve in those offices for the 2021-2022 term. For the offices of President, ISDOC received multiple nominations and, as a result, has called an election for that office. Each ISDOC Member District is entitled to participate in the election and ballots are due to ISDOC by October 23, 2020. Staff recommends the Board review the candidates for the ISDOC offices, and authorize IRWD to cast its ballot in favor of Mark Monin (El Toro Water District) for President and authorize the District to submit its ballot to ISDOC no later than the October 23, 2020, deadline.

# BACKGROUND:

ISDOC is a membership association of Orange County's 27 independent special districts. Its purpose is to advance the interests of Orange County special districts through advocacy of sound public policy, educational opportunities to enhance special district governance and services, and collaboration with others to elevate awareness of the role of special districts. ISDOC does not have any responsibility for the Orange County Special Districts Selection Committee, which is a separate and unrelated entity.

ISDOC has sought nomination of candidates interested in serving as ISDOC officers and on its Executive Committee for the 2021-2020 term. The ISDOC Executive Committee determines the direction and focus of ISDOC. The Executive Committee is comprised of the ISDOC President, First Vice President, Second Vice President, Third Vice President, Secretary, Treasurer and the Immediate Past President. The responsibilities of each office are as follows:

- <u>*President:*</u> The President is the chief executive officer of ISDOC. He or she presides at all meetings of the Board of Directors and the Executive Committee, appoints all committees and represents ISDOC as its official spokesperson;
- *First Vice President*: The First Vice President chairs the Program Committee, and in the absence of the President, serves as the President;
- <u>Second Vice President:</u> The Second Vice President chairs the Membership Committee, and in the absence of the President and First Vice President, serves as the President;

- <u>*Third Vice President:*</u> The Third Vice President chairs the Legislative Committee, and in the absence of the President, First Vice President and Second Vice President, serves as the President;
- <u>Secretary:</u> The Secretary is responsible for all correspondence and the dissemination of information to members. The Secretary prepares and distributes agendas and minutes for the Executive Committee meeting and edits and publishes the quarterly newsletter; and
- <u>*Treasurer*</u>: The Treasurer maintains ISDOC financial records and bank accounts, collects dues and other receipts, and pays all bills duly approved by the Executive Committee.

# ISDOC Election Process:



# 3.7 MG ZONE 1 RESERVOIR FINAL ACCEPTANCE

# SUMMARY:

The 3.7 Million Gallon (MG) Zone 1 Reservoir project is complete. IRWD's contractor Pacific Hydrotech Corporation completed the required work and all punch list items. The project has received final inspection and acceptance of construction is recommended.

# **BACKGROUND:**

IRWD currently operates a 15-million-gallon domestic water reservoir located off Sand Canyon Avenue between Trabuco Road and Elysian. This reservoir serves as the primary storage for the Zone 1 domestic water system and as the forebay for the onsite East Irvine Zone 1 to 3 and South County emergency booster pump stations. The project includes construction of a new 3.7 MG aboveground prestressed concrete reservoir, which will increase the overall domestic water storage in the Zone 1 system and will provide greater operational flexibility and storage redundancy in IRWD's largest domestic water service area.

Staff completed the design in May 2018, and Pacific Hydrotech Corporation was awarded the construction contract on June 26, 2018. Pacific Hydrotech Corporation completed construction of all improvements on October 7, 2020. A summary of construction change orders is provided as Exhibit "A".

Project 06401 is included in the FY 2020-21 Capital Budget. The existing budget is sufficient to fund the final payment for the project.

# ENVIRONMENTAL COMPLIANCE:

This project is subject to the California Environmental Quality Act (CEQA) and in conformance with California Code of Regulations Title 14, Chapter 3, Article 6, a Notice of Intent to adopt a Mitigated Negative Declaration was filed with the County of Orange on January 18, 2018. Pursuant to State Guideline § 15073, the Initial Study/Mitigated Negative Declaration (IS/MND) was made available for public review for a period of 30 days from January 18, 2018 through February 16, 2018. #### **REVISED IRWD POLICY PRINCIPLES REGARDING PFAS CONTAMINANTS**

#### SUMMARY:

IRWD policy position papers are reviewed periodically to determine if the positions are still valid, need to be revised, or if new papers should be written on other issues. Staff has updated the IRWD policy position paper pertaining to issues associated with per-and polyfluoroalkyl substances, also known as PFAS. At high enough concentrations, these contaminants can pose threats to human health. The policy paper has been revised to reflect current conditions and the status of regulations being developed that will likely have impacts on IRWD as well as water and sanitation agencies throughout Orange County and the United States. Staff recommends that the Board adopt the revised IRWD's Policy Principles Regarding PFAS Contaminants dated October 12, 2020.

#### **BACKGROUND:**

In 2004, IRWD began producing policy papers on topics of particular interest to IRWD. Because of IRWD's standing in the water industry, its position is regularly solicited on issues of vital interest to the industry and the community. In order to keep these position papers current and germane, staff occasionally recommends that the Board review the papers and, when appropriate, incorporate revisions or adopt new papers.

PFAS compounds have emerged recently as "contaminants of concern" primarily due to human health impacts. These compounds are often referred to as "forever chemicals" because they decompose very slowly and can therefore accumulate in the environment and in humans. While there are many sources that can expose humans to PFAS (dust in the air, food packaging material, clothing, etc.), state and federal regulators are now acting to limit the amount of PFAS contaminants in drinking water supplies.

In September 2019, the IRWD Board of Directors adopted a Policy Position Regarding PFAS Contaminants. IRWD's policy position supports advocacy, both legislative and regulatory, to promote science-based regulations and appropriate timelines for implementing treatment solutions. The District's policy position also provides clarity as to how IRWD has modified its operations, and how IRWD suggest Orange County Water District should work with all Groundwater Producer Agencies to develop and implement solutions to what appears to be a groundwater basin-wide problem.

Staff has prepared a revised draft IRWD Policy Position Paper Regarding PFAS Contaminants to reflect current conditions and the status of regulations being developed that will likely have impacts on IRWD as well as water and sanitation agencies throughout Orange County and the United States. The revisions made to the draft policy paper are shown as redline changes in Exhibit "A". A clean version of the paper is provided as Exhibit "B".

## IRWD POLICY POSITION REGARDING PFAS CONTAMINANTS SEPTEMBER 30, 2019OCTOBER 12, 2020

#### Issue Summary:

The policy issues associated with the cleanup of what are often referred to as "PFAS compounds" in the Orange County Groundwater Basin (Basin), both prior to and after the establishment of regulatory limits in drinking water, are complex and likely to be controversial. To help guide IRWD's advocacy efforts related legislative and regulatory efforts, as well as issues of concern to IRWD services and the cleanup of PFAS compounds that have been found in the Basin, this paper reflects the policy position adopted by the IRWD Board.

#### Background on PFAS Contaminants:

In 2012, the United States Environmental Protection Agency (EPA) issued rules which required monitoring for 30 added contaminants by public water systems across the United States. Perfluorooctanic acid (PFOA) and perfluorooctane sulfonate (PFOS) were included on the list for monitoring. These compounds are organic chemicals that are part of a larger group of manmade chemicals referred to as per-and polyfluoroalkyl substances (PFAS). These substances, sometimes referred to as "forever chemicals," are persistent in the environment while being generally resistant to heat, water, and oil. They have been widely used in consumer products such as carpet, clothing, fabrics for furniture, paper packaging for food, fire-fighting foams, and other materials (e.g., cookware) designed to be waterproof, stain-resistant, or non-stick.

Between 2013 and 2015, OCWD tested water from the Basin consistent with EPA requirements. The results of the tests were submitted to the EPA and the State Water Resources Control Board Division of Drinking Water (DDW). In July 2018, DDW established precautionary advisory levels for PFOA and PFOS.

#### Precautionary Advisory Levels:

Notification Levels are precautionary health-based advisory levels established by DDW for chemicals in drinking water that are not regulated by Maximum Contaminant Levels (MCLs). State law requires timely notification to local jurisdictional authorities by a retail water system whenever a Notification Level is exceeded in drinking water. DDW recommends that public water systems take a source of water out of service if a contaminant is present at concentrations considerably higher than the Notification Levels. The level prompting such recommendations is called the "Response Level".

Notification and Response Levels have no binding effect on a public water system's ability to serve water to customers. Because of public perception issues associated with continuing to serve water that contains PFOA and PFOS at concentrations above the Response Levels, the thresholds can be interpreted by some entities as "de facto MCLs."

## Maximum Contaminant Levels:

MCLs are standards that are set by the EPA and some states for drinking water quality. MCLs serve as legal threshold limits on the amount of a substance that is allowed in a potable water supply. The EPA is moving forward with developing MCLs for PFOA and PFOS. The State of

California has taken the first step in the MCL development process by requesting that the Office of Environmental Health Hazard Assessment (OEHHA) develop Public Health Goals for PFOA and PFOS. In general, the federal or state MCL process takes at least three years to complete sexpected to soon initiate a parallel process to establish its own enforceable limits. Until either federal or state MCLs are set for PFOA and PFOS, there are no legal requirements for a public water system to blend, treat or take an affected water source out of production.

## Contaminants Could Become a Widespread Problem:

In April 2019, monitoring orders were sent by DDW to public water systems across California including IRWD and 11 other Orange County Groundwater Producers (Producers). In response to the orders, OCWD implemented a sampling and analysis program that identified that PFOA and PFOS contaminants exist in a substantial portion of the Basin.

In August 2019, DDW released new lower Notification Levels for PFOA and PFOS, and DDW also requested that OEHHA evaluate seven other PFAS compounds to determine if Notification Levels are appropriate<sup>1</sup>. In February 2020, DDW released and is expected to release lower Response Levels, which by the end of 2019. These lowered Response Levels have impacted are expected to influence the decisions of numerous Producers to the operation of (or to not operate) approximately 704 Producer wells. Additional Producers are at risk if the contaminants continue to migrate through the Basin. A migration would likely reduce many other Producers' ability to rely on groundwater.

# OCWD and Groundwater Basin Considerations:

OCWD has recently initiated is conducting pilot studies to evaluate various treatment processes that might be effective at removing PFOA and PFOS from groundwater recovered from the Basin. In addition, OCWD has initiated efforts to study studying how treatment facilities canould be integrated into Producer potable water production distribution systems that are affected by the contaminants. As part of these ongoing efforts, OCWD has is expected to developed and implemented a policy on how the costs of the design, construction, operation and maintenance (O&M) of treatment facilities might will be allocated to OCWD and the affected Producers. In developing its policy, OCWD will need to consider equity issues associated with other contaminants that exist in the Basin that have either been avoided or that are currently being cleaned up from the Basin. Agreements based on this policy have been executed between many of the affected Producers and OCWD. These agreements will facilitate the design, construction and operation of PFAS treatment facilities.

BEA Exemptions Should Be Considered:

OCWD District Act gives OCWD the power to enter into a contract with a Groundwater Producer to encourage the Producer to increase production of groundwater in lieu of using imported water for the purpose of removing contaminants from the Basin. The corresponding treatment facilities are commonly referred to as Basin Equity Assessment (BEA) exempt projects. In practice, a Producer that operates such facilities is annually credited pro-rated capital and actual O&M costs associated with the treatment facilities. The credits are used to offset BEA payments owed by the Producer for pumping above the OCWD Basin Production Percentage (BPP). Providing BEA exemptions to PFOA and PFOS treatment projects would not be applicable to Producers that would use such a project to treat groundwater extracted under the BPP. Where Producer agencies have enough well capacity to pump unimpaired water up toabove the BPP, the implementation of BEA exempt project might be useful for removing PFOA and PFOS from the Basin.

## Raising BPP Should Be Avoided:

If, in response to DDW Response Levels or future MCLs, the Producers affected by the PFOA and PFOS contaminants choose to take their wells out of service, then OCWD could financially be affected through reduced Replenishment Assessment (RA) revenue. If OCWD were to increase the BPP in response to these financial impacts, then the Producers that operate BEA-exempt projects would be financially impacted. This is an important issue and OCWD should avoid raising the BPP in response to wells being shut down due to the presence of PFOA and PFOS contaminants.

#### **IRWD Policy Principles:**

To help guide IRWD's advocacy efforts related to PFAS contaminants, the following policy position principles have been assembled. These principles provide guidance on issues related to legislative and regulatory action, IRWD services, and the Orange County Groundwater Basin.

## State and Federal Legislative and Regulatory Issues:

- 1. Public health and environmental standards should be developed that are based on science and a comprehensive understanding of the risk that PFAS contaminants pose to public health and the environment;
- 2. State and federal agencies should hold PFAS producers ultimately liable for cleanup costs. Additionally, regulators should ban the importation of PFAS containing products that can result in further environmental contamination;
- 3. Regulations should focus on the most persistent PFAS compounds that pose the greatest human health risk and sources that produce the highest levels of exposure;
- 4. Federal MCLs for PFOA and PFOS should be established in a timely manner in accordance with the established regulatory processes under the Safe Drinking Water Act;

- 5. If PFAS is designated as hazardous substance under CERCLA, then wastewater and water utilities must be exempted from liability because water and wastewater utilities do not produce or create PFAS they only receive PFAS in the water and wastewater they treat; and
- 6. Federal financial assistance should be provided through the EPA's Drinking Water State Revolving Fund and other programs to communities that are forced to address contaminated water supplies.
- 7. The federal government shall take responsibility for PFAS contamination associated with the many active and closed military bases under its jurisdiction.

## IRWD Service Issues:

- 1. IRWD elects not to produce water from any source for its potable water system that contains unacceptable levels of PFOA and PFOS unless an effective water treatment system is in place to remove these contaminants;
- 2. IRWD will look for opportunities to collaborate with other Producer agencies to develop mutually beneficial joint PFOA and PFOS removal facilities; and
- IRWD will establish a policy position on the impacts of PFAS in recycled water or residual biosolids materials once the regulations for these products are promulgated. <u>Until</u> <u>such time, IRWD will not use sources of recycled water that increase the concentrations</u> <u>of PFAS in the recycled water produced at MWRP or LAWRP.</u>

#### Orange County Groundwater Basin Issues:

- 1. OCWD should establish a policy for the removal of PFOA and PFOS contaminants in the Basin that takes into consideration regulatory recommendations and requirements, equity issues associated with other contaminants in the Basin, protection of the use of BEA-exempt projects to clean up other contaminants, and the need to stop the migration of the contaminants before they impact additional Producers' wells;
- 2. IRWD supports OCWD treatment pilot studies to evaluate various treatment processes to cost-effectively remove PFOA and PFOS from groundwater recovered from the Basin. Viable treatment systems must consider the ultimate fate of these contaminants rather than shifting them to another environmental media;
- 3. Until the MCLs are established or the RLs are significantly reduced for PFOA and PFOS, IRWD does not support the final design, construction and operation of treatment facilities that would result in costs being assessed through the RA to the Producers;
- 4. Once MCLs are established or RLs are significantly reduced for PFOA and PFOS, OCWD should work with Producers to implement BEA-exempt projects where possible to remove the contaminants;

- 5. Where use of BEA-exempt projects is not possible, OCWD should develop and fund the design, construction and operation of treatment facilities that can be integrated into a Producer's retail water system;
- 6. Producers affected by the PFOA and PFOS contaminants should pay for a portion if not all the O&M costs associated with the treatment of groundwater delivered through their potable water system. Producers should remain responsible for cost to convey and pump treated groundwater into their distribution systems;
- 7. OCWD should pursue avenues to obtain reimbursement for the design, construction, and operation of treatment facilities to remove PFAS contaminants from the Basin from the companies that produced PFOA and PFOS;
- 8. OCWD should support efforts to implement upstream source control including the funding, design, construction, and operation of treatment processes to remove PFOA and PFOS from sewage treatment plant effluent that is discharged upstream into the Santa Ana River where feasible;
- 9. To ensure that no area of the Basin is unfairly impacted by recharge of Santa Ana River water that has concentrations of PFOA and PFOS, OCWD should strategically balance among its facilities (including the Santiago Basins) the recharge of imported water and water produced from the Groundwater Replenishment System; and
- 11.10. OCWD should not pay for a Producer's alternative source of imported water. In addition, OCWD should not pay for temporary PFAS treatment and conveyance facilities if a Producer elects to incur these costs, unless the temporary facilities are incorporated into the permanent solution that is acceptable to OCWD.
- 12. OCWD should not impair the use of existing BEA-exempt projects that clean up other contaminants from the Basin by raising the BPP.

## Contaminants Could Become a Widespread Problem:

In April 2019, monitoring orders were sent by DDW to public water systems across California including IRWD and 11 other Orange County Groundwater Producers (Producers). In response to the orders, OCWD implemented a sampling and analysis program that identified that PFOA and PFOS contaminants exist in a substantial portion of the Basin.

In August 2019, DDW released new lower Notification Levels for PFOA and PFOS, and DDW also requested that OEHHA evaluate seven other PFAS compounds to determine if Notification Levels are appropriate<sup>1</sup>. In February 2020, DDW released lower Response Levels, which have impacted the operation of approximately 70 Producer wells. Additional Producers are at risk if the contaminants continue to migrate through the Basin. A migration would likely reduce many other Producers' ability to rely on groundwater.

## OCWD and Groundwater Basin Considerations:

OCWD is conducting pilot studies to evaluate various treatment processes that might be effective at removing PFOA and PFOS from groundwater recovered from the Basin. In addition, OCWD is studying how treatment facilities can be integrated into Producer potable water production distribution systems that are affected by the contaminants. As part of these ongoing efforts, OCWD has developed and implemented a policy on how the costs of the design, construction, operation and maintenance (O&M) of treatment facilities will be allocated to OCWD and the affected Producers. Agreements based on this policy have been executed between many of the affected Producers and OCWD. These agreements will facilitate the design, construction and operation of PFAS treatment facilities.

## BEA Exemptions Should Be Considered:

OCWD District Act gives OCWD the power to enter into a contract with a Groundwater Producer to encourage the Producer to increase production of groundwater in lieu of using imported water for the purpose of removing contaminants from the Basin. The corresponding treatment facilities are commonly referred to as Basin Equity Assessment (BEA) exempt projects. In practice, a Producer that operates such facilities is annually credited pro-rated capital and actual O&M costs associated with the treatment facilities. The credits are used to offset BEA payments owed by the Producer for pumping above the OCWD Basin Production

Percentage (BPP). Providing BEA exemptions to PFOA and PFOS treatment projects would not be applicable to Producers that would use such a project to treat groundwater extracted under the BPP. Where Producer agencies have enough well capacity to pump above the BPP, the implementation of BEA exempt project might be useful for removing PFOA and PFOS from the Basin.

## IRWD Policy Principles:

To help guide IRWD's advocacy efforts related to PFAS contaminants, the following policy position principles have been assembled. These principles provide guidance on issues related to legislative and regulatory action, IRWD services, and the Orange County Groundwater Basin.

## State and Federal Legislative and Regulatory Issues:

- 1. Public health and environmental standards should be developed that are based on science and a comprehensive understanding of the risk that PFAS contaminants pose to public health and the environment;
- 2. State and federal agencies should hold PFAS producers ultimately liable for cleanup costs. Additionally, regulators should ban the importation of PFAS containing products that can result in further environmental contamination;
- 3. Regulations should focus on the most persistent PFAS compounds that pose the greatest human health risk and sources that produce the highest levels of exposure;
- 4. Federal MCLs for PFOA and PFOS should be established in a timely manner in accordance with the established regulatory processes under the Safe Drinking Water Act;
- 5. If PFAS is designated as hazardous substance under CERCLA, then wastewater and water utilities must be exempted from liability because water and wastewater utilities do not produce or create PFAS they only receive PFAS in the water and wastewater they treat; and
- 6. Federal financial assistance should be provided through the EPA's Drinking Water State Revolving Fund and other programs to communities that are forced to address contaminated water supplies.
- 7. The federal government shall take responsibility for PFAS contamination associated with the many active and closed military bases under its jurisdiction.

#### IRWD Service Issues:

1. IRWD elects not to produce water from any source for its potable water system that contains unacceptable levels of PFOA and PFOS unless an effective water treatment system is in place to remove these contaminants;

- 2. IRWD will look for opportunities to collaborate with other Producer agencies to develop mutually beneficial joint PFOA and PFOS removal facilities; and
- 3. IRWD will establish a policy position on the impacts of PFAS in recycled water or residual biosolids materials once the regulations for these products are promulgated. Until such time, IRWD will not use sources of recycled water that increase the concentrations of PFAS in the recycled water produced at MWRP or LAWRP.

## Orange County Groundwater Basin Issues:

- 1. OCWD should establish a policy for the removal of PFOA and PFOS contaminants in the Basin that takes into consideration regulatory recommendations and requirements, equity issues associated with other contaminants in the Basin, protection of the use of BEA-exempt projects to clean up other contaminants, and the need to stop the migration of the contaminants before they impact additional Producers' wells;
- 2. IRWD supports OCWD treatment pilot studies to evaluate various treatment processes to cost-effectively remove PFOA and PFOS from groundwater recovered from the Basin. Viable treatment systems must consider the ultimate fate of these contaminants rather than shifting them to another environmental media;
- 3. Until the MCLs are established or the RLs are significantly reduced for PFOA and PFOS, IRWD does not support the final design, construction and operation of treatment facilities that would result in costs being assessed through the RA to the Producers;
- 4. Once MCLs are established for PFOA and PFOS, OCWD should work with Producers to implement BEA-exempt projects where possible to remove the contaminants;
- 5. Where use of BEA-exempt projects is not possible, OCWD should develop and fund the design, construction and operation of treatment facilities that can be integrated into a Producer's retail water system;
- 6. Producers affected by the PFOA and PFOS contaminants should pay for a portion if not all the O&M costs associated with the treatment of groundwater delivered through their potable water system. Producers should remain responsible for cost to convey and pump treated groundwater into their distribution systems;
- 7. OCWD should pursue avenues to obtain reimbursement for the design, construction, and operation of treatment facilities to remove PFAS contaminants from the Basin from the companies that produced PFOA and PFOS;
- 8. OCWD should support efforts to implement upstream source control including the funding, design, construction, and operation of treatment processes to remove PFOA and PFOS from sewage treatment plant effluent that is discharged upstream into the Santa Ana River where feasible;

- 9. To ensure that no area of the Basin is unfairly impacted by recharge of Santa Ana River water that has concentrations of PFOA and PFOS, OCWD should strategically balance among its facilities (including the Santiago Basins) the recharge of imported water and water produced from the Groundwater Replenishment System; and
- 10. OCWD should not pay for a Producer's alternative source of imported water. In addition, OCWD should not pay for temporary PFAS treatment and conveyance facilities if a Producer elects to incur these costs, unless the temporary facilities are incorporated into the permanent solution that is acceptable to OCWD.
