PUBLIC HEARING

2021 REDISTRICTING: COMPOSITION OF REDISTRICTED DIVISIONS, PROPOSED DRAFT DIVISION MAP AND CONSIDERATION OF ADOPTION OF FINAL MAP

SUMMARY:

Every 10 years, local governments with by-division elections must redistrict and redraw their division boundaries using the new census data to reflect how local populations have changed, and to ensure that the divisions are, as far as practicable, equal in population. In California, Elections Code Sections 22000-22002 govern how special districts, such as IRWD, redistrict after each federal decennial census. The IRWD Board of Directors is responsible for approving new division boundaries which, once approved, will become effective for the next election of the IRWD Board of Directors in November 2022.

The Board held a public hearing on December 13, 2021, before the drawing of draft maps of proposed division boundaries. The purposes of that hearing were to invite and solicit public comment on the criteria for, and the composition of, the redistricted divisions, and for the Board of Directors to discuss the criteria to be used by the District in the drawing of proposed Director division boundaries.

A second public hearing was held after the drawing of draft maps. The purpose of the hearing was to invite and solicit public comments on the composition of redistricted divisions and the proposed draft division maps, Draft Map Plan 1 and Draft Map Plan 2, which were published by the District on its website. At the close of the public hearing, the Board authorized staff to agendize at a third public hearing consideration of adoption of a final map of division boundaries based on requested revisions to Draft Map Plan 1.

A third public hearing is now being held after a revised draft map, Draft Map Plan 1A, has been drawn and published on the District's website. The purpose of this hearing is to invite and solicit public comments on the composition of redistricted divisions, the revised draft division map, and the Board's consideration of adoption of a final map.

RECOMMENDED HEARING PROCEDURE:

hearing on the redistricting of the Irvine Ranch Water District Board of Directors Division Boundaries, and to receive public comments on the composition of the redistricted divisions, the revised draft map, and the Board's consideration of adoption of a final map. BACKGROUND:

Prior to 2020, IRWD used an at-large method to elect the members of its Board of Directors. The at-large method allowed for voters from the entire service area to elect each of the five members of the Board of Directors. After undertaking a year-long public process to evaluate moving from an at-large election process to division-based elections, the IRWD Board of Directors voted to transition the election of the IRWD Board of Directors to division-based elections.

A by-division method divides a service area into separate divisions and allows the voters from each division to elect a member of the Board of Directors for that division. In a by-division method of election, the elected individual serves as the division's representative on the Board and must reside in that division. The November 2020 election was the first election in which the IRWD Board of Directors were elected through division-based elections.

Current IRWD Division Map:

On May 13, 2019, the IRWD Board of Directors adopted the current <u>IRWD Division Boundary</u> <u>Map</u>. The Board Members from Divisions 1 and 4 were elected in 2020 and the Board Members from Divisions 2, 3 and 5 will be elected in 2022.

To help the community better understand the divisions and the division in which each village is located, a reference map that has an overlay of the villages located in each division, the <u>Village Reference Map</u>, was made available for the public. The District also made an <u>Interactive Division Map</u> available to the public.

Statutorily Mandated Process for Redistricting:

Every 10 years, local governments with by-division elections must redistrict and redraw their division boundaries using the new census data to reflect how local populations have changed, and to ensure that the divisions are, as far as practicable, equal in population.

Elections Code Sections 22000-22002 govern how special districts like IRWD redistrict after each federal decennial census. That process requires, at a minimum, that a special district hold at least two public hearings to discuss division maps, prior to adopting a final redistricted map. The IRWD Board of Directors is responsible for approving new division boundaries which, once approved, will become effective for the next election of the IRWD Board of Directors in November 2022.

Legally Required Factors Considered When Evaluating Division Boundaries:

While many federal and state laws govern the drawing of division boundaries, the United States Constitution establishes the fundamental principle which governs the drawing of division boundaries. Above all else, the Constitution requires that divisions be equal, or nearly equal, in total population. Federal courts have ruled that this means that the population difference between the most and least populous divisions may not exceed ten percent. California Elections Code section 22000 further states that divisions should be drawn to be, "as far as practicable, equal in population" using the population numbers from the last federal decennial census.

Provided that the equality in population, based on the last decennial census, requirement is met, the Elections Code also requires the revised boundaries comply with Section 10301 of Title 52 of the United States Code, as amended, to the extent those provisions apply.

The Elections Code also allows for consideration of: (1) topography, (2) geography, (3) cohesiveness, contiguity, integrity, and compactness of territory, and (4) communities of interests of the division when determining where division boundaries are placed.

Staff presented proposed criteria for the Board's consideration and for use by the District when redrawing proposed director division boundaries at the first public hearing on December 13, 2021. Staff also provided a summary of the census data on the population characteristics of IRWD's service area, and discussed the criteria proposed to be used as the District redraws the division boundaries. Additionally, staff presented information on how the public could submit additional comments on the composition of possible divisions and how the public could submit conceptual maps for consideration as the potential division area maps are drawn.

Public Comment Period:

Prior to the drawing of potential division maps, the District invited the public to submit additional comments on the composition of possible divisions and to submit conceptual maps for consideration as the potential division area maps are drawn. The deadline to submit these additional comments and conceptual maps was January 6, 2022, at 5:00 p.m. The District received no comments or conceptual maps.

Draft Division Maps:

IRWD conducted a second public hearing on January 24, 2022, to invite and solicit public comment on the draft division maps, which were published by the District on its website: Plan 1 and Plan 2. The staff report, presentation and materials presented to the Board at the second public hearing can be viewed at https://www.irwd.com/images/pdf/about-us/district-election-process/january 24 2022 public hearing materials.pdf.

At the close of the second public hearing, the Board eliminated Plan 2 from consideration and authorized staff to create a Plan 1A, a modification of Plan 1, which would move all of Newport Coast into Division 5. The Board authorized staff to agendize a third public hearing for February 14, 2022, to invite and solicit public comment of the revised draft division map and for the Board to consider adoption of a final map of division boundaries based on requested revisions to Draft Map Plan 1.

The revised draft map, Draft Map 1A, which was published on the District's website more than seven days prior to the third public hearing, is provided as Exhibit "A". Staff will present the revised draft map to the Board for its consideration and possible adoption. The draft PowerPoint presentation is provided as Exhibit "B".

To adopt a final map of redistricted division boundaries based on Draft Map Plan 1A, staff recommends the Board adopt the proposed resolution, provided as Exhibit "C", by title.






DIFFERENCES WITH TARGET DIVISION POPULATION



Irvine Ranch Water District Resolution No. 2019-12, "Resolution Changing the Method of Election of Directors from At-Large to By-Division, and Adopting a Map Establishing Initial Divisions for the Election of Members of the Board of Directors, Division Numbering and the Sequence of Elections," provides that the Board of Directors will consider adjusting its division boundaries following each decennial federal census to assure compliance with all applicable provisions of law.

Elections Code section 22000 requires the Board of Directors to examine division boundaries after each federal decennial census using that census to adjust the boundaries so that the divisions are as equal as possible in population and in compliance with Section 10301 of Title 52 of the United States Code, as amended.

Elections Code section 22000 further authorizes the Board of Directors to give consideration to topography, geography, cohesiveness, contiguity, integrity and compactness of territory as well as communities of interest.

The Board of Directors has conducted duly noticed public hearings with published notice in English, Spanish, Chinese, Farsi and Korean on December 13, 2021 and January 24, 2022 seeking public input on this process. The December 13 public hearing was held prior to the drawing of draft maps and the January 24 hearing was held after draft maps had been drawn and published.

The Board of Directors has conducted a duly noticed public hearing with published notice in English, Spanish, Chinese, Farsi and Korean on this date, February 14, 2022, with the intent to consider adoption of Plan 1A, which was published on the District's website more than seven days prior to the public hearing.

The Board of Directors has determined that Plan 1A adjusts the division boundaries to be as equal as possible in population considering the factors provided in Elections Code section 22000 and that Plan 1A complies with Section 10301 of Title 52 of the United States Code, as amended.

NOW, THEREFORE, the Board of Directors of IRVINE RANCH WATER DISTRICT DOES HEREBY RESOLVE, DETERMINE and ORDER that:

<u>Section 1.</u> The Board of Directors hereby finds the foregoing recitals to be true and correct.

Section 2. The Board of Directors adopts the map identified as Plan 1A, attached hereto as Exhibit "1" and incorporated herein by this reference, as the map setting forth the adjusted Director Divisions to be used commencing with the regularly-scheduled election of November, 2022 for the election of members of the Board of Directors.

<u>Section 3.</u> Pursuant to Elections Code section 22000, the Board of Directors will consider adjustments of the Division boundaries following each decennial federal census to assure compliance with all applicable provisions of law.



BOARD WORKSHOP

CAPITAL IMPROVEMENT PROGRAM ASSET MANAGEMENT

SUMMARY:

IRWD is developing a more proactive approach to capital-focused asset management. The District's Capital Improvement Program (CIP) Asset Management project used risk-based analyses to develop preliminary repair and rehabilitation recommendations for the most critical pump stations, storage tanks, wells, and sewage lift stations. At the Board meeting, staff will present details of the analysis.

BACKGROUND:

Since 1961, IRWD has largely focused on planning based on future growth and development. As the District's facilities mature, there is a growing need for replacement and rehabilitation of existing facilities. Over the past year, an interdepartmental team completed the first phase of IRWD's CIP Asset Management project. The team used a risk-based approach and conducted high-level condition assessments at 158 facilities in the potable, non-potable, and sewage collection systems. The field condition assessments helped identify the Likelihood of Failure and evaluated remaining useful life expectancies at all facilities. Concurrently, a multi-faceted Consequence of Failure analysis looked at social, environmental, and financial factors to identify the most critical pump stations, storage tanks, wells, and sewage lift stations. The Likelihood of Failure and Consequence of Failure analyses helped develop a preliminary list of facilities that will be more closely evaluated for specific repair and rehabilitation projects.

The CIP Asset Management project is a multi-phased program, with Phase 1 focusing on pump stations, lift stations, tanks, and wells, and future phases focusing on pipelines and treatments plants. Phase 1 also developed powerful and sustainable business intelligence (i.e., reporting and data analysis) tools in the Microsoft Power Business Intelligence (BI) environment. Phase 2 will focus on the 3,700 miles of potable, non-potable, and sewage collection pipelines. Subsequent phases will develop approaches for IRWD's potable and recycled water treatment plants.

The project incorporated data from enterprise systems, such as the Geographic Information System (GIS), Replacement Planning Model (RPM), and the Maximo Computer Maintenance and Management System (CMMS). BI and data analytics were created that allowed staff to quickly view results and update facility data as needed. The Microsoft Power BI environment provides for a seamless integration with future phases of the project and sustainability by IRWD staff.

MINUTES OF REGULAR MEETING –JANUARY 24, 2022

The regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 5:00 p.m. by President LaMar on January 24, 2022. Due to the ongoing COVID pandemic and the recent surge in Omicron Variant cases, the Board meeting was held remotely under the provisions of AB 361.

Directors Present: LaMar, Withers, Swan (arrived at 5:12 p.m.), McLaughlin, and Reinhart.

Also Present: General Manager Cook, Executive Director of Technical Services Burton, Executive Director of Operations Chambers, Executive Director of Finance and Administration Clary, Director of Treasury and Risk Management Jacobson, Executive Director of Water Policy Weghorst, Director of Recycling Operations Zepeda, Director of Water Resources Sanchez, Director of Human Resources Mitcham, Director of Water Quality and Regulatory Compliance Colston, Director of Strategic Communications and Advocacy/Deputy General Counsel Compton, Director of Safety and Security Choi, Secretary Bonkowski, Assistant Secretary Swan, General Counsel Collins, Special Legal Counsel DeMayo, Consultant Diep, Special Legal Counsel Robinson, Consultant Newell, and members of the public and other staff.

FORMAT OF IRWD BOARD AND COMMITTEE MEETINGS DURING COVID-19 OMICRON SURGE

With the current omicron-driven surge in COVID-19 cases, General Manager Cook said that staff recommends the Board affirm that meetings of the full Board and the standing Board committees will temporarily be conducted via teleconference following the restrictions and rules outlined in AB 361. On MOTION by Reinhart, seconded by Withers and carried by a roll call vote (4-0) Withers, Reinhart, McLaughlin, and LaMar voting aye, and Swan absent, the following resolution was adopted by title:

PUBLIC HEARINGS

PROPOSED CHANGES TO THE SCHEDULE OF RATES AND CHARGES EFFECTIVE FEBRUARY 1, 2022

Pursuant to the requirements of Proposition 218, a Public Hearing on the rates and charges is required. Director Swan arrived at 5:12 p.m. President LaMar declared this to be the time and place for a hearing on the proposed changes to the rates and charges and asked the Secretary how the hearing was noticed.

Secretary Bonkowski said that the hearing was noticed by mail and presented an affidavit of mailing. On <u>MOTION</u> by Swan, seconded by Withers, and unanimously carried by a roll call vote (5-0) Withers, Reinhart, McLaughlin, Swan and LaMar voting aye, THE AFFIDAVIT OF MAILING BY AN INDEPENDENT PROCESSING FIRM AS PRESENTED BY THE SECRETARY WAS RECEIVED AND FILED.

President LaMar asked Legal Counsel to describe the nature of the proceedings. Legal Counsel Collins said that the public hearing is held, pursuant to Proposition 218, Article XIIID of the Constitution of the State of California, for all persons interested to be heard, to present objections or protests, including any written comments submitted, concerning the increase in property-related rates and charges and any proposed new property-related rates and charges.

President LaMar asked for a staff report from the Executive Director of Finance or her designee on the proposed rates and charges and inquired whether there have been any written communications. Using a PowerPoint presentation, Manager of Strategic Planning and Analysis Smithson reviewed the budget and rate setting calendar, the Proposition 218 notice noting that 116,077 notices were mailed to customers and property owners, and that written protests were directed to be mailed to a separate post office box from the rest of the District's mail and were received by the District's Independent auditors, Davis Farr. Mr. Smithson reviewed the five letters received protesting the increase, which do not meet the 50% +1 protest threshold for preventing rate increases from being adopted.

Mr. Smithson then reviewed the proposed potable water, recycled water, and sewer rates and charges, along with the water shortage contingency plan rates. He further reviewed a typical residential customer bill, rate history, a rate comparison with other water agencies along with a recommendation to adopt the rates effective February 1, 2022.

President LaMar asked whether there was anyone present who wished to address the Board regarding the proposed changes to the rates and charges. No one wished to be heard.

President LaMar asked whether there are any comments or questions from members of the Board of Directors. There were none. Director LaMar closed the public hearing, and on MOTION by Swan, seconded by McLaughlin, unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes, THE HEARING WAS CLOSED, AND THE FOLLOWING RESOLUTION WAS ADOPTED BY TITLE:

RESOLUTION NO. 2022-2

RESOLUTION OF THE BOARD OF DIRECTORS OF IRVINE RANCH WATER DISTRICT ADOPTING CHANGES TO THE SCHEDULE OF RATES AND CHARGES FOR WATER, SEWER AND RECLAIMED WATER SERVICE

<u>2021 REDISTRICTING CRITERIA AND THE COMPOSITION OF REDISTRICTED</u> DIVISIONS

President LaMar declared this to be the time and place for a public hearing on redistricting the Irvine Ranch Water District Board of Directors Division Boundaries, and to receive public comments on the criteria for and the composition of the redistricted divisions and draft maps. He asked the Board Secretary how the hearing was noticed.

Secretary Bonkowski said that the public hearing was noticed by publication in the *Orange County Register* on January 9 and January 16, 2022; by publication in Spanish in the *Excelsior Unidos* on January 7 and January 14, 2022; by publication in Korean in the *Korea Times* on January 7 and January 14, 2022; by publication in Traditional Chinese in the *World Journal* on January 9 and January 16, 2022; by publication in Farsi in *Hafteh Bazaar* on January 7 and January 14, 2022; by electronic posting in English, Farsi, Korean, Traditional Chinese, and Spanish on the IRWD website, which can be translated into approximately 20 languages; and by physical posting at IRWD's headquarters. She presented the affidavits of posting and proof of publication to the Board related to the hearing. On MOTION by Swan, seconded by Reinhart and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes, THE BOARD RECEIVED AND FILED THE AFFIDAVITS OF POSTING AND PROOF OF PUBLICATION.

President LaMar asked staff to describe the nature of the proceedings. Using a PowerPoint presentation, Director of Strategic Communications and Advocacy/Deputy General Counsel Compton reviewed the IRWD redistricting process, the public comment and map submission period noting that the public comment period was from December 2, 2021 to January 6, 2022, and said that no maps were received. Consultant Diep then reviewed the data and existing conditions noting that the data was obtained from the 2020 Consensus Law 94-171 redistricting data. Ms. Diep reviewed the required and permissible redistricting criteria said that there must be equal population between divisions with a spread under 10 percent. She said that the goal is for equal population of the current 447,168 with a target division equaling 89,434 for each division. Using maps, she reviewed the differences with target division population, current division boundaries, along with two draft maps identified as Plans 1 and 2. Following discussion, it was the consensus of the Board to eliminate Plan 2 and to create a Plan 1A which will include all of the Newport Coast area into the Division 5. There being no further comments, on MOTION by Reinhart, seconded by Swan, and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes THE SECOND PUBLIC HEARING WAS CLOSED AND THE BOARD AUTHORIZED STAFF TO AGENDIZE THE THIRD PUBLIC HEARING ON FEBRUARY 14, 2022, FOR CONSIDERATION OF ADOPTION OF A FINAL MAP OF DIVISION BOUNDARIES BASED ON MAP 1 AS MODIFIED.

He then reviewed key points of the agreement including: 1) terminating the Irvine Company's reversionary rights interest in Irvine Lake (and replacing it with a covenant requiring the lake to be used for reservoir and approved recreation purposes); 2) approving reciprocal road easements providing unrestricted use by all parties of the existing access road (the "Haul Road") from Santiago Canyon Road to the lake; 3) terminating prior lake management agreements including the Haul Road Agreement, Reciprocal License Agreement and other ancillary agreements related to Irvine Lake and adjacent land (originally between IRWD, Serrano, and the Irvine Company); 4) approving the transfer of the Irvine Company's 75% recreation rights interest to the County; and 5) defining permitted and prohibited recreational uses in and around the lake.

Mr. Jacobson reviewed future recreational uses and said that the County has provided a draft Letter of Intent (LOI) between the County, Serrano, and IRWD, which includes the issuance of a request for proposal, the process to select a lessee (to include IRWD's and Serrano's input), and future management and permitted recreational uses within Irvine Lake and adjacent land owned by the County. He said that a final lease agreement of the Flats property would include terms allowing for the temporary or permanent use of the property for reservoir purposes at the discretion of the water districts. He said that the County's Orange County Parks will take the lead for management and that the net revenue split would be 50% County, 30% Serrano, and a 20% IRWD split. He said that the top priorities would include IRWD's operations, maintenance, and construction projects for Irvine Lake. Following discussion on liability issues, on MOTION by Reinhart, seconded by Withers and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting ave, and 0 noes, THE BOARD APPROVED THE IRVINE LAKE PROPERTY AND RECREATION RIGHTS UMBRELLA AGREEMENT SUBJECT TO NON-SUBSTANTIVE CHANGES, AUTHORIZED THE GENERAL MANAGER TO EXECUTE THE AGREEMENT AND ALL RELATED DOCUMENTS, AND AUTHORIZED THE GENERAL MANAGER TO EXECUTE A LETTER OF INTENT TO ISSUE A JOINT REQUEST FOR PROPOSAL TO SELECT A LESSEE TO OPERATE RECREATIONAL ACTIVITIES AT IRVINE LAKE.

IRWD POLICY POSITION PAPER ON REGIONAL WATER SHORTAGE RESPONSE ACTIONS

Executive Director of Water Policy Weghorst reported that following the 2012-2017 statewide drought, legislation was enacted in 2018 to strengthen local water supplier water management and water shortage planning, and that Assembly Bill 1668 and Senate Bill 606 require water suppliers to undertake additional drought planning, include projected water shortage information in their Urban Water Management Plans and enhance their Water Shortage Contingency Plans. Mr. Weghorst said that these plans are updated and submitted to the Department of Water Resources (DWR) at least every five years, with the most recent plans submitted in 2021. He said that additionally, beginning in 2022, water suppliers are required to prepare and submit to DWR an Annual Water Supply and Demand Assessment.

Mr. Weghorst said that IRWD has actively engaged in state and regional policy discussions regarding potential drought responses, including mandatory reductions and given that discussions regarding drought responses are likely to continue, staff recommends the Board adopt a policy position paper regarding regional water shortage actions. He then reviewed the proposed position paper with the Board highlighting its six policy principles.

Director Withers said that this item was reviewed by the Water Resources Policy and Communications Committee on January 17, 2022.

On <u>MOTION</u> by Withers, seconded by McLaughlin and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes, THE BOARD ADOPTED THE IRWD REGIONAL WATER SHORTAGE RESPONSE ACTIONS POLICY POSITION PAPER.

TERMS FOR WATER STORAGE AND TRANSFER PILOT PROGRAM WITH MOJAVE WATER AGENCY

Executive Director of Water Resources Policy Weghorst said that the Mojave Water Agency is a State Water Project (SWP) Contractor that currently has Table A water supplies in excess of demands. These supplies also exceed Mojave's water banking capacities that were developed through its Mojave Basin Conjunctive Use Program. Mr. Weghorst said that in December 2021, staff met with Mojave to discuss implementing a mutually beneficial pilot program that would allow Mojave to deliver excess SWP water into storage at the IRWD Water Bank, with Mojave transferring one-half of the water to IRWD. Mojave's main objective of implementing such a program is to store its share of the water to be recovered later and transferred to another SWP Contractor consistent with the amendments to the SWP Contract that went into effect in February 2021. The SWP contract amendments provide additional water management tools related to transfers and exchanges that provide increased flexibility in managing SWP supplies.

Mr. Weghorst said that as a follow-up to the December 2021 meeting with Mojave, staff prepared terms for implementation of a Water Storage and Transfer Pilot Program between IRWD and Mojave. He said that the pilot program would allow Mojave to deliver its SWP supplies to IRWD's Water Bank for storage with Mojave transferring one-half of the water to IRWD. He said that since the water source would be SWP supplies, the California Department of Water Resources (DWR) will need to approve the program and prepare the appropriate point of delivery and transfer agreements. He said that the transfer of SWP water will also require an SWP Contractor willing to act on IRWD's behalf. The proposed terms for this pilot program, which are a slight variation from IRWD's traditional unbalanced exchange programs and are provided in the exhibit would allow Mojave, at its discretion, to deliver up to 20,000 acre-feet (AF) of SWP Table A water to IRWD's Water Bank through the end of 2030. Mojave would have the ability to deliver up to 7,000 AF per year for recharge on a first-priority basis. Any additional deliveries in the same year would be subject to Buena Vista Water Storage District and/or Antelope Valley - East Kern Water Agency opting to not deliver water into IRWD's Water Bank in the same year. Mojave would be required to deliver a minimum of 13,000 AF over the course of the pilot program. Additionally, when requested by Mojave, IRWD would recover Mojave's share of the stored water using IRWD's first priority rights to the use of IRWD's Water Bank wells. The recovery of Mojave's water would be at a rate not to exceed 3,250 AF per year (with IRWD's annual recovery capacity in the IRWD Water Bank is currently 17,900 AF per year.) This would allow Mojave to recover its share of the minimum delivery requirement within two years. Mojave could request to recover more water should IRWD determine that capacity is available. The requirement for Mojave to deliver a minimum of 13,000 AF of water into storage equitably offsets the first priority recovery commitments to Mojave. Mr. Weghorst said that staff believes that with IRWD already having some extraordinary supply water stored in the Metropolitan system, IRWD's need for first-priority recovery capacity is reduced in the short-term.

Director Reinhart said that this item was reviewed and approved by the Supply Reliability Programs Committee on January 20, 2022. Following discussion, on <u>MOTION</u> by Reinhart, seconded by Withers and unanimously carried by a roll call vote (5-0) Withers, McLaughlin, Swan, LaMar and Reinhart voting aye, and 0 noes, THE BOARD AUTHORIZED THE GENERAL MANAGER TO DEVELOP AND EXECUTE A WATER STORAGE AND TRANSFER PILOT PROGRAM AGREEMENT BETWEEN IRWD AND MOJAVE WATER AGENCY BASED ON THE TERMS PRESENTED.

OTHER BUSINESS

GENERAL MANAGER'S REPORT

General Manager Cook provided an update on COVID-19 activity and said there were only two new cases since last Thursday. He said that 1,000 rapid test kits along with additional masks have been ordered and will be arriving this week.

Mr. Cook said that the status of delinquent accounts is at 4,200 outstanding amounting to \$4.4 million, and he will continue to keep the Board posted on this debt.

Mr. Cook introduced Mr. Steve Choi, the District's new Director of Safety & Security, who formerly worked for the port of Long Beach, and is a UCI graduate. He also introduced Mr. Jason Manning, the District's new Reliability Engineer, who formerly worked for SOCWA.

COMMUNITY UPDATE

Mr. Bruce Newell provided an update on the activities in the canyon.

DIRECTORS COMMENTS

Director Reinhart said he attended his regular meetings listed and highlighted his attendance at an OCWD Board meeting and a Southern California Water Coalition lunch meeting.

2022 LEGISLATIVE AND REGULATORY UPDATE

SUMMARY:

This report provides an update on the 2021-2022 legislative session, regulatory issues, and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate.

Staff recommends the Board receive and file this report.

• AB 1001 (Christina Garcia) — Mitigation Measures: Disadvantaged Communities: "WATCH."

BACKGROUND:

January 28, 2022, was the last day for bills to be submitted to the Office of the Legislative Counsel, and January 31 was the last day for bills introduced in 2021 to be passed out of their house of origin. The bill introduction deadline this year is February 18, although resolutions and constitutional amendments can be introduced after that date. The first policy committee deadlines are in late April and early May.

A copy of the 2022 Legislative Matrix is provided as Exhibit "A".

2022 State Legislative Update:

AB 1001 (Christina Garcia, D-Bell Gardens) – Mitigation Measures: Disadvantaged Communities

Assembly Bill 1001 (Christina Garcia, D-Bell Gardens) authorizes mitigation measures, identified in an Environmental Impact Report or Mitigated Negative Declaration for a project that impacts the air or water quality of a disadvantaged community (DAC), to include measures for avoiding, minimizing or compensating adverse effects on disadvantaged communities. It requires that if the mitigation measures include compensating for adverse effects on the air or water quality of a disadvantaged community, the compensating measures shall mitigate those effects directly in the affected disadvantaged communities.

This two-year bill was passed through the Assembly Natural Resources Committee and the Assembly Appropriations Committee to the Assembly floor in January. The bill was amended on the Assembly floor on January 24. The recent amendments narrow the applicability of the requirement for measures "directly in" a DAC and stakeholders are reviewing the implications of those amendments. A number of statewide associations have been actively engaged on this bill to address the concern that requiring measures "directly in" a DAC limits discretion to address

the adverse effects of a project in the most efficient and effective manner. Given those ongoing discussion, staff recommends the Board adopt a "watch" position on the bill at this time to allow those discussion to continue.

CONSENT CALENDAR

REHABILITATION OF IRWD WELL 51 FINAL ACCEPTANCE

SUMMARY:

The rehabilitation of IRWD Well 51 is complete. IRWD's contractor Weber Water Resources, LLC completed the required rehabilitation work and all punch list items. Final inspection is complete, and staff recommends final acceptance of the project.

BACKGROUND:

IRWD Well 51 is near the northern corner of the intersection of Pullman and Daimler Streets in Irvine. This well was constructed in 1992 with a copper bearing steel casing and louvers and sat idle for nearly 30 years. The well was never equipped with a pump because the original project that included Wells 51, 52, and 53 was put on hold due to the development of the Deep Aquifer Treatment System and increased annual pumping from the principal aquifer within the Orange County Groundwater Basin.

An unsuccessful attempt was made to rehabilitate the well in 2009 using traditional mechanical methods. Rehabilitation methods improved significantly since then, and include the use of rigorous mechanical, chemical, and pumping development. A video of the well casing was reviewed by staff and Richard C. Slade & Associates, hydrogeologist for this project, and visual observation indicated that the well could be successfully rehabilitated using updated methods.

Slade completed the design in April 2021 and Weber Water Resources, LLC was awarded the construction contract on May 11, 2021. Weber Water Resources mobilized in July 2021. During the rehabilitation, four holes in the casing were discovered and two contract change orders were issued to install steel swage patches over the holes; the contract time was extended to complete the additional work. A summary of the construction change orders is provided in Exhibit "A". Weber Water Resources completed construction of all improvements on December 31, 2021.

The rehabilitation of Well 51 was successful with a projected well flow rate of up to 2,000 gallons per minute with 83 feet of drawdown or a specific capacity of 24 gallons per minute per foot of drawdown. The only water quality constituent of concern is color with the concentration of 30 color units, which exceeds the secondary standard of 15 color units. The new well production will be added to the Groundwater Work Plan for planning purposes. Staff recommends the Board accept the construction of the Rehabilitation of IRWD Well 51.

RESOLUTION FOR SYPHON RESERVOIR IMPROVEMENT PROJECT APPLICATIONS FOR TITLE XVI GRANT FUNDING

SUMMARY:

The Bureau of Reclamation is accepting applications for grant funding under its WaterSMART – Title XVI Water Reclamation and Reuse Program, as amended by the Water Infrastructure Improvements for the Nation (WIIN) Act. In response to this opportunity, staff plans to submit a grant application for the Syphon Reservoir Improvement Project for 25% of total project costs that are planned to be incurred through September 30, 2025. The program allows project sponsors to reapply for funding multiple times until a project's total funding award has reached 25% of the total project cost, up to \$30 million.

As part of the grant application process, the Bureau of Reclamation requires that an applicant's governing body adopt a resolution designating an authorized representative to submit grant applications and to enter into an agreement to receive the funding. The resolution must confirm that the applicant has the ability to provide a cost share of up to 75% of the project costs. Staff recommends the Board adopt a resolution authorizing submission of grant applications for the WaterSMART – Title XVI WIIN Water Reclamation and Reuse Program for 25%, up to \$30 million, of the total Syphon Reservoir Improvement Project costs and authorize the General Manager to execute a related agreement to receive grant funding.

BACKGROUND:

Since 2018, IRWD has submitted separate grant funding applications for the Syphon Reservoir Improvement Project under Reclamation's WaterSMART – Title XVI Program as amended by the WIIN Act. Eligible applicants for Title XVI funding are sponsors of water recycling projects that have completed a Feasibility Study that Reclamation has found to meet the requirements of Title XVI. Reclamation has already approved a Title XVI compliant Feasibility Study for the Syphon Reservoir Improvement Project.

Following notification that the Syphon Reservoir Improvement Project was not selected for funding under last year's Funding Opportunity Announcement (FOA), staff met with Reclamation to discuss IRWD's grant application. Reclamation indicated that it expects to award funding for a larger number of projects in the near future. Reclamation staff provided constructive feedback on areas of IRWD's application that can be improved and encouraged IRWD to submit an application in response to the 2022 FOA.

2022 Title XVI Funding Opportunity:

In January 2022, Reclamation issued a new FOA for grants under the WaterSMART – Title XVI Program. This FOA will be used to allocate available Fiscal Year (FY) 2022-enacted

appropriations for Title XVI projects authorized under the WIIN Act and funding available under the new Bipartisan Infrastructure Law. Applications submitted under this FOA may also be considered for additional funding, should it become available in FY 2022 or thereafter. Applicants that are awarded funding under the Bipartisan Infrastructure Law will need to meet additional requirements, including Buy American and Wage Rate Requirements. Since the Syphon Reservoir Improvement Project has a previously approved Title XVI compliant Feasibility Study, it is eligible to request funding under the current 2022 FOA.

Grant Funding Application:

Based on the 2022 FOA, Title XVI Program grant funding can be applied to planning, design and/or construction costs incurred from February 7, 2018, through September 30, 2025. Staff will estimate eligible Syphon Reservoir Improvement Project costs that will be incurred by September 2025 and submit a grant application for 25% of those costs. In accordance with the Title XVI Program, IRWD would be required to provide at least 75% of total project costs. The program allows project sponsors to reapply for funding multiple times until a project's total funding award has reached 25% of the total project cost or a \$30 million maximum. Under previous Title XVI FOAs, funding was limited to a \$20 million maximum per project. Grant applications under this FOA are due to Reclamation by March 15, 2022.

Staff expects that the current grant application will be more competitive than previous applications. The Final Environmental Impact Report for the project, and the ongoing project design process, will improve the project's scoring relative to Reclamation's evaluation criteria. Reclamation has not specified the amount of funding available for this year's grant program but estimates that between 10 and 30 awards will be granted.

Board Resolution:

As part of the grant funding process, Reclamation requires that a resolution be adopted by an applicant's governing body. Reclamation allows resolutions to be submitted up to 30 days after the application deadline. The resolution must designate an authorized representative to submit applications for grant funding and to enter into an agreement to receive funding. It must also confirm that the applicant has the ability to provide the required cost share of up to 75% of the project costs. Accordingly, staff recommends the Board adopt a resolution, provided as Exhibit "A", supporting WaterSMART grant applications for the Syphon Reservoir Improvement Project.

FISCAL IMPACTS:

The Syphon Reservoir Improvement Project (Project 03808) is included in the FY 2021-22 and FY 2022-23 Capital Budget. On February 5, 2021, the Board approved an Expenditure Authorization in the amount of \$139,650,000 for the project, bringing the total project budget to \$146,000,000.

The Irvine Ranch Water District is eligible to submit applications for grant funding for up to 25 percent of the total project cost, up to a maximum of \$30 million, for its Syphon Reservoir Improvement Project.
