Reasons why project is exempt:

IRWD will assume and continue the same service that was provided by Orange County Sanitation District (OCSD) for a portion of the City of Tustin service area, portions of Unincorporated Orange County known as North Tustin.

Class 1 consists of the operation, repair, minor alteration of existing utility facilities involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination; and addition of safety and health protection devices in conjunction with existing facilities. Class 20 consists of changes in the organization of local government agencies not changing the geographical area in which previously existing powers are exercised. (State Guidelines 15301 and 15320).

Submission of this form is optional. Local agencies may file this form with the county clerk pursuant to Public Resources Code Section 21152(b). The filing of the notice starts a 35-day statute of limitations on court challenges to the approval of the project under Public Resources Code Section 21167(d). Failure to file the notice results in the statute of limitations being extended to 180 days.

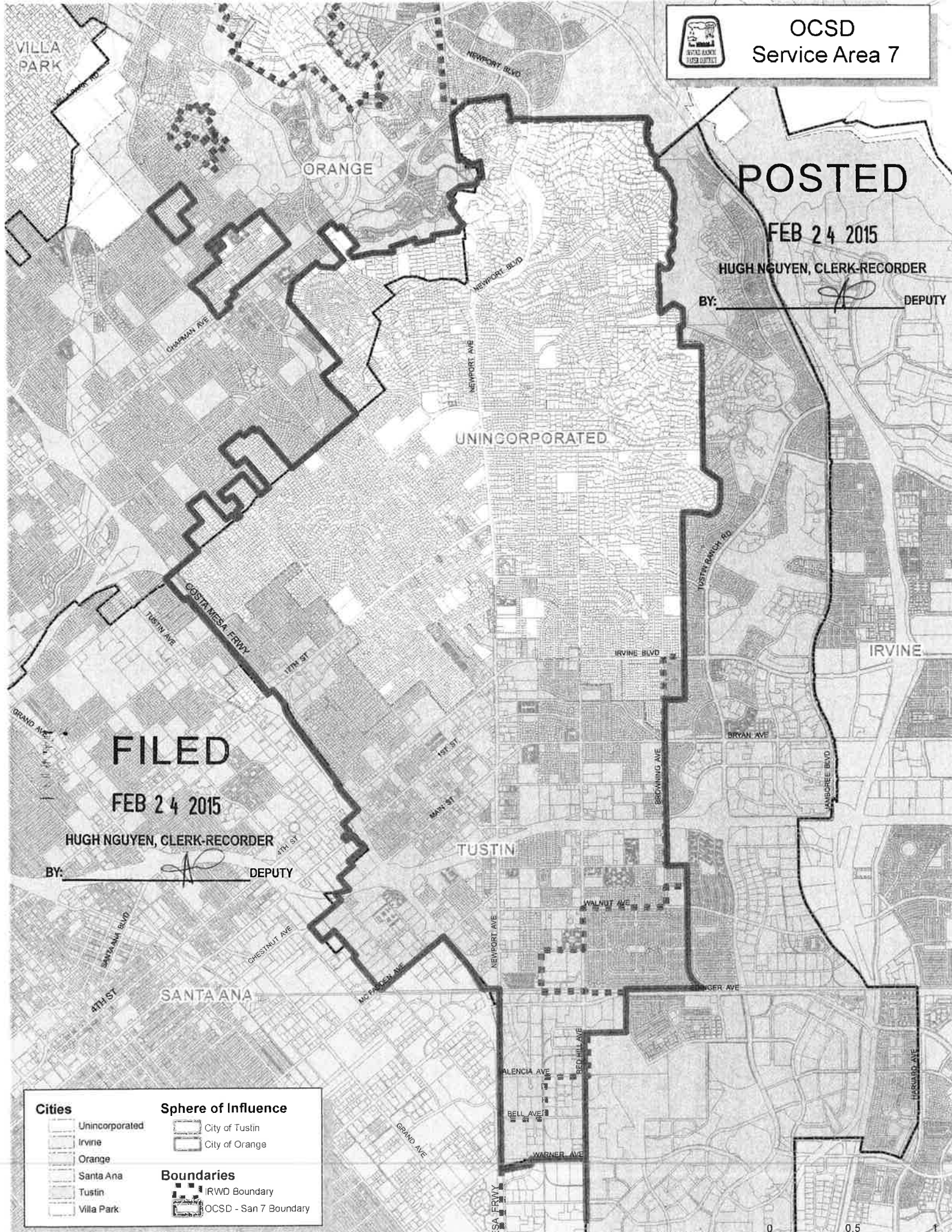
